A BILL

To amend part Q of the Omnibus Crime Control and Safe Streets Act of 1968 to encourage the use of school resource officers.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SCHOOL RESOURCE OFFICERS.**

4 Part Q of title I of the Omnibus Crime Control and
5 Safe Streets Act of 1968 (42 U.S.C. 3796dd et seq.) is
6 amended—

1 (1) in section 1701(d)—

2 (A) by redesignating paragraphs (8)
3 through (10) as paragraphs (9) through (11),
4 respectively; and

5 (B) by inserting after paragraph (7) the
6 following:

7 “(8) establish school-based partnerships be-
8 tween local law enforcement agencies and local
9 school systems by using school resource officers who
10 operate in and around elementary and secondary
11 schools to combat school-related crime and disorder
12 problems, gangs, and drug activities;” and

13 (2) in section 1709—

14 (A) by redesignating the first 3 undesig-
15 nated paragraphs as paragraphs (1) through
16 (3), respectively; and

17 (B) by adding at the end the following:

18 “(4) ‘school resource officer’ means a career
19 law enforcement officer, with sworn authority, de-
20 ployed in community-oriented policing, and assigned
21 by the employing police department or agency to
22 work in collaboration with schools and community-
23 based organizations—

24 “(A) to address crime and disorder prob-
25 lems, gangs, and drug activities affecting or oc-

1 curring in or around an elementary or second-
2 ary school;

3 “(B) to develop or expand crime prevention
4 efforts for students;

5 “(C) to educate likely school-age victims in
6 crime prevention and safety;

7 “(D) to develop or expand community jus-
8 tice initiatives for students;

9 “(E) to train students in conflict resolu-
10 tion, restorative justice, and crime awareness;

11 “(F) to assist in the identification of phys-
12 ical changes in the environment that may re-
13 duce crime in or around the school; and

14 “(G) to assist in developing school policy
15 that addresses crime and to recommend proce-
16 dural changes.”.
