A BILL

To require the Director of the Office of Management and Budget to conduct an audit of any unobligated coronavirus-related funding and to rescind all such funding, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Audit and Return It
5 Act”.

1 **SEC. 2. OMB AUDIT OF COVID FUNDING AND RESCISSION.**

2 (a) AUDIT.—

3 (1) IN GENERAL.—Not later than 30 days after
4 the date of enactment of this Act, the Director of
5 the Office of Management and Budget shall conduct
6 an audit of appropriations provided by provisions of
7 law described in paragraph (2) and issue a report
8 listing the unobligated amounts that remain avail-
9 able under any such provision.

10 (2) PROVISIONS OF LAW.—The provisions of
11 law described in this paragraph are the following:

12 (A) The Coronavirus Preparedness and
13 Response Supplemental Appropriations Act,
14 2020 (Public Law 116–123).

15 (B) The Families First Coronavirus Re-
16 sponse Act (Public Law 116–127).

17 (C) The Coronavirus Aid, Relief, and Eco-
18 nomic Security Act (Public Law 116–136).

19 (D) The Paycheck Protection Program and
20 Health Care Enhancement Act (Public Law
21 116–139).

22 (E) Divisions M and N of the Consolidated
23 Appropriations Act, 2021 (Public Law 116–
24 260).

25 (F) The American Rescue Plan Act of
26 2021 (Public Law 117–2).

1 (b) RESCISSION.—On the date the report is issued
2 under subsection (a)(1), all unobligated amounts listed in
3 such report are hereby rescinded and shall be deposited
4 into the general fund of the Treasury for the sole purpose
5 of deficit reduction.
