A BILL

To direct the Comptroller General of the United States to conduct a study on the effectiveness of local alerting systems, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Weather Alert Response*
5 *and Notification Act” or the “WARN Act”.*

6 **SEC. 2. EFFECTIVENESS OF LOCAL, STATE, AND FEDERAL**
7 **ALERTING SYSTEMS.**

8 *(a) IN GENERAL.—The Comptroller General of the*
9 *United States shall conduct a study on the effectiveness of*
10 *local, State, and Federal emergency alerting systems in dis-*
11 *seminating timely and relevant information during weath-*
12 *er-related emergencies to help communities develop better*
13 *policies and procedures for emergency response and enhance*
14 *public safety in the event of a weather-related emergency.*

15 *(b) CONTENTS.—In conducting the study under sub-*
16 *section (a), the Comptroller General shall—*

17 *(1) evaluate the efficacy of various alert medi-*
18 *ums, including platforms such as social media, to dis-*
19 *seminate emergency alerts, including travel bans and*
20 *mass power outages, during extreme weather events;*

21 *(2) assess the extent that guidance and training*
22 *exists for developing alert content, such as ensuring*
23 *alerts are clear, relevant, and provide the public with*
24 *actionable information; and*

1 (3) *determine whether improvements could be*
2 *made to public alerting based on input from a se-*
3 *lected sample of emergency managers, local officials,*
4 *and community groups.*

5 (c) *REPORT.—Not later than 18 months after the date*
6 *of enactment of this Act, the Comptroller General shall sub-*
7 *mit to the Committee on Transportation and Infrastructure*
8 *and the Committee on Homeland Security of the House of*
9 *Representatives and the Committee on Homeland Security*
10 *and Governmental Affairs of the Senate a report on the*
11 *study conducted under subsection (a).*

Amend the title so as to read: “A bill to direct the Comptroller General of the United States to conduct a study on the effectiveness of emergency alerting systems, and for other purposes.”.
