1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Electronic Permitting

4	SEC. 2. DEPARTMENT OF THE INTERIOR PERMIT ACCESSI-				
5	BILITY.				
6	(a) In General.—In order to improve the overall				
7	economy, efficiency, and management of operations and				
8	activities of the Department of the Interior (referred t				
9	in this section as the "Department"), reduce paperwork				
10	and provide high-quality services and access to the public				
11	the Secretary of the Interior shall, to the extent prac-				
12	ticable—				
13	(1) design and deliver modernized electronic				
14	permitting systems to accept, process, and record				
15	applications (including plan submissions, payment				
16	activity, and other related correspondence) for per-				
17	mits, forms, and other paperwork required for activi-				
18	ties regulated by the Department;				
19	(2) provide a centralized electronic permitting				
20	system online repository, available to the public on				
21	the Department's website, that includes—				
22	(A) hyperlinks to facilitate navigation to				
23	all Department electronic permitting systems;

25	(B) with respect to permits, the contact in-				
26	formation for the appropriate Department em-

3	(3) provide to the Committee on Natural Re-						
4	sources of the House of Representatives and the						
5	Committee on Energy and Natural Resources of the						
6	Senate periodic updates on the implementation of						
7	paragraphs (1) and (2).						
8	(b) Disclosure of Information Prohibited.—						

- 9 No information described in section 552(b) of title 5,
- 10 United States Code, or protected from disclosure by an-
- 11 other law of the United States shall be disclosed under
- 12 this Act.
- 13 (c) Duplication of Systems Not Permitted.—
- 14 No system shall be duplicated under this Act.
- 15 (d) Consultation.—In developing the permitting
- 16 systems required under section 2 of this Act, the Secretary
- 17 of the Interior shall consult with States, local govern-
- 18 ments, Indian Tribes and other stakeholders who apply
- 19 for agency permits and will use the permitting systems.
- 20 SEC. 3. CONFORMING AMENDMENT TO ENSURE CONSIST-
- 21 ENCY WITH THE FISCAL RESPONSIBILITY
- 22 **ACT OF 2023.**
- In developing the permitting systems required under
- 24 section 2 of this Act, the Secretary of the Interior shall
- 25 ensure that the Department's electronic permitting sys-

- 1 tems are consistent with the priorities identified in section
- 2 110 of the National Environmental Policy Act of 1969 (42
- 3 U.S.C. 4336d) with respect to any permit that requires
- 4 review under that Act.
