A BILL

To amend title 49, United States Code, to extend authorizations for the airport improvement program, to amend the Internal Revenue Code of 1986 to extend the funding and expenditure authority of the Airport and Airway Trust Fund, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) SHORT TITLE.—This Act may be cited as the
5 “Airport and Airway Extension Act of 2023, Part II”.

TITLE I—FEDERAL AVIATION PROGRAMS

SEC. 101. AIRPORT IMPROVEMENT PROGRAM.

6 (a) AUTHORIZATION OF APPROPRIATIONS.—Section
 7 48103(a) of title 49, United States Code, is amended by
 8 striking paragraph (7) and inserting the following:

9 “(7) \$1,464,480,874 for the period beginning
 10 October 1, 2023, and ending on March 8, 2024.”.

11 (b) OBLIGATION AUTHORITY.—Subject to limitations
 12 specified in advance in appropriation Acts, sums made
 13 available pursuant to the amendment made by subsection
 14 (a) may be obligated at any time through September 30,
 15 2024, and shall remain available until expended.

16 (c) PROGRAM IMPLEMENTATION.—For purposes of
 17 calculating funding apportionments and meeting other re-
 18 quirements under sections 47114, 47115, 47116, and
 19 47117 of title 49, United States Code, for the period be-

1 ginning on October 1, 2023, and ending on March 8,
2 2024, the Administrator of the Federal Aviation Adminis-
3 tration shall—

4 (1) first calculate such funding apportionments
5 on an annualized basis as if the total amount avail-
6 able under section 48103 of such title for fiscal year
7 2024 was \$3,350,000,000; and

8 (2) then reduce by 56 percent—

9 (A) all funding apportionment amounts
10 calculated under paragraph (1); and

11 (B) amounts made available pursuant to
12 subsections (b) and (f)(2) of section 47117 of
13 such title.

14 (d) EXTENSION OF PROJECT GRANT AUTHORITY.—
15 Section 47104(c) of title 49, United States Code, is
16 amended in the matter preceding paragraph (1) by strik-
17 ing “December 31, 2023,” and inserting “March 8,
18 2024.”.

19 (e) EXTENSION OF SPECIAL RULE FOR APPORION-
20 MENTS.—Section 47114(c)(1)(J) of title 49, United
21 States Code, is amended by striking “December 31,
22 2023,” and inserting “March 8, 2024.”.

17 2023” and inserting “March 8, 2024”.

23 on October 1, 2023, and ending on March 8, 2024.”.

3 amended by striking paragraph (16) and inserting the fol-
4 lowing:

5 “(16) \$111,475,410 for the period beginning on
6 October 1, 2023, and ending on March 8, 2024.”.

7 **SEC. 106. SMALL COMMUNITY AIR SERVICE.**

8 (a) ESSENTIAL AIR SERVICE AUTHORIZATION.—Sec-
9 tion 41742(a)(2) of title 49, United States Code, is
10 amended by striking “\$89,191,486 for the period begin-
11 ning on October 1, 2023, and ending on December 31,
12 2023,” and inserting “\$155,115,628 for the period begin-
13 ning on October 1, 2023, and ending on March 8, 2024.”.

14 (b) AIRPORTS NOT RECEIVING SUFFICIENT SERV-
15 ICE.—Section 41743(e)(2) of title 49, United States Code,
16 is amended by striking “\$2,513,661 for the period begin-
17 ning on October 1, 2023, and ending on December 31,
18 2023,” and inserting “\$4,371,585 for the period begin-
19 ning on October 1, 2023, and ending on March 8, 2024.”.

22 **SEC. 201. EXPENDITURE AUTHORITY FROM AIRPORT AND
23 AIRWAY TRUST FUND.**

24 (a) IN GENERAL.—Section 9502(d)(1) of the Inter-
25 national Revenue Code of 1986 is amended—

1 (1) in the matter preceding subparagraph (A)
2 by striking “January 1, 2024” and inserting
3 “March 9, 2024”; and

4 (2) in subparagraph (A) by striking the semi-
5 colon at the end and inserting “or the Airport and
6 Airway Extension Act of 2023, Part II;”.

7 (b) CONFORMING AMENDMENT.—Section 9502(e)(2)
8 of such Code is amended by striking “January 1, 2024”
9 and inserting “March 9, 2024”.

10 **SEC. 202. EXTENSION OF TAXES FUNDING AIRPORT AND**
11 **AIRWAY TRUST FUND.**

12 (a) FUEL TAXES.—Section 4081(d)(2)(B) of the In-
