# A BILL

To amend title XVIII of the Social Security Act to modify the criteria for designation of rural emergency hospitals.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*  
3   **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Second Chances for*  
5   *Rural Hospitals Act”.*

6   **SEC. 2. EXPANDING THE DEFINITION OF RURAL EMER-**

7                   **GENCY HOSPITAL UNDER THE MEDICARE**  
8                   **PROGRAM.**

9       (a) *IN GENERAL.—Section 1861(kkk) of the Social Se-*  
10   *curity Act (42 U.S.C. 1395x(kkk)) is amended—*

11               (1) *in paragraph (2)(A), by striking “is enrolled*  
12   *under section 1866(j)” and inserting “except in the*  
13   *case of a facility described in paragraph (3)(B)”;*

14               (2) *in paragraph (3)—*

15               (A) *in subparagraph (B), by striking the*  
16   *period at the end and inserting “; or”;*

17               (B) *by redesignating subparagraphs (A)*  
18   *and (B) as clauses (i) and (ii), respectively, and*  
19   *adjusting the margins accordingly;*

20               (C) *by striking “facility that as of” and in-*  
21   *serting “facility—*

22               “(A) that as of”; and

23               (D) *by adding at the end the following new*  
24   *subparagraph:*

25               “(B) that—

1                   “(i) during the period beginning January  
2                   1, 2014, and ending December 26,  
3                   2020—

4                   “(I) was a critical access hospital;  
5                   or

6                   “(II) was a subsection (d) hospital  
7                   (as defined in section  
8                   1886(d)(1)(B)) located in a county (or  
9                   equivalent unit of local government) in  
10                  a rural area (as defined in section  
11                  1886(d)(2)(D)); and

12                  “(ii) as of the date of the enactment of  
13                  this subparagraph, had ceased operations.”;  
14                  and

15                  (3) in paragraph (4)—

16                  (A) in subparagraph (A)(i), by striking  
17                  “An action plan” and inserting “Except in the  
18                  case of a facility described in paragraph (3)(B),  
19                  an action plan”; and

20                  (B) in subparagraph (B)(i), by inserting  
21                  “except in the case of a facility described in  
22                  paragraph (3)(B),” before “the facility”.

23                  (b) AMENDMENTS TO PAYMENT RULES.—Section  
24                  1834(x) of the Social Security Act (42 U.S.C. 1395m(x))  
25                  is amended—

1                   (1) in paragraph (1), by inserting “, except that,  
2       in the case of a facility described in section  
3       1861(kkk)(3)(B) that, as of the date on which such fa-  
4       cility submits an application under section 1866(j) to  
5       enroll under this title as a rural emergency hospital,  
6       is located less than 35 miles away from the nearest  
7       hospital, critical access hospital, or rural emergency  
8       hospital, such increase shall not apply” before the pe-  
9       riod at the end; and

10                  (2) in paragraph (2)(A), by inserting “(other  
11       than a facility described in section 1861(kkk)(3)(B)  
12       that, as of the date on which such facility submits an  
13       application under section 1866(j) to enroll under this  
14       title as a rural emergency hospital, is located less  
15       than 10 miles away from the nearest hospital, critical  
16       access hospital, or rural emergency hospital)” after  
17       “rural emergency hospital”.

18                  (c) **EFFECTIVE DATE.**—The amendments made by this  
19       section shall apply beginning January 1, 2027.
