# RESOLUTION

Providing for consideration of the bill (H.R. 3334) to provide for the imposition of sanctions on members of the National Communist Party Congress of the People's Repub-

lic of China, and for other purposes; providing for consideration of the bill (H.R. 8205) to amend the Omnibus Crime Control and Safe Streets Act of 1968 to provide that Byrne grant funds may be used for public safety report systems, and for other purposes; providing for consideration of the bill (H.R. 8790) to expedite under the National Environmental Policy Act of 1969 and improve forest management activities on National Forest System lands, on public lands under the jurisdiction of the Bureau of Land Management, and on Tribal lands to return resilience to overgrown, fire-prone forested lands, and for other purposes; providing for consideration of the resolution (H. Res. 1469) ensuring accountability for key officials in the Biden-Harris administration responsible for decisionmaking and execution failures throughout the withdrawal from Afghanistan; and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 3334) to provide for the imposition  
6 of sanctions on members of the National Communist  
7 Party Congress of the People's Republic of China, and for  
8 other purposes. The first reading of the bill shall be dis-  
9 pensed with. All points of order against consideration of  
10 the bill are waived. General debate shall be confined to  
11 the bill and shall not exceed one hour equally divided and  
12 controlled by the chair and ranking minority member of

1 the Committee on Foreign Affairs or their respective des-  
2 ignees. After general debate the bill shall be considered  
3 for amendment under the five-minute rule. The amend-  
4 ment in the nature of a substitute recommended by the  
5 Committee on Foreign Affairs now printed in the bill,  
6 modified by the amendment printed in part A of the report  
7 of the Committee on Rules accompanying this resolution,  
8 shall be considered as adopted in the House and in the  
9 Committee of the Whole. The bill, as amended, shall be  
10 considered as the original bill for the purpose of further  
11 amendment under the five-minute rule and shall be consid-  
12 ered as read. All points of order against provisions in the  
13 bill, as amended, are waived. No further amendment to  
14 the bill, as amended, shall be in order except those printed  
15 in part B of the report of the Committee on Rules. Each  
16 such further amendment may be offered only in the order  
17 printed in the report, may be offered only by a Member  
18 designated in the report, shall be considered as read, shall  
19 be debatable for the time specified in the report equally  
20 divided and controlled by the proponent and an opponent,  
21 shall not be subject to amendment, and shall not be sub-  
22 jeet to a demand for division of the question in the House  
23 or in the Committee of the Whole. All points of order  
24 against such further amendments are waived. At the con-  
25 clusion of consideration of the bill for amendment the

1 Committee shall rise and report the bill, as amended, to  
2 the House with such further amendments as may have  
3 been adopted. The previous question shall be considered  
4 as ordered on the bill, as amended, and on any further  
5 amendment thereto to final passage without intervening  
6 motion except one motion to recommit.

7 SEC. 2. Upon adoption of this resolution it shall be  
8 in order to consider in the House the bill (H.R. 8205)  
9 to amend the Omnibus Crime Control and Safe Streets  
10 Act of 1968 to provide that Byrne grant funds may be  
11 used for public safety report systems, and for other pur-  
12 poses. All points of order against consideration of the bill  
13 are waived. In lieu of the amendment in the nature of a  
14 substitute recommended by the Committee on the Judici-  
15 ary now printed in the bill, an amendment in the nature  
16 of a substitute consisting of the text of Rules Committee  
17 Print 118-51 shall be considered as adopted. The bill, as  
18 amended, shall be considered as read. All points of order  
19 against provisions in the bill, as amended, are waived. The  
20 previous question shall be considered as ordered on the  
21 bill, as amended, and on any further amendment thereto,  
22 to final passage without intervening motion except: (1) one  
23 hour of debate equally divided and controlled by the chair  
24 and ranking minority member of the Committee on the

1 Judiciary or their respective designees; and (2) one motion  
2 to recommit.

3 SEC. 3. At any time after adoption of this resolution  
4 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
5 declare the House resolved into the Committee of the  
6 Whole House on the state of the Union for consideration  
7 of the bill (H.R. 8790) to expedite under the National En-  
8 vironmental Policy Act of 1969 and improve forest man-  
9 agement activities on National Forest System lands, on  
10 public lands under the jurisdiction of the Bureau of Land  
11 Management, and on Tribal lands to return resilience to  
12 overgrown, fire-prone forested lands, and for other pur-  
13 poses. The first reading of the bill shall be dispensed with.  
14 All points of order against consideration of the bill are  
15 waived. General debate shall be confined to the bill and  
16 shall not exceed one hour equally divided and controlled  
17 by the chair and ranking minority member of the Com-  
18 mittee on Natural Resources or their respective designees.  
19 After general debate the bill shall be considered for  
20 amendment under the five-minute rule. The amendment  
21 in the nature of a substitute recommended by the Com-  
22 mittee on Natural Resources now printed in the bill, modi-  
23 fied by the amendment printed in part C of the report  
24 of the Committee on Rules accompanying this resolution,  
25 shall be considered as adopted in the House and in the

1 Committee of the Whole. The bill, as amended, shall be  
2 considered as the original bill for the purpose of further  
3 amendment under the five-minute rule and shall be consid-  
4 ered as read. All points of order against provisions in the  
5 bill, as amended, are waived. No further amendment to  
6 the bill, as amended, shall be in order except those printed  
7 in part D of the report of the Committee on Rules. Each  
8 such further amendment may be offered only in the order  
9 printed in the report, may be offered only by a Member  
10 designated in the report, shall be considered as read, shall  
11 be debatable for the time specified in the report equally  
12 divided and controlled by the proponent and an opponent,  
13 shall not be subject to amendment, and shall not be sub-  
14 ject to a demand for division of the question in the House  
15 or in the Committee of the Whole. All points of order  
16 against such further amendments are waived. At the con-  
17 clusion of consideration of the bill for amendment the  
18 Committee shall rise and report the bill, as amended, to  
19 the House with such further amendments as may have  
20 been adopted. The previous question shall be considered  
21 as ordered on the bill, as amended, and on any further  
22 amendment thereto to final passage without intervening  
23 motion except one motion to recommit.

24 SEC. 4. Upon adoption of this resolution it shall be  
25 in order without intervention of any point of order to con-

1 sider in the House the resolution (H. Res. 1469) ensuring  
2 accountability for key officials in the Biden-Harris admin-  
3 istration responsible for decisionmaking and execution  
4 failures throughout the withdrawal from Afghanistan. The  
5 resolution shall be considered as read. The previous ques-  
6 tion shall be considered as ordered on the resolution and  
7 preamble to adoption without intervening motion or de-  
8 mand for division of the question except one hour of de-  
9 bate equally divided and controlled by the chair and rank-  
10 ing minority member of the Committee on Foreign Affairs  
11 or their respective designees.

12 SEC. 5. Section 3(j) of House Resolution 5 is amend-  
13 ed by adding at the end the following new paragraph:

14 “(3) DEFINITION.—For purposes of this sub-  
15 section, ‘non-governmental capacity’ shall mean any  
16 capacity except representing the executive branch of  
17 the United States government.”.
