RESOLUTION

Providing for consideration of the bill (H.R. 5349) to develop and disseminate a civic education curriculum and oral history resources regarding certain political ideologies, and for other purposes, and providing for consideration of the bill (H.R. 7198) to amend title 5, United States Code, to require greater transparency for Federal regulatory decisions that impact small businesses, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 5349) to develop and disseminate a civic education cur-
4 riculum and oral history resources regarding certain polit-
5 ical ideologies, and for other purposes. All points of order
6 against consideration of the bill are waived. The amend-
7 ment in the nature of a substitute recommended by the
8 Committee on Education and the Workforce now printed
9 in the bill shall be considered as adopted. The bill, as
10 amended, shall be considered as read. All points of order
11 against provisions in the bill, as amended, are waived. The
12 previous question shall be considered as ordered on the
13 bill, as amended, and on any further amendment thereto,
14 to final passage without intervening motion except: (1) one
15 hour of debate equally divided and controlled by the chair
16 and ranking minority member of the Committee on Edu-
17 cation and the Workforce or their respective designees; (2)
18 the further amendment printed in part A of the report
19 of the Committee on Rules accompanying this resolution,
20 if offered by the Member designated in the report, which
21 shall be in order without intervention of any point of
22 order, shall be considered as read, shall be separately de-
23 batable for the time specified in the report equally divided
24 and controlled by the proponent and an opponent, and

1 shall not be subject to a demand for division of the ques-
2 tion; and (3) one motion to recommit.

3 SEC. 2. Upon adoption of this resolution it shall be
4 in order to consider in the House the bill (H.R. 7198)
5 to amend title 5, United States Code, to require greater
6 transparency for Federal regulatory decisions that impact
7 small businesses, and for other purposes. All points of
8 order against consideration of the bill are waived. The
9 amendment in the nature of a substitute recommended by
10 the Committee on the Judiciary now printed in the bill
11 shall be considered as adopted. The bill, as amended, shall
12 be considered as read. All points of order against provi-
13 sions in the bill, as amended, are waived. The previous
14 question shall be considered as ordered on the bill, as
15 amended, and on any further amendment thereto, to final
16 passage without intervening motion except: (1) one hour
17 of debate equally divided and controlled by the chair and
18 ranking minority member of the Committee on the Judici-
19 ary or their respective designees; (2) the further amend-
20 ment printed in part B of the report of the Committee
21 on Rules accompanying this resolution, if offered by the
22 Member designated in the report, which shall be in order
23 without intervention of any point of order, shall be consid-
24 ered as read, shall be separately debatable for the time
25 specified in the report equally divided and controlled by

- 1 the proponent and an opponent, and shall not be subject
- 2 to a demand for division of the question; and (3) one mo-
- 3 tion to recommit.
