RESOLUTION

Providing for consideration of the bill (H.R. 7673) to prohibit the Secretary of Energy from prescribing or enforcing energy conservation standards for clothes washers that are not cost-effective or technologically feasible, and for other purposes; providing for consideration of the bill (S. 4199) to authorize additional district judges for the district courts and convert temporary judgeships; and providing for consideration of the Senate amendment

to the bill (H.R. 5009) to reauthorize wildlife habitat and conservation programs, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 7673) to prohibit the Secretary of Energy from pre-
4 scribing or enforcing energy conservation standards for
5 clothes washers that are not cost-effective or techno-
6 logically feasible, and for other purposes. All points of
7 order against consideration of the bill are waived. The bill
8 shall be considered as read. All points of order against
9 provisions in the bill are waived. The previous question
10 shall be considered as ordered on the bill and on any
11 amendment thereto to final passage without intervening
12 motion except: (1) one hour of debate equally divided and
13 controlled by the chair and ranking minority member of
14 the Committee on Energy and Commerce or their respec-
15 tive designees; and (2) one motion to recommit.

16 SEC. 2. Upon adoption of this resolution it shall be
17 in order to consider in the House the bill (S. 4199) to
18 authorize additional district judges for the district courts
19 and convert temporary judgeships. All points of order
20 against consideration of the bill are waived. The bill shall
21 be considered as read. All points of order against provi-
22 sions in the bill are waived. The previous question shall
23 be considered as ordered on the bill and on any amend-
24 ment thereto to final passage without intervening motion

1 except: (1) one hour of debate equally divided and con-
2 trolled by the chair and ranking minority member of the
3 Committee on the Judiciary or their respective designees;
4 and (2) one motion to commit.

5 SEC. 3. Upon adoption of this resolution it shall be
6 in order to take from the Speaker's table the bill (H.R.
7 5009) to reauthorize wildlife habitat and conservation pro-
8 grams, and for other purposes, with the Senate amend-
9 ment thereto, and to consider in the House, without inter-
10 vention of any point of order, a motion offered by the chair
11 of the Committee on Armed Services or his designee that
12 the House concur in the Senate amendment with an
13 amendment consisting of the text of Rules Committee
14 Print 118–52. The Senate amendment and the motion
15 shall be considered as read. The motion shall be debatable
16 for one hour equally divided and controlled by the chair
17 and ranking minority member of the Committee on Armed
18 Services or their respective designees. The previous ques-
19 tion shall be considered as ordered on the motion to its
20 adoption without intervening motion.

21 SEC. 4. The chair of the Committee on Armed Serv-
22 ices may insert in the Congressional Record not later than
23 December 10, 2024, such material as he may deem ex-
24 planatory of the Senate amendment and the motion speci-
25 fied in section 3 of this resolution.
