RESOLUTION

Providing for consideration of the joint resolution (H.J. Res. 20) providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Department of Energy relating to “Energy Conservation Program: Energy Conservation Standards for

Consumer Gas-fired Instantaneous Water Heaters”; providing for consideration of the joint resolution (H.J. Res. 35) providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Environmental Protection Agency relating to “Waste Emissions Charge for Petroleum and Natural Gas Systems: Procedures for Facilitating Compliance, Including Netting and Exemptions”; and providing for consideration of the concurrent resolution (H. Con. Res. 14) establishing the congressional budget for the United States Government for fiscal year 2025 and setting forth the appropriate budgetary levels for fiscal years 2026 through 2034.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the joint resolu-
3 tion (H.J. Res. 20) providing for congressional dis-
4 approval under chapter 8 of title 5, United States Code,
5 of the rule submitted by the Department of Energy relat-
6 ing to “Energy Conservation Program: Energy Conserva-
7 tion Standards for Consumer Gas-fired Instantaneous
8 Water Heaters”. All points of order against consideration
9 of the joint resolution are waived. The joint resolution
10 shall be considered as read. All points of order against
11 provisions in the joint resolution are waived. The previous
12 question shall be considered as ordered on the joint resolu-
13 tion and on any amendment thereto to final passage with-
14 out intervening motion except: (1) one hour of debate
15 equally divided and controlled by the chair and ranking

1 minority member of the Committee on Energy and Com-
2 merce or their respective designees; and (2) one motion
3 to recommit.

4 SEC. 2. Upon adoption of this resolution it shall be
5 in order to consider in the House the joint resolution (H.J.
6 Res. 35) providing for congressional disapproval under
7 chapter 8 of title 5, United States Code, of the rule sub-
8 mitted by the Environmental Protection Agency relating
9 to “Waste Emissions Charge for Petroleum and Natural
10 Gas Systems: Procedures for Facilitating Compliance, In-
11 cluding Netting and Exemptions”. All points of order
12 against consideration of the joint resolution are waived.
13 The joint resolution shall be considered as read. All points
14 of order against provisions in the joint resolution are
15 waived. The previous question shall be considered as or-
16 dered on the joint resolution and on any amendment
17 thereto to final passage without intervening motion except:
18 (1) one hour of debate equally divided and controlled by
19 the chair and ranking minority member of the Committee
20 on Energy and Commerce or their respective designees;
21 and (2) one motion to recommit.

22 SEC. 3. At any time after adoption of this resolution
23 the Speaker may, pursuant to clause 2(b) of rule XVIII,
24 declare the House resolved into the Committee of the
25 Whole House on the state of the Union for consideration

1 of the concurrent resolution (H. Con. Res. 14) establishing
2 the congressional budget for the United States Govern-
3 ment for fiscal year 2025 and setting forth the appropriate
4 budgetary levels for fiscal years 2026 through 2034. The
5 first reading of the concurrent resolution shall be dis-
6 pensed with. All points of order against consideration of
7 the concurrent resolution are waived. General debate shall
8 not exceed three hours, with two hours of general debate
9 confined to the congressional budget equally divided and
10 controlled by the chair and ranking minority member of
11 the Committee on the Budget or their respective designees
12 and one hour of general debate on the subject of economic
13 goals and policies equally divided and controlled by Rep-
14 resentative Schweikert of Arizona and Representative
15 Beyer of Virginia or their respective designees. The
16 amendment printed in the report of the Committee on
17 Rules accompanying this resolution shall be considered as
18 adopted in the House and in the Committee of the Whole.
19 The concurrent resolution, as amended, shall be consid-
20 ered as read. After general debate the Committee shall
21 rise and report the concurrent resolution, as amended, to
22 the House. The previous question shall be considered as
23 ordered on the concurrent resolution and amendments
24 thereto to adoption without intervening motion except
25 amendments offered by the chair of the Committee on the

- 1 Budget pursuant to section 305(a)(5) of the Congressional
- 2 Budget Act of 1974 to achieve mathematical consistency.
- 3 The concurrent resolution shall not be subject to a demand
- 4 for division of the question of its adoption.
