Dear Madam Speaker and Madam President:

Pursuant to section 4(b) of the Pro bono Work to Empower and Represent Act of 2018, also known as the "POWER Act," Public Law No. 115-237, the Director of the Administrative Office of the United States Courts is required to submit to Congress a compilation and summary of reports received from chief district judges detailing each public event conducted in accordance with the law's requirements during the previous fiscal year.

The federal Judiciary led approximately 65 "empowerment" events (including joint and virtual events) organized by 76 judicial districts during fiscal year 2022 as detailed in the enclosed report. These events informed more than 6,000 people of the importance of pro bono work.
