She created the Reimagine Youth Justice Task Force to create alternatives to juvenile hall for young offenders and has made efforts to curb racial bias in her department by partnering with the non-profit Vera Institute of Justice to evaluate her office's decision making.

Diana's accomplishments in the judiciary are too enumerable and impressive to list briefly

In 2003, Bo worked in more than 30 states for the Human Rights Campaign to pass equality legislation and to elect candidates who supported LGBTQ rights.

Bo has also worked for the Congressional Progressive Caucus, serving as Chief of Staff of its foundation, what is now the Progressive Caucus Center. In 2013, Bo became Campaign Manager for the mayoral campaign of now-D.C. Mayor Muriel Bowser. After that successful campaign, Bo became Executive Director of DC Vote.

As a victim of gun violence herself, Ebony founded a nonprofit, Broken By Violence, to help families like hers heal after being impacted by gun violence. Broken By Violence has provided services to hundreds of families including rental assistance, food assistance, emergency housing, mental health service referrals, and monthly healing spaces for survivors. She has worked with Solano Family Justice Center, the Vallejo Police Department, the City of Vallejo, and the Alameda County District Attorney to provide victims services and has also advocated for legislation that would better support survivors throughtout California.

Although her life was irrevocably changed by tragedy, through her strength and determination, she became a beacon of hope for others. Her resilience and dedication to serving others is an inspiration to all who meet her. She truly embodies the values of a woman of courage by showing kindness, wisdom, humility, and compassion.
