Two months after his escape, Raymond and members of his unit suffered casualties following the explosion of a ground mine. After sustaining debilitating injuries, Raymond was honorably discharged and ordered home. Upon returning to New Hampshire, Raymond continued a life of service to his country. Raymond's strong sense of duty speaks to his patriotism, bravery, and camaraderie, and we thank him for defending our freedoms and supporting others that share in his mission.

After returning to the Granite State, Raymond served as an active member of the local community. Although he began at the Portsmouth Naval Shipyard, Raymond would continue to work into his retirement, eventually becoming an electrician in his own business. As a lifelong member of the American Legion and the VFW, Raymond committed himself to supporting his fellow veterans. As a Pease Greeter, Raymond welcomed troops to the Pease Air National Guard Base before they were deployed on combat missions around the world. In his later years, Raymond continued to advocate for the military as he led support groups for former POWs and joined in Memorial Day and Veterans' Day tributes. Raymond's commitment to supporting the men and women of our armed forces exemplifies his loyalty and respect to the defense of our Nation.

Nearly 60 years passed by before Raymond's time as a POW was formally recognized. Today, as we remember Raymond's life, we recognize his history of service and sacrifice. I commend Raymond for his lifelong dedication to our state and Nation, and I want to extend my sincere condolences to his family and loved ones. Raymond's legacy will continue to live on in the lives of those he influenced. INTRODUCTION OF THE NO FENC-ING AT THE UNITED STATES CAPITOL COMPLEX ACT

Ms. NORTON. Mr. Speaker Pro Tempore, today, I introduce the No Fencing at the United States Capitol Complex Act, which would prohibit the installation of new permanent fencing on the grounds of the United States Capitol complex. I am pleased that Senator CHRIS VAN HOLLEN is introducing this bill in the Senate.

After the insurrectionist attack on the Capitol on January 6, 2021, the Capitol complex became an untraversable fortress surrounded by frightening fences capped with barbed wire typical of authoritarian regimes. Although more needs to be done to protect the Capitol complex, the failure of Capitol security leaders to plan for the predictable and openly announced attack on the Capitol on January 6th does not justify closing the complex to the public, to whom it belongs. We can and must maintain our commitment to security without sacrificing public access by using the least restrictive means necessary to address security.

The January 6th attack on the Capitol, which had little to do with the lack of perma-

nent fencing, was the greatest intelligence and security failure in the history of our nation's capital. There were countless security failures on January 6th that we can and must address. including: taking threats of extremist violence seriously at an earlier stage; closing the Capitol building grounds during high-profile and high-threat events, as is typically done, but was not done on January 6th; manpower; building security; and training. Permanent fencing, which is incredibly imprecise, would not address those security lapses. It is more likely to keep out children, joggers and tourists than a coordinated attack on the Capitol. In fact, it is a form of security theater-it would make the Capitol "look" safer but mask the lack of state-of-the-art security measures that could prevent attacks in the future. Every threat to the Capitol since January 6th has been stopped by longstanding and new security measures and the excellent work of the Capitol Police. Permanent fencing would not aid the Capitol Police in stopping threats but it would create an image of authoritarianism, secrecy and inaccessibility. The Capitol complex is for all the American people, and, with proper security, must remain open to them.

Permanent fencing would send an un-American message to the nation and the world. by transforming our democracy from one that is accessible, transparent and of the people to one that is closed off, secretive and fearful of its own citizens. It would tell the world that the most powerful nation must rely on crude barriers for safety instead of state-of-the-art intelligence and security protocols. The Capitol has welcomed First Amendment protests and demonstrations for centuries without becoming a fortress. The openness of the Capitol and our democracy is our strength, not a security weakness that needs to be rooted out. Any further consideration of permanent fencing is desperate, distasteful and disrespectful of our history and institutions.

Furthermore, the Capitol complex does not exist in a vacuum. It is immediately surrounded by residential neighborhoods and local businesses, which form the heart of the District of Columbia. Permanent fencing would cause serious damage to the fabric of these communities. After January 6th, these residents and businesses were more than understanding as their neighborhoods turned into militarized zones. They waited patiently as officers checked their identification on their walks home or took alternative routes when they found blocked streets. Permanent fencing would infringe on their ability, as well as the general public's ability, to enjoy the public spaces that define our nation's capital.

The distance between government and the people has grown, with trust in government at historic lows. Installing permanent fencing at the Capitol complex would only increase that distance.

I urge my colleagues to support this bill.

Mr. Speaker Pro Tempore, I rise to recognize the life and service of Ukrainian Air Force Major Andrii Pilshchykov, a fighter pilot who tragically lost his life in the fight to defend his country from the Russian invasion. Mr. Pilshchykov reached the rank of Captain in the 40th Tactical Aviation Brigade of the Ukrainian Air Force, before being posthumously promoted to Major.

Born in Kharkiv only 30 years ago, Andrii fulfilled his life-long dream to fly some of the fastest and toughest airplanes in the world. From a young age, Andrii was fascinated with airplanes and jets and eagerly took on the little-known hobby of "Planespotting," in which participants track the movement and record photos of desired aircraft all around the globe. As soon as he could, Andrii enrolled in Ukraine's Ivan Kozhedub National Air Force University. It was in this academy that Andrii learned to fly MiG-29 fighter jets, which he would go on to fly during the current war to save his country. Andrii's peers and instructors were so impressed with his abilities that he was assigned to be an instructor for certain classes even though he was still a cadet.

After graduating from the academy in 2018, Andrii joined the 40th Tactical Aviation Brigade at Yasylkiv Air Base, where he would become an Air Force Captain. During his first year, Andrii traveled to my home state of California, where he completed an internship with the 144th Fighter Wing of California's Air National Guard in the City of Fresno. As he learned how to fly F-15 fighter jets, Andrii took his learning experience in California very seriously, earning the nickname "Juice" because he would only order juice as he refrained from alcohol. He took this nickname back home with him, and for a time he was the only pilot in the Ukrainian Armed Forces with an official call sign: "Juice."

After leaving the Air Force for only a brief period, Andrii did not hesitate to sign up again for service in February 2022 as the Russian invasion threatened the people and very sovereignty of Ukraine. It was not long before he resumed flights, fighting to keep Ukrainian skies safe over Kyiv and other major battle areas. During Andrii's service, he flew over 100 combat missions and destroyed dozens of the enemy's command posts. In May 2022, Andrii was awarded the Order for Courage (3rd Class) for his valiant service.

Because of his keen interest in promoting the modernization of Ukraine's Air Force, and his proficiency in English, Andrii and a small contingent of his colleagues were sent to Washington, D.C., to illustrate and emphasize the urgent need to supply Ukraine with F–16 fighter jets. I had the honor of meeting Andrii. After his visit to Capitol Hill, the Ukraine Fighter Pilots Act was introduced, which I was proud to cosponsor.

I want to express my deepest appreciation for the invaluable service rendered not only to the nation of Ukraine, but in the fight for democracy itself, by Major Andrii Pilshchykov. My deepest condolences go out to his family, the people of Ukraine and all those impacted by his loss.

HONORING THE 80TH ANNIVER-SARY OF THE 349TH AIR MOBIL-ITY WING (RESERVE)

Mr. GARAMENDI. Mr. Speaker Pro Tempore, I rise to recognize the 349th Air Mobility

Wing (Reserve), assigned to the Air Mobility Command, Scott Air Force Base, II. The 349th, celebrated its 80th anniversary on October 14, 2023.

The 349th AMW (Reserve). located at Travis Air Force Base, California, is the largest associate wing in the United States Air Force Reserve. 349th AMW personnel fly the C–5 Galaxy, the C–17 Globemaster III, and the KC–10 Extender, and are now transitioning to the KC–46 Pegasus. The missions of the wing's aircrews include airlifting personnel and material worldwide as well as aerial refueling a wide variety of aircraft.

The 349th AMW is also home to the 349th Aeromedical Evacuation Squadron, responsible for treating patients during medical airlift; the 349th Airlift Control Flight, tasked to enter austere locations and prepare for USAF aircraft arrival; and the 349th Medical Squadron, capable of providing hospital services worldwide, in a contingency environment.

The mission of the 349th AMW is to "generate and sustain combat-ready mobility Airmen." This makes the wing responsible for training almost 3,500 Reservists who, in turn, work side-by-side their active-duty counterparts in the 60th AMW, also stationed at Travis.

In November 1943, 349th Troop Carrier Group was activated at Sedalia Army Air Field, Missouri. The 349th TCG had five troop carrier squadrons assigned, including what is now the 312th Airlift Squadron, which is still assigned to the 349th.

The 349th, like the other reserve troop carrier wings, was completely equipped and ready to move with only a few hours' notice as was the case during the Cuban call-up. Only four hours after the first call to report for duty was made, 95 percent of the wing's flying personnel had checked in and were ready to move. This proved the value of the Air Force Reserve's "Ready Now" concept and the wing's motto "In Omnia Paratus." In all things prepared.

A recall to active duty was again initiated on January 26, 1968, for the Vietnam War, and many hundreds of tons of cargo were carried across the Pacific. Upon deactivation in 1969, the 349th moved to Travis AFB, CA.

In 1972, the 349th joined the active component in flying and maintaining the C–5 "Galaxy" making the 349th a two-weapon system reserve strategic airlift wing.

On February 1, 1992, the 349th was re-designated the 349th Airlift Wing, deleting the word "military" from its name to conform with the active-duty Air Force's reorganization and realignment policies.

In September 1994, the KC–10 "Extender" tanker mission was added to the Wing and became an "Air Mobility Wing," the only Air Force Reserve unit at the time to fly three types of aircraft: the C–141 "Starlifter," the C– 5 "Galaxy," and the KC–10.

With the C-17 "Globemaster III" arrival at Travis in Summer 2006, the wing and its host became the only units in the country to fly three major weapons systems. On May 25, 2006, the 301st Airlift Squadron converted from the C-5 to the C-17 and on June 25, 2006, the 945th Aircraft Maintenance Squadron was activated to support the Globemaster III.

Most recently the 349th Aeromedicine Squadron deployed reserve medical personnel in support of New York City's response to the Covid-19 pandemic, and 61 Wing Airmen deployed in support of Operation Allies Refuge.

Mr. Speaker Pro Tempore and colleagues, please join me in praising the dedicated service of the Air Force reservist assigned to the 349th Air Mobility Wing (Reserve), Travis AFB, CA, who give and have given of their time and talents to serve our Nation and support our military readiness.
