Reports Filed: Reports were filed today as follows: H.R. 359, to establish Fort San Gerónimo del Boquerón in Puerto Rico as an affiliated area of the National Park System, and for other purposes (H. Rept. 118–263);

H.R. 1607, to clarify jurisdiction with respect to certain Bureau of Reclamation pumped storage development, and for other purposes, with an amendment (H. Rept. 118–264);

H.R. 1722, to amend the Grande Ronde Reservation Act, and for other purposes (H. Rept. 118–265);

H.R. 3448, to amend chapter 3081 of title 54, United States Code, to enhance the protection and preservation of America's battlefields, with an amendment (H. Rept. 118–266);

H.R. 2717, to authorize the National Medal of Honor Museum Foundation to establish a commemorative work on the National Mall to honor the extraordinary acts of valor, selfless service, and sacrifice displayed by Medal of Honor recipients, with an amendment (H. Rept. 118–267); and

H.R. 1318, to authorize the location of a monument on the National Mall to commemorate and honor the women's suffrage movement and the pas-

sage of the 19th Amendment to the Constitution, and for other purposes (H. Rept. 118–268).

Journal: The House agreed to the Speaker's approval of the Journal by voice vote.

Page H5381

Department of the Interior, Environment, and Related Agencies Appropriations Act, 2024: The House passed H.R. 4821, making appropriations for the Department of the Interior, environment, and related agencies for the fiscal year ending September 30, 2024, and for other purposes, by a yea-and-nay vote of 213 yeas to 203 nays, Roll No. 597. Consideration began November 2nd.

Rejected the Leger Fernandez motion to recommit the bill to the Committee on Appropriations by a yea-and-nay vote of 201 yeas to 215 nays, Roll No. 596. Pages H5392-93

Agreed to:

Stauber amendment (No. 129 printed in part A of H. Rept. 118–261) that prohibits any funds from being used to implement or enforce the Administration's NEPA Phase 1 regulations; Pages H5387–88

Stauber amendment (No. 130 printed in part A of H. Rept. 118–261) that prohibits any funds from being used to finalize, implement, or enforce the Administration's proposed NEPA Phase 2 regulations;

Pages H5388–89

Westerman amendment (No. 131 printed in part A of H. Rept. 118–261) that prohibits the use of funds for the development, implementation, and interagency coordination of an Ocean Justice Strategy;

Pages H5389–90

Ogles amendment (No. 120 printed in part A of H. Rept. 118–261) that was debated on November 2nd that prohibits funds to carry out the provisions of section 50262 of Public Law 117–169 (Inflation Reduction Act) (by a recorded vote of 214 ayes to 204 noes, Roll No. 593);

Roy amendment (No. 126 printed in part A of H. Rept. 118–261) that prohibits funds from being used to carry out environmental justice activities (by a recorded vote of 212 ayes to 204 noes, Roll No. 594); and

Roy amendment (No. 127 printed in part A of H. Rept. 118–261) that prohibits funds from being used to implement any of the Administration's executive orders on climate change (by a recorded vote of 208 ayes to 207 noes, Roll No. 595).

Pages H5385-86, H5391-92

Rejected:

Schweikert amendment (No. 128 printed in part A of H. Rept. 118–261) that sought to reduce discretionary budget authority in the bill by 16 percent.

Pages H5386–87

H. Res. 838, the rule providing for consideration of the bills (H.R. 4821), (H.R. 4820), and (H.R. 6126), was agreed to Thursday, November 2nd.

Agreed that in the engrossment of the foregoing bill, the clerk be authorized to make technical corrections to include corrections in spelling, punctuation, section numbering and cross-referencing, and the insertion of appropriate headings.

Suspensions—Proceedings Resumed: The House agreed to suspend the rules and pass the following measure which was debated on Wednesday, November 1st:

Stop Harboring Iranian Petroleum Act: H.R. 3774, amended, to impose additional sanctions with respect to the importation or facilitation of the importation of petroleum products from Iran, and for other purposes, by a ²/₃ yea-and-nay vote of 342 yeas to 69 nays, Roll No. 598.
