After earning her bachelor's degree, she went on to secure her master's degree in social work at the Wurzweiler School of Social Work at Yeshiva University.

Following the completion of her studies, she returned to New Haven to begin her career. Robyn's first job was with the Jewish Community Center and her career has seen her participate in every aspect of the Greater New Haven Jewish Federation, an organization which she continues to work closely with today as the Interim Director for Women's Philanthropy. For more than a decade she served as the Director of Annual Giving and as Diversity Coordinator at Hamden Hall Country Day School and later became the Senior Director of the Mandel Center for Leadership Excellence for the Jewish Federation of America. She is also the founder of RKT Consulting Group and works with nonprofit organizations as a consultant and executive coach. She is also currently serving as the Interim Development Director for inSIGHT Through Education, a Holocaust education program in South Florida.

Robyn has a deep love for and connection to Israel and she has devoted many hours to coordinating trips to Israel on behalf of the Jewish Federation. This past spring, she was instrumental in coordinating a mission to Israel for a group of members from the New Haven and Hartford Jewish Federations. Looking back today, I am sure that those who joined the mission are grateful to have had such a meaningful experience.

Robyn and the work she has undertaken throughout her life are a reflection of her Jewish faith. Service to the community, cultivating giving in others, preserving Jewish history, and expanding educational opportunities not only for Jewish students but for society as a whole. Her efforts and leadership have been recognized with a myriad of honors from organizations like the Anti-Defamation League, Congregation B'nai Jacob, Yale New Haven Children's Hospital, and the Community Foundation of Greater New Haven.

Pastor Haynes, born in Dallas, TX, has committed his life to not only serving within the walls of his Church—Friendship-West Baptist Church—but has made it his mission to stand up for those without a voice. Specifically, his advocacy and commitment to advancing our community can be seen through his strong continued fight for fair lending practices, advocating for just food policies, seeking much-needed criminal justice reform, and much more.

One initiative born from the vision of Dr. Haynes is the successful THRIVE Intern and Leadership Program. The young people intern with local businesses across the Dallas-Fort Worth metroplex as well as Friendship-West and are paid at a rate above minimum wage while receiving intentional mentoring and engaging in community service. This program became so successful that Dr. Havnes received recognition from President Barack Obama for the creation and success of the program.

Celebrating his 40th Pastoral Anniversary earlier this year, Pastor Haynes has remained

a dynamic and powerful teacher of God's word who has been a source of hope and encouragement for many. Through his leadership, Friendship. West has grown its ministry and membership from less than 100 members in 1983 to over 13,000.

While there is much to celebrate and commend Pastor Haynes for, I'd be remiss if I didn't extend congratulations and recognition on his recent appointment as the new leader of the Rainbow PUSH Coalition, one of the nation's oldest civil rights organizations. Founded in 1971 by Rev. Under his leadership, I know that the organization will only grow and reach new heights in its impact on underserved communities.

Ms. TENNEY. Mr. Speaker, I rise today to join Niagara County and the Western New York Community in commending the family of WWI hero and Medal of Honor Recipient, U.S. Army Private First Class, Frank J. Gaffney for preserving his extraordinary military service and achievements during World War I.

On November 10, 2023, the Family of Frank Gaffney presented Niagara County with his medals including the Congressional Medal of Honor for permanent display in the rotunda of Niagara County Courthouse The display of these medals will not only maintain the legacy of Frank Gaffney, but it will provide a reminder that Niagara County is home to some of the bravest service members who have ever lived.

I am proud of all who supported the development of this project, including the Niagara County Legislature and the Niagara County Historian's Office. This one-of-a-kind display now stands as a symbol and reminder to Niagara County and all of Western New York of the heroic actions that Frank Gaffney took to preserve our freedoms.

On September 29, 1918, near Ronssoy, France, while serving with Company G, 108th Infantry Regiment of the U.S. Army's 27th Division, Frank Gaffney, an automatic rifleman, pushed forward alone, after all the other members of his squad had been killed. he discovered several Germans placing a heavy machine gun in position. He took swift action and eliminated the crew, captured the gun, bombed several dugouts, and, after killing four more of the enemy with his pistol, held the position until reinforcements arrived. Gaffney independently breached a portion of Germany's Hindenburg line helping capture 80 prisoners in the process. Due to his incredible actions, six different countries recognized and honored him including the United States. In 1919 Mr. Gaffney was awarded the Congressional Medal of Honor.

In 2022 a biographical book was published detailing Mr. Gaffney's life titled He Charged Alone by author John Strasburg. According to Strasburg, after WWI, Mr. Gaffney returned to Niagara County, New York, due to a combat injury during his service. Mr. Gaffney had to have his left arm amputated. Despite challenges he faced after the war, he raised a family and continued to advocate for several veteran organizations. He died in 1948 at the age of 62.

We must continue to recognize and commemorate those who sacrificed on behalf of our nation and fought on our country's many historic battlefields. I thank the family of Frank Gaffney and Niagara County, because of their contributions, one of our greatest heroes, Private First Class Frank J. Gaffney will forever be remembered within our local community. It is my honor to represent the community that Mr. Gaffney called home along with the members of our community who crafted this historic display.

Mr. PANETTA. Mr. Speaker, I rise today to highlight the successful outcome of the firstever U.S.-Central Asia Leader's Summit. On September 21, 2023, on the margins of the United Nations General Assembly, President Joseph R. Biden met with the Presidents of Kazakhstan, the Kyrgyz Republic, Tajikistan, Turkmenistan, and Uzbekistan for the inaugural C5+1 Presidential Summit.

Since its inception in 2015, the C5+1 platform has increased U.S.-Central Asia dialogue and cooperation to advance an independent, prosperous, and secure Central Asia that addresses common concerns in partnership with the United States. The United States and the C5 stand united and committed to activities in the region that enhance security, improve economic resilience, support sustainable development, combat climate change, and promote peace.

Key aspects of the security arrangement discussed at the summit included cooperation on law enforcement through expanded information sharing, cooperation on border security and safe migration, including respect for the sovereignty and territorial integrity of all nations, and the sharing of best practices on countering terrorism and preventing radicalization. The Parties also agreed to promote the rule of law and improve democratic governance.

To that end, the U.S. and Central Asia are determined to accelerate regional cooperation and connectivity. This includes expanding trade routes such as the Trans-Caspian Trade Route (or the "Middle Corridor"), advancing efforts to create a more favorable business environment for U.S. private sector trade and investment in Central Asia, and working toward establishing permanent normal trade relations (PNTR).

The Parties remain dedicated to integrating regional energy systems to diversify and expand new energy export routes and reliably supply global markets, integrating energy systems, increasing clean energy production, and developing and securing critical minerals supply chains The Parties are committed to redoubling efforts to increase clean energy production, mitigate methane emissions, develop sustainable hydropower capacity, and increase energy efficiency, particularly by mobilizing public and private financing for a green energy transition.

Through ongoing dialogue and collaborative efforts, the C5+1 can realize its vision for a more resilient, secure, and prosperous Central Asia, and foster closer people-to-people connections between the region and the United States.

HONORING THE LIFE AND LEGACY OF DORIS "DEB" BIESTERFELD TOWNSHEND

Ms. DELAURO. Mr. Speaker, today, family, friends, and community leaders will gather to remember one of the City of New Haven's greatest treasures, Doris "Deb" Biesterfeld Townshend, who we lost in September of 2020. At the age of 98, she had lived a full life and passed peacefully at her cherished, historic Victorian home, known as Raynham, on Townsend Avenue.

The Townshend's family line in New Haven stretches back to 1739, when Jeremiah Townsend of Boston, first settled there. Deb met her husband, Henry "Harry" Townshend, while still a student at Mount Holyoke College. In fact, they met on the train-an inspiring meet cute, especially for train lovers like me. Harry and Deb married in 1942 and became the fifth generation of the Townshend family to live in New Haven. Deb loved to tell the story of their homestead, Raynham, which had been in the family since 1798 which it was first established as a farm. The home was used as a summer home by the Townshend family until Deb and Harry made it their year-round, permanent residence. It was there that they raised their five children and celebrated seventy wonderful years together before Harry passed away in 2012.

Deb loved the Elm City and dedicated a lifetime to ensuring its history was both preserved and celebrated. She was not only a member of one of New Haven's longest tenured families, but she was also a historian, and it was her love of history and her strong belief in community that inspired her to work on a litany of local restoration projects and her service as a member of a myriad of boards, committees, and service organizations. She was a Past President of Fort Nathan Hale Restoration Projects and the East Haven Historical Society: a Past Vice President and Honorary Member of the New Haven Preservation Trust, as well as the Chair of New Haven's Historic District Commission for fifteen years and the Historian of the First Church of Christ for twenty-two years-just to name a few. Deb also volunteered her time at the New Haven Historical Society and served as a docent at the Peabody Museum of Natural History.

Deb was a force of nature, much like my own mother, Luisa DeLauro. They may have come from different sides of the political aisle, but they understood the importance of protecting the community and its New Haven's history. Deb played a critical role in my parent's effort to designate Wooster Square as New Haven's first historic district and she went on to play a key role in supporting historic sites across the City—including Fort Nathan Hale, the Federal Period King's Block in Fair Haven and ensuring the Townshend's ancestral home was placed on the National Historic Registry.

In her obituary, her children recounted a story from Deb's childhood. When she was young girl, Deb was asked what she wanted to be when she grew up and her reply was just one word: "Kind" It was a goal well met. Deb was not just kind; she was a reflection of the very best of us.

She loved her family fiercely and cared deeply for the communities she called home both New Haven and the Madison Valley of Montana. She was an extraordinary woman who leaves a legacy of service to which we should all strive.

I am deeply honored to have this opportunity to stand today to pay tribute to Doris "Deb" Biesterfeld Townshend. While I extend my deepest sympathies to her five children, Sharon, Cynthia, Hervey, Nancy, and Timothy and their spouses, as well as her ten grandchildren and seventeen great-grandchildren; I also extend my heartfelt thanks to the Townshend family for so graciously sharing Deb with us all. Like for so many others, her energy, enthusiasm and dedication were an inspiration for me, and her memory will continue to inspire for years to come.

DEPARTMENT OF THE INTERIOR, ENVIRONMENT, AND RELATED AGENCIES APPROPRIATIONS ACT, 2024

> SPEECH OF HON. BETTY McCOLLUM

IN THE HOUSE OF REPRESENTATIVES Thursday, November 2, 2023

Ms. MCCOLLUM. Mr. Chair, I rise in strong opposition to H.R. 4821, Interior, Environment,

and Related Agencies Appropriations Act, 2024. The overall 35 percent reduction to the top line of this bill is simply irresponsible. With this bill, House Republicans are endangering public health, damaging our public lands and natural resources, and are failing to address the existential threat of climate change.

Communities in Minnesota and across our nation need reliable access to safe drinking water and clean air. The Environmental Protection Agency is tasked with safeguarding the air we breathe and the water we drink, cleaning up harmful pollution, and responding to public health emergencies like the train derailment last February in East Palestine, Ohio, where the EPA is still overseeing the cleanup of toxic contamination today. This bill includes a crippling 39 percent cut to the EPA that will jeopardize our public health. H.R. 4821 eliminates funding for environmental justice grant programs. These programs are designed to ensure disadvantaged communities that have historically suffered from underinvestment have access to clean air and water and climate resilience solutions. Just this October, the EPA issued \$3 million in environmental justice grants across the state of Minnesota to address environmental or public health issues and build a healthier future for all Minnesotans. These grants must be protected.

Our public lands and natural resources must be protected not only for today, but for future generations. H.R 4821 threatens our public lands and critical watersheds throughout the nation, and specifically harms conservation efforts in Minnesota with harmful policy riders that would overturn two final decisions by the Forest Service and Bureau of Land Management to protect the watershed that flows through the 1.1-million-acre Boundary Waters Canoe Area Wilderness. This wilderness protects a priceless reserve of water so clean that vou can drink directly from the lakes. We should not be using a funding bill to ignore settled scientific record and overturn final decisions on mineral leases and mining withdrawals.

As Ranking Member on the Defense Appropriations Subcommittee, I am intimately aware that the Department of Defense considers climate change to be a top national security issue. Why are House Republicans harming our country's ability to respond to this threat? The drastic cuts made in this bill will put us at a severe global disadvantage in responding to climate change and helping communities who are directly affected by it.

Mr. Chair, instead of reevaluating their extreme 2024 funding bills and working to find a bipartisan path forward to fund the government beyond November 17th, House Republicans are moving forward with passing bills that have no chance of ever becoming law. With this bill, House Republicans are debilitating essential government agencies, jeopardizing our public lands and natural resources, and abandoning investments made by Democrats last Congress to address the threat of climate change. For all of these reasons, I must vote against H.R. 4821, and I urge my colleagues to do the same. Mr. DUARTE. Mr. Speaker, I rise today to recognize Captain Carrie Stephens upon her retirement for 33 years of dedicated service in the United States Navy.

Captain Carrie M. Stephens was born and raised in Newman, California, attending public school there until college. She received her Bachelor of Science in Business Administration from the University of the Pacific in June 1986. After working in the mortgage banking industry for a year, Captain Stephens attended McGeorge School of Law in Sacramento, California. In May 1990, she received her Juris Doctorate. While in law school, she was awarded the American Jurisprudence Award in Criminal Law. In November of 1990, she was commissioned in the United States Navy. Judge Advocate General's Corps. A month later, she was admitted to the California State Bar. Ms. Stephens has served a combined 33 years of active and reserve duty in the Navy, earning the rank of Captain.

From 1991 to 1994, Captain Stephens was stationed at the Naval Legal Service Office Treasure Island. She practiced criminal and civil law and was appointed as Special Assistant United States Attorney, Civil Division. In 1994, Ms. Stephens was transferred to Naval Construction Battalion Center Port Hueneme where she served as the base attorney handling civil and criminal matters and was later appointed Special United States Attorney, Criminal Division.

Upon her discharge from active duty in 1996, Ms. Stephens moved back to her hometown of Newman, and joined the Stanislaus County Public Defender's Office. As a Deputy Public Defender, Ms. Stephens handled all types of complex criminal matters. In 1999, she received a position with the office of Stanislaus County Counsel where for 18 years she represented the county child welfare agency, advocating for the protection of abused and neglected children.

In 2018, Captain Stephens was elected Superior Court Judge for the Stanislaus County Superior Court. She is the current Judge, presiding over the felony criminal department.

She was elevated to Chief Judge, Navy and Marine Corps Trial Judiciary, Reserve Component in December 2013 and for two years, commanded a cadre of military judges. Thereafter, she was selected Commanding Officer, NR RLSO Japan for a two-year billet.

Through a competitive selection process, Captain Stephens was designated an appellate judge assigned to the Navy and Marine

Court of Criminal Appeals from December 2017 to December 2019. From 2019 to the present, Captain Stephens has been with the Navy Reserve NAMARA Policy conducting legal reviews of courts-martial on behalf of the Judge Advocate General of the Navy and has served as a Special Assistant for the Deputy Advocate General for Reserve Affairs and Operations and Awards Board President.

Captain Carrie Stephens exemplifies the highest standards of duty, honor, and commitment through her 33-year career in the United States Navy. Not only is she an inspiration to her community of Newman, but she has also earned the admiration of California's 13th Congressional District. of the Beulah Heights First Pentecostal Church of New Haven, Connecticut in extending my heartfelt congratulations on the celebration of their 100th Anniversary. Throughout its history, the Church and its congregation have demonstrated a unique commitment to serve the community and ensure that the most vulnerable of our citizens could find comfort and resources in their time of need.

Originally named Beulah Heights Mission, the ministry was founded in a converted storefront on Poplar Street in New Haven during the summer of 1923 under the leadership of the late Elder Walter and Rosa B. Andrews. While their initial membership was modest, just twelve, over the next several decades, under the leadership of Elder Andrews, Mother Andrews, and then Elder Lambert Tolbert, the ministry saw steady growth. In 1943, the Elder George H. Brooks succeeded Elder Tolbert and in 1950 was installed as Pastor of Beulah Heights Church.

The installation of Pastor George Brooks at Beulah Heights Church also marked the beginning of what would be an expansion of the Church's work in the community and generational leadership at Beulah Heights. After serving as junior pastor under his father, Elder Theodore L. Brooks, Sr. was installed as the church's fifth pastor in 1988.

It was the vision and leadership of Bishop Brooks that Beulah Heights became a pillar in the Greater New Haven community. The first outreach ministry under this new administration was the Beulah Land Development Corporation, launching what still today is an ongoing renaissance in New Haven's Dixwell community. The organization's mission focused on transforming severely blighted properties into safe, revitalized affordable homes for working families. Over the last four years, its Back to School Fair has served over 1,500 children and 3,000 families. Children from preschool through high school receiving backpacks filled with all the tools necessary to be prepared on the first day of school and adults and parents in attendance are connected with a network of health and human services resources from around the city. The Beulah Heights Social Integration Program provides outreach to individuals who have experienced substance abuse, dependence and incarceration-equipping them with essential resources to help them obtain employment, housing, and mental health support. And the T.L. Brooks Ministries utilizes new technologies to make the preached word available for the masses on . CD and DVD.

Today, while Bishop Brooks remains an active participant in both the Church and its many ministries, his son, Elder Harold Brooks leads Beulah Heights First Pentecostal Church, while his other son, Darrell Brooks serves as the Chief Operating Officer for Beulah Land Development—representing a third generation of invaluable service to our community.

The Beulah Heights First Pentecostal Church has not only been a center for religious worship, but a vehicle through which their members could give back to the community. For the last century, the Beulah Heights First Pentecostal Church has been a fixture in our community, their ministry and outreach efforts leaving an indelible mark on our community. The Beulah Heights First Pentecostal Church gives its members a place to find their spiritual center and to solidify and support

At the age of 94, Reverend Martinez lived a full life, full of family, faith, and service to our community. His legacy of advocacy and religious leadership has left an indelible mark and will serve as an inspiration to many for generations to come.

Born in Puerto Rico, Reverend Martinez came to New Haven more than six decades ago, eventually making a home in West Haven where he has lived for more than fifty years. He and his first wife, Persida, raised six children, all of whom have mirrored their father's commitment to community. His son, John, was a beloved State Representative for many years before his tragic passing in 2002; Joe a firefighter for the City of New Haven; and Ariel, followed his father in becoming a pastor himself. His daughter, Evelyn, volunteered her time as a supervisor and site coordinator for the Vita Tax Program.

A Pentecostal Minister, Reverend Martinez founded the Door of Salvation Pentecostal Church of New Haven where he led the congregation for more than sixty years. As a spiritual guide, he nourished the souls of many often providing much needed comfort during the hardest of personal trials. A leader in the Pentecostal ministry and understanding the growing need for Spanish language led houses of worship, Reverend Martinez was also responsible for the establishment of a multitude of Spanish speaking churches across the state.

As a pastor, Reverend Martinez had a unique insight into the needs of his community. With many in his congregation struggling to find financial and economic security, he looked for ways he could make a difference in their lives. This led him to serve on several local service organization boards including the City of New Haven Crossroads Program, the Hill Health Center, and the Latino Youth Development Program. Always seeking to do more for his community, Reverend Martinez founded the New Life Corporation, an organization formed to aid communities and residents with financial and tax assistance: cofounded the Evangelical Spanish Association of New Haven, which assisted the inner city with low-income housing; and was instrumental in the development of Junta for Progressive Action, the oldest Latino, communitybased nonprofit organization in New Haven which began as an advocacy hub to address the needs of Greater New Haven first generation of migrants and has grown to offer nocost social services, legal services, immigration services, adult education, and youth programs to over 2.000 low-income individuals annually.

As a respected leader in his community, local elected officials often sought his advice and counsel. When I first decided to run for Congress, Reverend Martinez was one of my earliest supporters. He introduced me not only to his congregation but also several others across the City. He and his family embraced me, and I have cherished the special friend-ship we have built over the years. I, like so many others, have and will continue to be inspired by Reverend Martinez—his compassion, advocacy, and commitment to bettering our community and improving the quality of life for all.

Today we mourn the loss of a giant—a spiritual guide, a community leader, a friend, and mentor. Reverend Juan Martinez will be deeply missed by all of those fortunate enough to have known him. Title IV of Senate Resolution 4, agreed to by the Senate of February 4, 1977, calls for establishment of a system for a computerized schedule of all meetings and hearings of Senate committees, subcommittees, joint committees, and committees of conference.
