Mr. CARTER of Louisiana. Mr. Speaker, today, I rise to honor the life of Keith E. Weatherspoon. He was born on December 13, 1949, in New Orleans, part of Louisiana's 2nd Congressional District, to Catherine Adauf Weatherspoon and Leslie E. Weatherspoon.

Keith was raised by his maternal grand-parents in Robbins, Illinois, and attended Eisenhower High School in Chicago. Eventually, he moved back to New Orleans, graduating from Walter L. Cohen Senior High School. Mr. Weatherspoon remained in New Orleans through college, attending Xavier University of Louisiana, and later receiving a master's degree from Tulane University. Keith was also a proud member of Kappa Alpha Psi Fraternity, Inc., to which he was initiated in the Fairfax/ Alexandria Chapter in 1983.

In his professional life, Keith Weatherspoon was involved in pharmaceutical sales, and later stockbroking. During his transition into the world of stockbroking, he paused this work to serve as Special Assistant to then, United States President Ronald Reagan. Upon his return to investment banking, he was able to establish housing finance agencies to provide mortgages to low-income families for municipalities and states.

Keith later served as Senior Vice President at Donaldson, Lufkin, & Jenrette, a major investment banking firm, through which he handled bond issues across the nation. His work in this role was monumental for Louisiana public schools, which were able to remain open in April 1988 thanks to Keith's facilitating a Louisiana bond refunding issue of \$1.2 billion. Mr. Weatherspoon also held innumerable leadership positions, such as Director of Business Development at Airware LLC and Managing Partner of Sterling-Weatherspoon. He had over 40 years of real estate experience, most recently at Berkshire Hathaway Home Services, and worked tirelessly on developing the Electric Vehicle charging industry.

Keith was committed to serving as a positive force for good, through uplifting others and remained committed to the city of New Orleans. Here, he served on the Board of City Trusts and counseled public officials on economic and municipal issues. He was devoted to the Zulu Social Aid and Pleasure Club, as a lifetime member and 1990's King Zulu. Keith was also a founding member of the Good Providers Fishing Club.

Mr. Weatherspoon met the love of his life, Debra Sterling Weatherspoon, in 2005, and was able to create beautiful memories by her side. They spent their time traveling and watching their beloved New Orleans Saints football games, alongside their cherished friends from their time at university. Most of all, they spent their time smiling and laughing

alongside one another. Keith and Debra were members of the Franklin Avenue Baptist Church in New Orleans, and, after Hurricane Katrina devastated New Orleans, the couple relocated to Texas, where they became members of the Metropolitan Church in Houston, Texas. Though residing in Houston, they celebrated every holiday and milestone in New Orleans.

Keith is survived by his devoted wife, Debra Sterling Weatherspoon, and one daughter, Ashley Marie Weatherspoon from his late exwife Marie Slade Weatherspoon. Keith also leaves to cherish his memories, three sisters, Cosette Weatherspoon West Kaufman (Julius), Giselle Weatherspoon Williams, and Nadja Weatherspoon Carr (Dennis); Sister-in laws, Yvonne Sterling, Verdell Sterling Carter, and Brother-in-law Howard A. Sterling; Godchildren, Kristal Terrel, Nikki Carter-Williams, Rodrick Davis, and Myran Ifford; and a host of nieces, nephews, other relatives, and friends.

He was preceded in death by his parents, Lester Earl Weatherspoon, and Catherine Adauf Weatherspoon, Maternal grandparents, Albert S. Adauf (Adolph), Mary Dixon Adolph (step-grandmother), Elizabeth Ovide Adauf and his Aunt Irene Adauf Williams.

Mr. Weatherspoon was a staunch believer in "if you want something in life, you must work hard for it". This is evident through the work that he put into every facet of his life, from his devotion to his loving family and friends to the innumerable number of commitments to which he dedicated himself. His legacy should serve as an inspiration to all. I will forever cherish the many conversations I shared over the years with my fraternity brother and confidant. His impact will be forever engraved in the lives he touched along the way. I am proud to say, I am a benefactor of his knowledge. Rest well, my brother.

Mr. THOMPSON of California. Mr. Speaker, I rise today to honor Nick Deguilio, a Deputy with the Napa County Sheriff's Department. I have named Mr. Deguilio as a Public Safety Hero of the Year for Napa County in California's 4th District as a result of his extraordinary selflessness, dedication and service to others.

Mr. Deguilio was born and grew up in Napa, California, where he spent most of his younger years playing football. After graduating from Justin Sienna High School. Mr. Deguilio attended college at University of California, Santa Cruz, obtaining a bachelor's degree in history in 2004.

In 2008, Mr. Deguilio and his brother Dominic attended the Police Academy before embarking on his career as a Deputy Sheriff at the Santa Cruz Sheriff's Office where he spent the next four years. Mr. Deguilio then made the move to the Sonoma County Sheriffs Office where he spent nine years before being hired by the Napa County Sheriffs Office in 2021.

In the early afternoon on July, 16, 2023, Mr. Deguilio responded to a medical call from an adult male that had sustained a hand cut from a boat propeller. Not knowing the severity of the injury, and without a dispatch broadcast, he recognized the potentially urgent situation, notified his colleagues and raced to the scene. Within seven minutes. Mr. Deguilio arrived and took control of the incident. While evaluating the patient's injury, consisting of a partial hand amputation, he requested an air ambulance and applied a tourniquet to stop excessive bleeding. Mr. Deguilio remained attentive to the patient, who was in apparent shock and somewhat unresponsive, before being relieved by Cal Fire and other responding deputies. The patient was then transported by helicopter to a hospital where he underwent multiple surgeries. The guick thinking and actions by Mr. Deguilio helped stabilize the victim and prevented a possibly far worseoutcome.

Exactly two months later Mr. Dequilio responded to a stabbing at a remote residence in Napa County, Initial details from a call to 911 were that the caller's husband had been stabbed by an unknown person in their backyard and that the husband was attempting to hold the suspect down. Mr. Deguilio was first to arrive on scene and decided to attempt to locate the victim and suspect without waiting for backup. He found the injured resident, who had taken the weapon and was holding the suspect down. Mr. Deguilio took control of the knife and immediately handcuffed the suspect when the resident fell to his hands and knees. He promptly cut open the resident's bloodied shirt, finding a 3-inch open stab wound on his upper back. Not knowing the severity of the stab wound, Mr. Deguilio immediately applied a "chest seal" to the resident's back, applying continual pressure while awaiting further medical assistance. As deputies arrived at the scene, he learned the suspect had also been stabbed during the altercation. Once medical personnel arrived and began aiding the resident, Mr. Deguilio moved to provide first aid to the suspect, applying another "chest seal" to the suspect's stab wound. Mr. Deguilio's quick decision-making certainly saved lives.

Mr. Deguilio's actions during both incidents show selfless dedication and service at the highest of levels to our community and the Law Enforcement profession.

Outside of work Mr. Deguilio is heavily involved in his child's Little League team as the coach. He recently competed with his brother in the Top Cop Challenge pistol match in Amador County. The brother duo placed second in the team competition and placed second and third in the individual competition. They then donated their five-thousand-dollar winnings to the First Responder Support Network/West Coast Post-Trauma Retreat. Mr. Deguilio is proudly married to Kati Deguilio,

RECOGNIZING AMY RUTKIN AND HER SERVICE TO THE U.S. HOUSE OF REPRESENTATIVES

Mr. NADLER. Mr. Speaker, I rise today to thank Amy Rutkin for nearly twenty-five years of outstanding service to the constituents of New York's 12th Congressional District and the House Judiciary Committee.

The decision to hire Amy as my Chief of Staff in 1999 was—as all my best decisions are—at the suggestion of my wife, Joyce, who had met her while working on the same New York City Comptroller race. While Amy hadn't previously worked on the Hill, upon meeting her, I knew she possessed the intellect, tenacity, and problem-solving skills necessary to step directly into the Chief of Staff role.

Previously, Amy had served as Director of Government Relations and Public Policy at Hadassah; as a Policy Analyst for New York Governor Mario Cuomo; and as Associate Director of Public Affairs at Planned Parenthood. This experience demonstrated our shared passion for advocacy and fighting for the principles we both believe in: women's and LGBTQ+ equality, civil rights, progressive Zionism, and much more.

While Amy grew up in Arizona and earned her undergraduate degree at Brandeis University in Boston, Massachusetts, she became steeped in the world of New York City politics when she studied at my alma mater, Columbia University, going on to graduate with a master's in public administration.

Despite a promise not to stay in the position "a day over four years," Amy was quickly thrown into the center of some of our nation's most significant challenges, and her commitment to seeing those challenges through kept her fighting alongside me for nearly twenty-five years. Barely two years into her taking the Chief of Staff role, the 9/11 terrorist attacks devastated my district, which then stretched from the Upper West Side of Manhattan through the heart of the World Trade Center and to parts of Brooklyn. We knew immediately that the air in Lower Manhattan wasn't safe to breathe—despite assurances from the Bush Administration-and in the years following, Amy dedicated herself to leading efforts in Congress to care for the victims, work that culminated in the James Zadroga 9/11 Health and Compensation Act. This landmark legislation upheld our promise to our nation's heroes who responded to the attacks as well as to all those who had been impacted by the toxic dust in the disaster area—a monumental feat that affected thousands of lives. Thanks to her persistence and dedication. Amv's impact on our 9/11 families can be felt far and

Years later, in 2017, our work together would face its biggest test as I entered the race to become Ranking Member of the House Judiciary Committee. Thanks in great part to the strong record I had built over the years with Amy's advice, I earned the trust of my colleagues to become the Ranking Member, a goal we had discussed for many years finally coming to fruition. I was proud to appoint Amy as Chief of Staff to the Committee, a role she seamlessly assumed following our victory.

Becoming Ranking Member—and later, Chairman—of the Judiciary Committee brought with it great opportunities for legislative action that Amy and I had talked about for years. It came with a caveat, however; Donald Trump was the President, and there was mounting pressure to launch an impeachment inquiry as he was fundamentally threatening and degrading our democracy.

Amy navigated the complexities of leading an impeachment with a steady hand, facing a demanding schedule and non-stop media attention, managing a staff of some of our nation's finest minds, and working closely with the House Leadership team. This experience earned her the acclaim of former Majority Leader STENY HOYER, who praised her "wise counsel" and "razor-sharp instincts," an assessment I couldn't agree with more.

After the Impeachment concluded in early 2020, unbeknownst to anyone at the time, we would be back again the following year for yet

another impeachment after President Trump led the January 6, 2021, insurrection at the Capitol. While under vastly different circumstances—this time, the Members were the direct victims of the President's crimes—Amy built on past experience to give President Trump the dishonor of being the only President to be impeached twice.

Impeachments aside, Amy's tenure leading the staff of the Judiciary Committee allowed us to realize several legislative goals we had worked on together for two decades.

For example, back in 2009, when same-sex marriages were under attack, Amy was critical in helping author the Respect for Marriage Act to protect marriage equality, a bill that was seen as fanciful at the time. Although the Supreme Court later recognized marriage equality in the Obergefell decision, this right came under renewed threat when Justice Thomas urged revisiting that precedent in the Dobbs case, which overturned decades of precedent protecting the right to reproductive freedom. Amy seized the moment and jumped into action to revive efforts to pass the Respect for Marriage Act. Within months, we were on the White House Lawn together with President Biden as he signed the bill into law. A dream that seemed impossible just a decade earlier had become a reality largely due to Amy's relentless tenacity for LGBTQ+ equality.

Fighting for civil rights has always been at the core of my political philosophy, but it was never more urgent than in the wake of George Floyd's murder in 2020, when our country was clamoring for change to our nation's approach to policing. Amy worked in tandem with then-Representative and now-Los Angeles Mayor Karen Bass to advance the George Floyd Justice in Policing Act through the House, not once but twice. On their work together, former Congresswoman Bass said, "Let me say in no uncertain terms that the United States House of Representatives would not have been able to pass the most comprehensive police reform package in United States history—the George Floyd Justice in Policing Act—two different times, without Amy's steady guidance and leadership."

Simply put, under Amy's leadership, the House Judiciary Committee was as productive and consequential as it has ever been in the years I served as Chairman. These accomplishments allowed me to run in a difficult primary last cycle on a record that was unmatched, and I am thankful to Amy not only for helping to develop this record, but also for amplifying to constituents the impact of my work in Washington.

Even now in the minority, Amy continues to influence the issues she is most passionate about. In the wake of the October 7th attack on Israel, she has doubled down on her work supporting my role as the most senior Jewish Member of Congress and she is a visible demonstration that you can be both progressive and Zionist. She is relentless in her work supporting our informal group of Jewish Members of Congress—and her success in bringing together voices from across the political spectrum speaks volumes to her understanding of the complexities of the Jewish community and her deep connection to the values that bind us together.

I would be remiss if I did not mention Amy's children, Phoebe and Zoey. Both of her children were born during her tenure in the office, and for me and the rest of our team, it has

been a pleasure watching them grow up and hearing their stories and jokes about their dog, Rufus

As Amy moves on to the next chapter in her life, I am forever grateful to have had her by my side for nearly twenty-five years as my most trusted advisor. With her brilliant political instincts, keen understanding of policy, and strong moral compass, she has been essential in bringing about so many of my accomplishments throughout my tenure in Congress.

I want to thank her for her many years of service and her friendship over the years. My district, the Judiciary Committee, and the lives of millions of people are better off for having had Amy fighting on their behalf.

Mr. THOMPSON of California. Mr. Speaker, I rise today to honor Ghost, a City of Santa Rosa Police Department K9. I have named Ghost as a Public Safety Hero of the Year from Sonoma County in California's 4th District because of his extraordinary selflessness, dedication and service to others.

Ghost is a 2-year-old Malinois who was born in Modesto, California and began his service with the Santa Rosa Police Department in September 2022. He lives and works with his partner, Officer Aaron Gonzales-Campos, along with Officer Gonzales-Campos' wife and two daughters. Ghost enjoys being a big brother to his two little sisters.

In a time of rampant gun violence, Ghost serves a crucial role for our community. Ghost and Officer Gonzales-Campos are Sonoma County's first firearm detection Police K9 team. After hundreds of hours of training and achieving certification in January 2023, Ghost is able to detect odors from firearms and related objects such as ammunition. After identifying an odor, Ghost identifies the threat to his partner.

In his first year and in addition to his regular duties, Ghost intercepted and removed eight illegal firearms from the streets of Santa Rosa. Just two weeks ago, he helped bust an identity theft ring that was also manufacturing illegal ghost guns and assault rifles. A proactive approach to intercepting illegal firearms is keeping Santa Rosa safe and reducing the risk of violent crimes.

Mr. Raby attended New Orleans public schools, James Weldon Elementary School, and Walter L. Cohen Senior High School. Jim and his high school sweetheart, Nola, were part of the third graduating class of Walter L. Cohen High School in 1955 and have been married for 63 years.

Upon graduating from Walter L. Cohen High School, Mr. Raby matriculated at Southern University in Baton Rouge, where he earned a BS in Mathematics. Jim went on to earn a master's in education, and a certification in Adult Education. During his time at Southern, he became involved in the Reserve Officers' Training Corps (ROTC) Program and, after graduating in 1959, received a Commission as an Army Second Lieutenant. In September of 1963, after serving 4 years on active military duty, during which he was often the only African American commissioned officer, Mr. Raby was honorably discharged with the rank of Captain.

After his discharge from the military, Jim began worked at the Philip Morris Tobacco company, a company for which he was the only African American sales representative in Louisiana. In November 1967, he resigned from his position at Philip Morris Tobacco company, and became the first African American to serve as a Field Underwriter for New York Life Insurance Company in the New Orleans General Office.

Once he retired from this position in 1994, Mr. Raby began working for the Orleans Parish School Board as the Program Coordinator for Project Independence. In August 2009, Jim was elected President of the Board of Directors of the Walter L. Cohen Alumni Association, through which he spearheaded efforts to rebuild Walter L. Cohen High School on its original site.

Mr. Raby's dedication to the different communities of which he is a part is evident throughout his story. He has not only contributed immensely to his Alma Mater, Walter L. Cohen High School, but also to our state, and to our nation. I commend Walter L. Mr. Farrow's distinguished career in law enforcement began as an officer with the Pacific Grove Police Department. He was appointed commissioner in

He has earned awards for his leadership including the Distinguished Service Award in 2017 and the UC Davis Chancellor's Award for Exceptional University Leadership in 2023.

Mr. GRIFFITH. Mr. Speaker, I rise today to honor the life of Roy Scherer, who passed away on December 8th, at the age of 81.

Roy was born on February 2, 1942, in Richmond, Virginia. He spent most of his childhood attending military schools and then went on to spend a few years in the U.S. Air Force after graduation.

According to his family, Roy's experience at the 1969 Democratic Convention in Chicago inspired him to fight injustice wherever he saw it. For him, one of those injustices was the penalties for drugs in Virginia. Roy formed Virginians for the Study of Marijuana Laws, becoming Virginia's first registered marijuana lobbyist.

In 1977, Roy was arrested for sneaking weed plants into the Virginia State Capitol. According to Roy, Delegate Cranwell didn't know what a weed plant looked like and wanted to see one, so he brought one in to show him. This explanation was apparently true and led him to being let off the hook.

When I was in the House of Delegates, he came to all of the Subcommittee on Courts of Justice meetings, advocating for saner drug policies and weed legalization.

There was once a bill introduced which would make the penalties in Virginia for crack cocaine and powdered cocaine possession similar to those in the federal law. Roy stood up and detailed how powdered cocaine was used primarily by white drug users and crack cocaine was used primarily by black drug users, and that in the bill the penalty for crack was far harsher than for powered cocaine. Knowing the Members of the Committee, Roy knew we wouldn't stand for this injustice.

Bob McDonald, Dave Albo, and I looked at each other and then looked down the dais. Kenny Melvin and others looked back and instantly we knew Roy was right; we amended the bill to make the penalties equitable.

Years later, the Supreme Court of the United States struck down the federal law because the inequitable drug penalties were unconstitutional.

Roy Scherer proved that, at least in Virginia, a well-reasoned conscientious citizen could address his government and be heard. We will always be indebted to his example.

Roy was also a big supporter of concealed carry. Being that he had no driver's license, Roy would ride his bicycle to the Capitol and keep his gun on him as the route he traveled to the Capitol was through an unsafe part of town. However, when he wanted to eat in a restaurant nearby, he would have to hide his gun in a bush outside of the restaurant. This led him to fight for concealed carry in restaurants in Virginia.

Roy is survived by his beloved wife and best friend, Sally, his sister Barbara, and his brother Frank, as well as many friends. I wish them all my deepest condolences for their loss.

A true Libertarian and a dedicated citizen, Roy made an impact on everyone he met, including myself. May his memory be a blessing to all who knew him.

Despite experiencing the challenges from a rare generic condition, Caroline was a champion for improving health care for people with medical complexities and a beacon of inspiration to me and everyone whose paths she crossed.

Born five weeks prematurely, Caroline suffered a seizure and stopped breathing in the first 12 hours of her life. Throughout her life, she underwent specialized speech, physical and cognitive therapy coordinated with the help of the Chronic-Complex Clinic at St. Joseph's Children's Hospital, a national leader in pediatric care. Although her battle with AHC was challenging and debilitating, Caroline was able to receive an education while creating lasting memories.

Caroline was always vibrant and loving, and her joy centered around spending precious moments with her family and friends. From indulging in her favorite music by Miley Cyrus and Taylor Swift to getting pampered with nails and makeup, she embraced life with a fun-loving spirit. Despite her limited speech, Caroline communicated effortlessly through her expressive eyes, warm hugs and an innate ability to sense when someone needed comfort, making her a uniquely perceptive and uplifting presence in the lives of those around her.

I am proud of Caroline's resilience and of her mother, Tish, for her unconditional love and willingness to fight for Caroline and every child with medically complex conditions. Caroline and Tish's invaluable work and advocacy inspired my work on the ACE Kids Act, which created a national medical home model for children with medical complexities. Tish and Caroline advocated for this bill in Washington and locally in Florida and in Congress, including Tish's testimony before the Energy and Commerce Committee. Because of their tireless advocacy, ACE Kids was signed into law

in 2019, so now children with medical complex needs can access better and more coordinated care, which will improve health outcomes, lower costs, and make families lives easier.

I have the deepest gratitude to Caroline and Tish for their sacrifices in helping address the unique challenges my neighbors with medically complex conditions face under the health care system to bring the best care. Caroline is survived by her parents, Tish and Bill West; her siblings, Billy, Drew, and Mallory; and many family members and friends who were all very dear to her. Additionally, I want to extend my gratitude to the medical team that helped Caroline and her family through this journey.

Keri Eisenbeis, BayCare Health System's Chief of Staff and Chief Communications Officer, emphasized the West Family's dedication to advocacy, stating that "the West Family, including Caroline, have been tireless champions for medically complex patients, including those at BayCare's St. Joseph's Children's Hospital." In addition to extending their condolences, they "mourn Caroline's passing, but celebrate the legacy of advocacy she inspired which led to the passage of the ACE Kids Act."

Mr. Speaker, I want to express my sincere condolences to Caroline's family and friends. She will be remembered by her warm smile and contagious laugh. Caroline was taken from us too soon, but she leaves with us infinite life lessons and an immeasurable impact on those who knew and loved her.

She plans to focus on continuing her education and training in resiliency and the neurobiology of stress and trauma in the first responder environment.

Ms. LOFGREN. Mr. Speaker, I rise to recognize the accomplishments of Mr. Bayard Rustin. His life was dedicated to civil rights advocacy, but because he was a gay man, his hard work and accomplishments were often shadowed.

Mr. Rustin was born in West Chester, Pennsylvania, where he was raised by his grand-parents, Julia and Janifer Rustin. Julia was an active member of the National Association for the Advancement of Colored People (NAACP)

and Bayard was introduced to the fight for civil rights when he campaigned against the discriminatory Jim Crow laws.

In 1948, Rustin traveled to India to learn from leaders of the Gandhian movement on nonviolent civil resistance. He brought those skills back to his work in the United States, assisting in writing "Speak Truth to Power: A Quaker Search for an Alternative to Violence." This was one of the most influential pacifist papers of its time, though Rustin remained an anonymous contributor due to fear that his known sexual orientation would compromise readers' respect for his contributions.

Rustin was instrumental in organizing the March on Washington in 1962. And yet, other prominent organizers did not want Rustin to receive any public credit for his hard work. His other accomplishments include organizing a group called "In Friendship" to provide legal assistance to people threatened with eviction and being named the first president of the American Federation of Labor and Congress of Industrial Organization's A. Philip Randolph Institute, which works towards integration and unionization of African Americans into formerly all-white unions. Later in life, he went on many humanitarian missions to provide aid and care to refugees in Vietnam, Cambodia, and Haiti.

Despite never receiving the recognition he deserved, he kept organizing and campaigning for what was right. Rustin worked for his own rights as a Black gay man and promoted values of nonviolence in civil resistance.

His unwavering dedication and vision of a peaceful and equitable nation is a guiding light. Though he was never given the recognition he deserved in life, I ask us to honor him now.

He also served in several illustrious positions, including Chairman of the Board of Hindu University of America and Vice President of the American Society of International Law.

In 2006 Professor Nanda was honored with a \$1 million founding gift from the University of Denver to launch the Ved Nanda Center for International and Comparative Law, promoting programs and scholarships in the field of international law. He was also honored with the prestigious Gandhi-King-Ikeda Award for Community Peace Building in 2004 and the Padma Bhushan in 2018. These accolades are a testament to his significant impact on the field and tireless efforts to advance knowledge and cultural exchange. His work was noticed and rightly honored for its impact.

For more than 30 years, Professor Nanda shared his wisdom with the larger Colorado community through his regular columns in the Denver Post. His clear and reasoned explanations of international issues provided important perspectives to readers.

EULOGY FOR MICHAEL DESTEFANO

Mr. TORRES of New York. Mr. Speaker, long before I was a Congressman and long before I had been a Council Member, I am and will always be the eternally grateful student of Michael DeStefano. For his influence on me is as powerful today, as it was nearly two decades ago, when God first brought him into my life.

When I was a kid, growing up in the 1990s, I would watch a show known as Boy Meets World, which had an iconic character, a wise, revered teacher by the name of George Feeny.

Mr. DeStefano was, in many ways, the Mr. Feeny of Herbert H. Lehman High School in the Bronx. As a teacher, Mr. DeStefano embodied for me the nobility of public education as a profession. And as a person, he was a formidable presence who could inhabit a room with the power of his personality and the force of his intellect. He had an eloquence and erudition that could captivate almost anyone who heard him speak. And captivate he did.

Indeed, Mr. DeStefano was the first educator to inspire me.

He engendered in me a love of words and ideas—a love that has remained with me ever since. He enabled me to discover a talent for public speaking I never thought I had. He encouraged me to lead the Lehman High School Law Team, which, I believe, set me on a trajectory that led to the New York City Council and then ultimately to the United States Congress. Words cannot capture the fullness of what Mr. DeStefano has meant to me.

The only constant in life, it has been said, is change. The ancient Greek thinker, Heraclitus, put it best: no person steps into the same river twice. The river is not the same, and neither is the person. Everyone and everything changes constantly at every moment. Reflecting on the theme of a constantly changing self, William James once observed that we have various selves at various points in our lives, and how do we know which one of those selves is the true self? According to James, the true self is one in which we feel most deeply and intensely alive.

Mr. DeStefano inspired me to pursue Moot Court in high school, and it is through Moot Court where I began discovering something resembling my true self, where I felt most deeply and intensely alive for the first time in my life.

As a student at Lehman High School, I remember looking for reasons to stop by Mr. DeStefano's office just to listen to and learn from him, just to be inspired by him. He never disappointed. He never ceased to amaze me with the sheer breadth of his knowledge and the sheer eloquence with which he could express every thought that came to mind and the sheer seamlessness with which he could move from one subject area to the next: philosophy and history and psychology, economics and international relations, literature, and religion. He could speak effortlessly about all of it. He had anecdotes and allusions, guotes and statistics that he could readily recover from his encyclopedic mind.

Whether it is Abraham Maslow's theory of self-actualization as the highest human need or Immanuel Kant's concept of the thing in itself or Soren Kierkegaard's leap of faith: all of these ideas that continue to shape how I think about life and the world were born out of conversations with Mr. DeStefano nearly two decades ago.

Those dialogues with Mr. DeStefano remain fresh in my mind as if we had spoken yesterday. I often find myself wondering: What would Mr. DeStefano do about a particular problem? What would he think about a particular question?

As I ask these questions, I am reminded that I am a better person and a better public servant for having had Mr. DeStefano as an educator in my life.

Mr. DeStefano brought out the best in me, and that, to me, is the greatest gift that one can give you.

I am grateful to his wife for sharing her brilliant husband and to his daughters for sharing their brilliant father with the students of Lehman High School, where he served with distinction as an Assistant Principal and teacher for decades.

He was a close confidante of Robert Leder, who at the time was the longest serving principal in the NYC public school system, beloved by many in the Bronx and beyond. The two of them, together, were the dream team in public education.

I miss and love them both.

Mr. DeStefano's legacy will live on not only in the lives of his family and friends but also in the lives of his students.

I will end as I began: I am proud to be a student of Michael DeStefano—always have been and always will be.

May my greatest teacher Rest in Peace.

REMEMBERING ARCHITECT ROBERT BONNER NORCROSS

Mr. COHEN. Mr. Speaker, I rise today to pay my deep respects to Robert Bonner Nor-

cross, a Memphis architect known for his designs of many Memphis landmarks, who died from complications of Early Onset Alzheimer's on December 27 at the age of 62. A native of Tyronza, Arkansas, and a graduate of Marked Tree High School and Fay Jones School of Architecture and Design at the University of Arkansas, Mr. Norcross became a principal in the architecture firm Looney Rick Kiss and led projects that transformed the city of Memphis and nearby communities for three decades. He was licensed in seven states and perhaps best known for his work on AutoZone Park, named the Minor League Ballpark of the Year in 2009 by Baseball America, and the FedEx Forum, home of the NBA Grizzlies and the University of Memphis Tigers. He had a hand in South City, the St. Jude Children's Research Hospital expansion. Soulsville Charter School and Multipurpose Building, Central Station, many homes in Harbor Town, the University of Memphis Men's Basketball Training Center, AutoZone's headquarters and the FedEx World Technology Center in Collierville. In 2020, he won the prestigious Francis Gassner Award from the American Institute of Architects-Memphis Chapter. Active in his Grace-St. Luke's Episcopal Church and its Vestry St. Columba outreach ministry in West Tennessee, Mr. Norcross was also a board member of the Boys & Girls Club of Memphis. Leadership Memphis, the Memphis Leadership Academy of Arkansas, Dean's Circle at Fay Jones School of Architecture and Design, and was a founding committee member of the Regional Memphis Design Center. I attended his service at Grace-St. Luke's on Saturday which was packed to the walls. I read the eulogy written by his children and will never look at butterflies again in the same way. I express my sincere condolences to his wife of 37 years, Jill, and their children Phoebe and Brandt, his colleagues and his many friends. He led a good life, but he left us too soon.

My heart goes out to Dan's wife and children. I would like to include in the RECORD a Facebook post written by his daughter Claire that encapsulates the tremendous man, husband, father, grandfather, and educator he was:

"Yet another post I didn't imagine having to write . . .

If you are lucky enough to know my Dad, you know there are not enough words to say about him.

Dad taught us, inspired us to be better people everyday. He passed many lessons and things on to us kids.

Education is important. Five Perry High School graduates . . . were lucky to walk across the stage as Dad said our name with pride and we gave him a hug, Dad's hugs will never be beaten . . . and then five college graduates that represented the state of Iowa. Two graduates from UNI, a Central College grad, a Luther College grad, and a University of Iowa grad. Four out of five of us now work in schools or for schools. The fifth child actually makes money.

As a teacher in his building and watching

him handle students and accommodating as needed to see them succeed, it became clear to me the impact we teachers and adults can have on our students. Sometimes all a kiddo needs to find success is for someone to genuinely hear them, and see them, and prove to them that someone cares about them after their mistakes, after their bad choices, and to not leave them out to dry. Dad took no greater pride than seeing the kids he harped on and held up tough expectations for, walk across the stage with a diploma in hand. He also made sure that each student had their correctly, pronounced spending months before graduation with flash cards pronouncing each name over and over so that every student and family got to hear their child's name or their name as they crossed the stage. If you know how diverse Perry is, you know how tough a test this can

Another thing Dad taught us was how to love. How to love each other, how to love our parents, how to love our spouses and significant others, how to love our kids and grandkids. And it comes down to one word, selflessly.

Dad loved my mom, Dad is in love with my mom, unconditional, no question, Dan & Elizabeth 4evr. His patience, his grace, his unwavering support for mom in good and bad times was so clear, I understand what it truly means and looks like to love another person, not just saying you love them but to live it and prove it every day. Not every kid is lucky enough to see this from their parents but we were.

Dad showed us that we are never too busy or too far away to care and support your parents. Dad has so much love and respect for his parents, he would drop anything to be there for them, however, whenever they needed. Give back to the people that give so much for you.

Us kids know now, especially looking back on our growing up years how much Dad loved us. Tough love when we needed, patience and understanding when we needed that. Expectations that he had, but expectations that he made sure we knew were important for us to have for ourselves.

It is the little things like calling me Clairey or sending me a random amount on Venmo saying "Gas" or "Lunch on me". I was so excited for my Dad to meet my girlfriend's three boys, knowing they would love him and he would love them as if they were my own. Going out of his way to make sure our boys felt welcome to the Marburger family. I really wish Dad had an opportunity to play catch with them, especially the youngest and his passion and love he is developing for football and being able to bond over that. The grandkids don't yet understand what they lost today, but there will forever be "grandpas babies", bear traps, gummy bears in the freezer, and plenty of naps in grandpas chair. All things we will carry on

My Dad was an incredible man, educator. husband, Dad, grandpa. A person I aspire to be and hope to make proud every day.

He will be greatly missed.

I love you, Dad. You are the best, forever".

Principal Marburger showcased to America, to Iowa, to our own families what Perry Strong means.

Mr. CARTER of Louisiana. Mr. Speaker, today, I rise to honor the life of Norman Raymond Smith, Executive Director of Harmony House Senior Center, the Tremé Community Education Program, an agency of the New Orleans Council on Aging. He was the son of the late Yvonne and Matthew Smith, Sr., born on November 17, 1944, in New Orleans, Louisiana, in the Historic Tremé Community, located in the district I represent. Mr. Smith passed away on Sunday, January 14, 2024.

Mr. Smith and his family, Roman Catholics, attended St. Peter Claver Catholic Church. The Mass was conducted in Latin which Smith could not understand, but he enjoyed the Gregorian chants and the singing of standard Black Catholic Church Hymns. He sometimes visited other churches with friends, which had very powerful Tremé voices accompanied by piano and sometimes guitar or drums. In his adult life, Norman joined Saint Paul the Apostle Catholic Church, where he served as an Usher.

As a youth living in the Historic Tremé, he attended Joseph A. Craig Elementary School, graduated from Joseph S. Clark Senior High School, and received his associate degree in Mortuary Science from the Commonwealth College of Science in Houston, Texas, becoming a licensed Mortician.

As a child, some of the first stories Smith heard were of family members from generations past. He knew that his father had been in the military, along with his grandfather and great-grandfather. In fact, his mother's greatgrandfather had served in the War of 1812, and her great-uncle had fought in the 9th Cavalry Heavy Artillery in the Civil War. Their stories fascinated Norman. Soon after finishing his training, he was drafted into the Army where he was to serve as a telephone technician, arriving in Vietnam and transferred to work as an identification specialist, and later he was tasked with preparing fallen heroes for return home to their families. After Smith returned from Vietnam, he worked as a funeral escort stationed at Oakland Army Base. His military service included serving as a United States Army Sergeant, Quarter Master Corporal, and was a Purple Heart Recipient, though never receiving his Medal of Honor. He was honorably discharged in 1969. He was also a member of the Veterans of Foreign War, following his service in the Vietnam War. a member of the American Legion Post 500, and the Disabled American Veterans. Chapter

He returned to New Orleans and began working at Charbonnet-Labat Funeral Home, also working at several other funeral homes in the city. His passion to see his community uplifted led to his ultimate involvement in community politics. His life as a community activist

started to take shape. He attended the inaugural class at the Institute of Politics at Loyola University. Norman also served as a delegate to the Democratic National Convention, electing President Jimmy Carter. Norman was instrumental in helping to elect countless men and women to state, local, and national offices

Education was always very important to Norman, so at the age of 50, he returned to Southern University at New Orleans and earned a Bachelor of Arts, BA in History. Norman worked as an Education Specialist at the State Department of Education under Superintendent Kelly Nix, serving Veterans across the State of Louisiana. His departure from the Department of Education led him to follow his dream of creating calendars like the one he read as a child at Joseph A. Craig School, Norman Rockwell. He began what would eventually add up to nine years of research on historical Black figures from Louisiana under the title "Etches of Ebony Louisiana", dedicating the rest of his life to researching and educating his community in the contributions of Black people born in Louisiana. In 1983 he published his first calendar.

An active resident of New Orleans until his passing, Norman was a renowned Culture Bearer, Tremé's Drummer, Photographer, member of Joseph S. Clark Alumni Association, Knights of Peter Claver Tommy Lafon Chapter 214, Loyola Institute of Politics, Amistad Research Center. Southern University New Orleans Alumni Association, Officer/ Member, New Orleans Embalmers Association, Crescent City Funeral Directors and Morticians Association, Louisiana Funeral Directors and Morticians Association, Louisiana Black History Historian, Political Strategist and President of Tremé Improvement Political Society (T.I.P.S.), and past member of the Upper Pontabla Board of Directors. He was also the Author and Publisher of "Footprints of Black Louisiana".

Norman was the proud father of two sons, Corey Norman Smith (Heather) and Christopher Jude Smith, born from his marriage to Joyce Singleton Smith. He was the loving grandfather of Sterling and Sydnei Smith, and Taylor Hampton; great-grandfather of Ava Rose and Dallon Steen, Jr., his sister Emelda Petit. Norman is preceded in death by siblings Emma Smith Brown, Matthew Smith, Jr., Anthony Smith, Verdelle Smith Johnson, Isabelle Smith, and Paulette Smith Pate.

He was one of those children who knew what he wanted to do at a young age. He wanted to be a historian. Specifically, he wanted to record and preserve Black history. As early as the fifth grade, Smith had the idea to make calendars that would bring to life the stories of Black historical figures. His goal was to share the many contributions Black people had made to American society, especially some who might be lesser known. "The point was to do something positive," he explained. "So little Black kids like me could have something to look forward to. To look up to." He successfully fulfilled his dream.

His impact on Greater New Orleans, especially the Tremé Community will forever remain engraved in the lives he touched along the way. Rest well, my brother.

I rise today to honor a team of public servants from the City of Santa Rosa all of whom traveled to and continue to support local and Federal Emergency Management Agency (FEMA) recovery efforts in Maui. Hawaii following the tragic wildfires of August 2023. The team includes Division Chief-Fire Marshall Paul Lowenthal, Deputy Director of Water and Sewer Operations Joe Schiavone, Chief Building Officer Jesse Oswald, Marin Water Communications and Public Affairs Officer Adriane Mertens and Programmer—Analyst Jake Bayless. I have named the team as a Public Safety Hero of the Year from Sonoma County in California's 4th District as a result of their extraordinary selflessness, dedication and service to others.

While people across our nation watched in horror as a wildfire engulfed Lahaina, many in our district found the sight sickeningly familiar. Just a few years prior in 2017, the Tubbs Fire swept through Santa Rosa destroying thousands of homes and taking twenty-two lives. Our community has hard-won wisdom when it comes to recovering from wildfire.

So, when FEMA Region IX Administrator Robert Fenton called Santa Rosa to ask for their expertise, these extraordinary public servants answered. Mr. Lowenthal, Mr. Schiavone, Mr. Oswald, Ms. Mertens, and Mr. Bayless landed in Maui on August 27, 2023. Over the coming months, the team provided extensive technical guidance in debris removal, information recovery, public communications, sewer service restoration, water service restoration and the development of

Maui's official recovery web portal: mauirecovers.org.

Mr. Lowenthal has been to Maui four times since the fire and continues to consult Maui County's Department of Water Supply, Department of Public Works, and numerous other agencies on recovery. Mr. Bayless helped convert key digital resources for survivors including our own community's into the new sonomacountyrecovers.org. mauirecovers.org. The website now serves as the official clearinghouse for Maui fire survivors seeking recovery information and services. Ms. Mertens provided over two months of public information support and provided technical guidance on the development of mauirecovers.org. Mr. Schiavone continues to work with Maui drinking and wastewater and was critical to the testing, flushing and restoration of water services. Mr. Oswald helped develop damage assessments and a rebuilding framework. He continues to consult Maui County Development Services Administration on recovery plan implementation and permitting process.

Mr. Speaker, we thank this team of exemplary civil servants for their persistence, service and commitment to our nation. Therefore, it is fitting and proper that we honor them here today.
