These victories marked a historic moment for SLCC, claiming their first national championships in women's sports. Mr. HOYER. Mr. Speaker, I rise today to mourn the loss of Dr. John Brooks Slaughter—a towering figure in academia and the science community in America. He passed away last month at the age of 89.

Some will remember John as the gifted engineer who devoted the first 15 years of his career to supporting the crucial work at the U.S. Navy Electronics Laboratory as a civilian employee. Later, he became the director of the Applied Physics Laboratory at the University of Washington, and assistant director for Astronomics, Atmospherics, Earth, and Ocean Sciences at the National Science Foundation (NSF).

Others will remember John for his leadership in academia and the sciences—especially after President Jimmy Carter selected him to serve as the sixth Director of the NSF in 1980. He excelled in that position during his two years, advocating for greater investment in science education, including at minority-serving institutions.

In Maryland, we will remember John as the man who transformed the University of Maryland, College Park (UMD) for the better as its Chancellor between 1982 and 1988—the first Black American to hold the position. He made our university more efficient, inclusive, diverse, collaborative, and prosperous. John was beloved by UMD's students, faculty, and staff alike. The same was true at Occidental College, where John served as President between 1989 and 1999, and at the University of Southern California, where John was appointed the Melbo Professor of Leadership in Education in 1999.

I'm sure John's wife Bernice, their two children Jacqueline and John, and the rest of his relatives will remember him as a devoted family man.

No matter who we are or how we knew John, however, we will remember him as a man of high intellect, great character, and unwavering devotion to serving others. For that, he has the gratitude of this Congress and this country. I hope all my colleagues will join me in mourning him and praying for his family.

Sanders went on to become a civil rights trailblazer in North Texas. He broke barriers in hiring practices by becoming the first black pharmacist to serve non-black customers in Fort Worth. Among his many accomplishments, he was recognized as a Pioneer in North Texas Pharmacy by the University of North Texas System College of Pharmacy. He went on to serve his community for multiple decades, and even after retirement, he continued giving back by mentoring many other young pharmacists.

He was also a man of faith. He was baptized at an early age and was a life servant of the Shiloh Missionary Baptist Church in Fort Worth, where he served as a deacon and head of the Brotherhood for over 50 years. Most importantly, he was a devoted family man.

Sanders will forever be remembered for his commitment to justice and the love he shared with his family and community. My prayers are with his loved ones and with the countless community members whose lives he profoundly impacted.

Battalion Chief with CAL FIRE's Sonoma-Lake Napa Unit. I have named Mr. Greenberg as a Public Safety Hero of the Year for Napa County in California's 4th District as a result of his extraordinary selflessness, dedication, and service to others.

Mr. Greenberg was born and grew up in Vallejo, California. He earned an associate degree in Fire Science Technology from Santa Rosa Junior College. Mr. Greenberg also achieved Bachelor of Science degrees in Business Administration and Financial Management from California State University, Chico.

Mr. Greenberg has dedicated much of his life to protecting our community from fire danger, working as a member of the Napa County Fire Department since the year 2000. In 2019, he became a member of the Napa Firewise Foundation (NCFF) Board of Directors which maps out Napa County's wildfire risks to public lives, residential communities, critical infrastructures, habitat protection and protection of the economies of tourism and agriculture. Mr. Greenberg is the operations branch director of CAL FIRE Incident Management Team 5 and a helitack crew member with the CAL FIRE Aviation Program. Over the past four years Mr. Greenberg has spearheaded efforts made by Napa Firewise and CalFire to reduce wildland fire impacts via pre-fire fuel reduction. These projects protect the public along evacuation routes, enhance defensible space among community sub-divisions of residential structures, re-establish historical dozer lines for containment of future wildland fires and manage our rural lands utilizing prescribed fires

and grazing. On July 5, 2023, a vegetation fire threat-School in the Coombsville area of Napa County. This fire started during peak hours at 1:35 pm and was influenced by a 13-mph wind on a grassy slope surrounded by residential homes. Lead by Mr. Greenburg, the City of Napa Fire Department, CAL FIRE and the Napa County Fire Department quickly defended the structures under threat and provided perimeter control from further fire growth. This response demonstrated the effectiveness of strong cooperative relations among centralized emergency responders and Mr. Greenberg's quick and effective leadership certainly prevented further damage to our community.

Mr. Greenberg is married to Natalie Greenberg and the two reside in Napa County with their two boys, 13-year-old Andrew Greenberg and 10-year-old Grant Greenberg. Mr. Speaker, we thank Mr. Greenberg for

HONORING CLARKSBURG FIRE PROTECTION DISTRICT

Mr. THOMPSON of California. Mr. Speaker, I rise today to honor the Clarksburg Fire Protection District. I have named them as Public Safety Heroes of the Year from Yolo County in California's 4th District because of their extraordinary selflessness, dedication, and service to others.

The Clarksburg Fire Protection District is an all-volunteer organization that has provided fire protection to the community of Clarksburg and the surrounding area for the past 78 years. Currently, the fire protection district has 23 trained volunteers who respond to fires, medical emergencies, vehicle accidents, and public service calls. The fire district has proven its effectiveness by responding to multiple emergency calls simultaneously, up to five at one time, without calling for aid from other agencies.

As the only chartered division of government in the Clarksburg township, the fire district has led numerous community events to organize discussions about the needs of the area. 90 percent of the fire district's volunteers live in the community creating a "neighbors helping neighbors" dynamic in many of the emergency responses. The volunteer firefighters are also very active in other aspects of our community and support numerous charitable and civic organizations.

As evidence of their importance to our community, in the end of 2022, extreme wind and weather events left Clarksburg without power and operational wells for days. The fire district responded by delivering water to the community for sanitation and opening the fire station as an emergency depot and warming station. Another instance of service came in recent years when a fire threatened Clarksburg. Within two minutes, firefighters were on the scene and suppressing the fire, beating the National Fire Protection Association rural response time standards by a wide margin.

Along with serving Clarksburg, the fire district participates in several mutual aid and automatic aid agreements with neighboring districts, neighboring departments, the county of Yolo, the state of California, and some federal agencies.

Mr. Speaker, we thank the Clarksburg Fire Protection District for their persistence, service, and commitment to our community. Therefore, it is fitting and proper that we honor them here today.
