Mr. JOHNSON of Louisiana. Mr. Speaker, I rise today to recognize Dr. Os Guinness for his distinguished career and his service to the American people and to Christians around the globe.

He was educated in England, where he completed his undergraduate degree at the University of London and his Doctor of Philosophy in the social sciences from Oxford University. Os has written or edited more than 30 books, including The Call, Unspeakable, A Free People's Suicide. The Global Public Square, and The Magna Carta of Humanity.

Os has also been a Guest Scholar at the Woodrow Wilson Center for International Studies, a Guest Scholar and Visiting Fellow at the Brookings Institution, and Senior Fellow at the Trinity Forum.

More importantly, he is the proud husband of Jenny and father of C.J. I have had the honor of meeting with both Os and Jenny on many occasions and have greatly appreciated

their commitment to fasting and praying weekly for America's leaders.

The impact of the life and work of Dr. Os Guinness will be felt in the Halls of Congress and around the globe long past the time that we are here. I know that I, and many more around the world, are trying to live by the words he wrote in his book, The Call: "We are not primarily called to do something or go somewhere; we are called to Someone. We are not called first to the special work but to God. The key to answering the call is to be devoted to no one and to nothing above God himself."

Mr. THOMPSON of California. Mr. Speaker, I rise today to honor the Historical Society of Winters, who are doing crucial work to preserve and commemorate the history of Winters' Japanese community.

The Historical Society of Winters began in 2004 as the Winters History Committee, initially created by the Winters City Council. In 2018, it became a nonprofit, and opened the Winters Museum that same Year. Their express intention was to be a 'museum without walls,' and to commemorate all the history of Winters, especially the history that had been forgotten.

One of the most important forgotten histories that the Historical Society has unearthed and commemorated is that of the pre-World War II Japanese community in Winters. In 1888, the first Japanese immigrants arrived in Winters, looking to create better lives for themselves and their families. Over the years, as more immigrants arrived, they created a thriving Japantown on the edge of the city. At its peak, the Japanese population of Winters numbered approximately 300 people.

Sadly, as World War II began, and President Roosevelt ordered the internment of all Japanese Americans on the West Coast, the community was torn apart. The thriving Japantown was abandoned, and all the families were sent to internment camps either in

Arizona or Colorado. But that was not the end of the story of this community. When the war finally ended on V–J Day in 1945. Japantown burned down in a suspicious fire. Due to this hostility, less than 15 percent of the pre-war Japanese residents returned to Winters.

This legacy of hostility and distrust of these people led to the stories of this integral Winters community being largely lost to history. But the Historical Society of Winters, along with the work of Japanese community members, has worked tirelessly to restore these memories and commemorate this essential part of our community's history.

To do this, the Historical Society took their advocacy to the local level. In the summer of 2023, they urged the Winters City Council to approve a monument which would commemorate the existence and history of the pre-war Japanese community and Japantown. In a unanimous vote, the city council approved the placement of the monument in Rotary Park, where the community once existed.

Without the dedicated and tireless advocacy by the Historical Society, as well as members of Winters' Japanese community, our community would likely have never learned about the existence and history of the pre-war community that shaped so much of this town.

For his brave service. he was awarded the European-African-Middle Eastern Medal with three bronze service stars, the Combat Infantry Badge, and the Good Conduct Medal. The 71st Infantry Regiment's Second Battalion is cited for its outstanding performance of duty in action against the enemy in Eastern France in December 1944 and January 1945.

After his honorable discharge, Joseph returned to New York to pursue a career and start a family. He obtained a job as manager at B.F. Goodrich Store in Albany, New York. Joseph married his beloved wife, Ethel McGeough-Moore and together they had four children, Elizabeth, Lela, Francis, and Ethel. He retired from B.F. Goodrich Store in 1972 after 42 years of employment.

When he was not working, Joseph maintained a fulfilling personal life and enjoyed hobbies such as traveling and smoking cigars. He was an active communicant of St. Mary's Church in Clinton Heights, New York, and a dedicated member of the Melvin Roads American Legion Post 1231, a veteran organization devoted to their community.

STATEMENT OF CONGRESSWOMAN ELEANOR HOLMES NORTON IN-TRODUCTION OF THE WASH-INGTON CHANNEL PUBLIC AC-CESS ACT MAY 6, 2024

Ms. NORTON. Mr. Speaker, I introduce the Washington Channel Public Access Act. This bill would prohibit the Secretary of the Army from finalizing, implementing or enforcing any rule that would restrict access to the Washington Channel (Channel) in the District of Columbia.

In 2019, the Secretary of the Army proposed a rule to establish a permanent restricted area in the Channel adjacent to Fort McNair, which would have restricted access to the navigable portion of the Channel by narrowing the waterway where recreational and commercial vessels could traverse and prohibited anchoring and mooring altogether. The U.S. Army Military District of Washington cited security needs at Fort McNair to justify the rule.

The proposed rule was arbitrary and capricious and would have unnecessarily restricted recreational and commercial access to the Channel without providing any security benefits.

Neighborhoods like The Yards and The Wharf have reinvigorated community engagement on the waterfront, and the Channel is increasingly used for regional transportation and recreation. The stretch of the Channel past Fort McNair is the only connection to the Potomac River. The rule would have likely forced kayaks, paddleboards and recreational boats into the same space as water taxis and river cruise ships, creating a potentially dangerous situation.

I hosted a public meeting in which community members expressed overwhelming opposition to the proposed rule, but military officials did not address the question of whether less restrictive measures could provide the same security. I then wrote asking Secretary of Defense Llovd Austin to direct the U.S. Army Military District of Washington and the U.S. Army Corps of Engineers to withdraw the proposed rule and to prohibit these agencies from proposing a similar rule. In 2021, the Committee on Transportation and Infrastructure passed a version of this bill. In 2022, the U.S. Army withdrew the proposed rule. Nevertheless, this bill is necessary to ensure that the Secretary of the Army does not finalize, implement or enforce a rule that would restrict public access to the Channel.

I urge my colleagues to support this bill.

After graduating with an associate degree in occupational studies from the Culinary Institute of America in 1977, at 21, he became an executive chef of La Normande in Shadyside. In July of 1980, Dr. Ryan was featured on the cover of Pittsburgh Magazine's "Pittsburgh's Culinary Revolution." Dr. Ryan returned to the CIA in 1982 to join the faculty.

Over the next 42 years, Dr. Ryan drove extraordinary growth and global impact at the CIA. He served as a director, vice president, and executive vice president before ultimately being named president in 2001, making him the College's first alum to hold the position. As CIA President, he acquired and added branch campuses such as CIA at Copia, in Napa Valley, CIA San Antonio, Texas, Singapore, and the growth of the Hyde Park, New York campus. These locations have become centers of food, wine, spirits, beverage, and culinary education, where the next generation of chefs, sommeliers, and food and hospitality leaders are developed.

Throughout Dr. Ryan's career, he has positively impacted the food and beverage industry through his platform as CIA president and numerous other leadership positions. He was elected President of the American Culinary Federation, the Nation's largest organization of chefs, and was elected to the Board of Direc-

tors of the National Restaurant Association. In 2023, Dr. Ryan was appointed to the U.S. Department of State Diplomatic Culinary Partnership. The "Kitchen Cabinet" was charged to find innovative ways of embracing food, hospitality, and community as diplomatic tools to engage world leaders, further crosscultural dialogue, and strengthen our bilateral relationships.

Dr. Ryan was named "One of the 50 Most Powerful People in Food" by Nation's Restaurant News and has received awards from countless food industry organizations. Dr. Ryan is one of five Americans to ever receive the Presidential Medal from the World Association of Chefs Societies, and he was inducted into the James Beard Foundation's who's who of Food and Beverage in America.

Mr. Speaker, no modern cullinary educator or culinarian has had as much influence on American Food dining or the culinary profession as Dr. Tim Ryan. His efforts have not only cultivated and shaped the next generation of culinarians, but also has left a legacy of what it means to be an exquisite person. Therefore, it is fitting and proper that we honor him here today.

BERRYESSA SNOW MOUNTAIN NATIONAL MONUMENT EXPANSION

HON. JOHN GARAMENDI

Mr. GARAMENDI. Mr. Speaker, today I rise to thank President Joseph R. Biden, Jr. for his proclamation pursuant to the Antiquities Act of 1906 expanding the Berryessa Snow Mountain National Monument. I also thank Secretary of the Interior Deb Haaland, U.S. Senator ALEX PADILLA (D–CA), Congressman MIKE THOMP-SON (D–CA04), and the Yocha Dehe Wintun Nation for their support in conserving this special place forever.

President Biden's proclamation expands the Berryessa Snow Mountain National Monument to include approximately 13,696 additional acres of federally owned public land in Lake and Colusa Counties, California, encompassing the entirety of the Molok Luyuk region within the Monument. Second, it directs the federal Bureau of Land Management and the U.S. Forest Service to improve tribal co-management of the Berryessa Snow Mountain National Monument. Third, it renames the former Walker Ridge tract to "Molok Luyuk," meaning Condor Ridge in the Patwin language of the Yocha Dehe and other Native American tribes indigenous to the area.

I am thrilled that President Biden issued this presidential proclamation to preserve the tribal wisdom, heritage, and cultural traditions that Molok Luyuk has been home to for over 11,000 years. This expansion follows years of advocacy by me, Congressman THOMPSON, Senator PADILLA; federal, tribal, and local officials representing Northern California; and nongovernmental organizations, including environmental conservation, public access, outdoor recreation, and off-highway vehicle groups.

In July 2015, President Obama issued Presidential Proclamation 9298, establishing the Berryessa Snow Mountain National Monument. This set the boundary as federal land surrounding the Lake Berryessa reservoir but omitted Molok Luyuk in Lake and Colusa Counties. My legislation (H.R.761/S.393) in the 114th Congress with then-U.S. Senator Barbara Boxer (D-CA) and Congressman THOMPSON to establish the National Monument would have included Molok Luyuk within the boundary.

In the 117th Congress, at the behest of Woodland, California-based Tuleyome, a nonprofit conservation advocacy organization cofounded by my former constituent Bob Schneider in 2002, I introduced the "Berryessa Snow Mountain National Monument Expansion Act" (H.R.6366/S.4080) with Senator PADILLA and Congressman THOMPSON. I and other members of California's Congressional delegation then called on President Biden to use his authority under the Antiquities Act of 1906 to expand the Berryessa Snow Mountain National Monument and provide opportunities for federally recognized tribes like the Yocha Dehe to engage in voluntary co-management with the relevant federal land management agencies. We also called on Secretary Deb Haaland to order the U.S. Board on Geographic Names to officially rename Walker Ridge to Molok Luyuk. On May 2, 2024, I joined the President in the Oval Office with Secretary Haaland for a signing ceremony granting our requests.

Conserving California's special places has been a lifelong passion throughout my tenure in the state legislature, as Deputy Secretary of the Interior during the Clinton Administration, and now as a Member of Congress. Molok Luyuk is one of those special places. It was a privilege to represent Lake and Colusa Counties as the U.S. Representative for California's Third Congressional District from 2013 to 2023, and I am honored to have played a leading role in expanding the Berryessa Snow Mountain National Monument to preserve Molok Luyuk's ecological diversity and tribal heritage for future generations.

Lastly, I want to thank my former Legislative Assistant, Mr. Tigran Agdaian, and my former Knauss Fellows, Mr. Sean Mullin and Mr. Jeffrey Beauvais, for their important role in developing this legislation while on my staff.

President Biden's expansion of the Berryessa Snow Mountain National Monument honors the Patwin Tribes who walked this land long before our country was founded. On behalf of California's Congressional delegation, I thank the President.

RECOGNIZING RABBI ZOBERMAN'S 50TH YEAR AS A RABBI

Mrs. KIGGANS of Virginia. Mr. Speaker, I rise to congratulate Rabbi Dr. Israel Zoberman, who was recently honored for his 50th year of service as a rabbi.

Rabbi Zoberman is the founder and spiritual leader of Temple LevTikvah in Virginia Beach. He was born on November 12, 1945, in Chu, Kazakhstan to Polish Holocaust survivors. He spent his early childhood in Displaced Persons Camps in Austria and Germany following an escape from Poland. Immigrating to Haifa, Israel in 1949 with his family, he served in the Israel Defense Forces in the 1960s. Following his military service, he earned a Bachelor's degree in Hebrew Literature from Chicago's College of Jewish Studies in 1969, and a Bachelor of Arts in Political Science from Chicago's Roosevelt University in 1970. He has a Master of Art in Political Science from the University of Illinois at Chicago in 1971. He was ordained as a Reform Rabbi at the Hebrew Union College Jewish Institute of Religion in Cincinnati, Ohio in 1974, along with a M.A. in Hebrew Letters. His alma-mater granted him an honorary Doctor of Divinity degree in 1999. He is the only rabbi to earn a doctoral degree in Pastoral Care and Counseling from the McCormick Theological Seminary (affiliated with the Presbyterian Church USA) in Chicago, Illinois in 1980.

He led his former Congregation Beth Chaverim for over 30 years. Also, he spent 10 years at the Catholic Church of the Ascension in Virginia Beach. Rabbi Zoberman represents the Jewish community at civic events in Chesapeake, Virginia. He is the first rabbi to serve as chairman of the Community Relations Council of the United Jewish Federation of Tidewater and is a long-time member of the Federation Holocaust Commission, Since1981. he has served on the spiritual panel of Lee's Friends, has been the past national interfaith chair of Jewish Counsel of Public Affairs and served as president of the Hampton Roads Board of Rabbis and Cantors, as well as president of the Virginia Beach Clergy Association. He is the only Hampton Roads rabbi to serve as a volunteer police chaplain with the Virginia Beach Police Department. He is a commissioner with the Virginia Beach Human Rights Commission.

Living out Reverend Williams and Janice's faith-based social justice mission, GLIDE is also one of the largest providers of social services in the city. GLIDE serves three nutritious meals a day, 365 days a year, to thousands of San Franciscans in need-while offering comprehensive support services, including affordable, accessible, quality health care, mental health services, and HIV/AIDS and substance abuse treatment. GLIDE also helps women overcome domestic violence and oppression by providing housing, child care and supportive services.
