H.R. 8070, to authorize appropriations for fiscal year 2025 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, with an amendment (H. Rept. 118–529);

H.R. 750, to require any person that sells or distributes a mobile application that the Federal Government has prohibited for Government-owned devices to disclose that fact to any individual who downloads, updates, or otherwise uses such application, and for other purposes, with an amendment (H. Rept. 118–530);

H.R. 620, to require an annual budget estimate for the initiatives of the National Institutes of Health pursuant to reports and recommendations made under the National Alzheimer's Project Act (H. Rept. 118–531);

H.R. 4646, to reauthorize the rural emergency medical service training and equipment assistance program, and for other purposes, with an amendment (H. Rept. 118–532); and
