Fort Belknap Indian Community Water Rights Settlement Act: Committee on Indian Affairs was discharged from further consideration of S. 1987, to provide for the settlement of the water rights claims of the Fort Belknap Indian Community, and the bill was then passed, after agreeing to the following amendment proposed thereto: **Pages S4171–72**

Tester/Daines Amendment No. 2074, in the nature of a substitute. **Page S4172**

Winnebago Land Transfer Act: Senate passed H.R. 1240, to transfer administrative jurisdiction of certain Federal lands from the Army Corps of Engineers to the Bureau of Indian Affairs, to take such lands into trust for the Winnebago Tribe of Nebraska. **Page S4172**

Unleashing American Innovators Act Technical Correction: Committee on the Judiciary was discharged from further consideration of S. 3960, to amend title 35, United States Code, to provide a good faith exception to the imposition of fines for false assertions and certifications, and the bill was then passed. **Page S4198**

National Pollinator Week: Senate agreed to S. Res. 747, recognizing the importance of pollinators to ecosystem health and agriculture in the United States by designating June 16 through June 22, 2024, as “National Pollinator Week”. **Page S4198**

Authorizing Leadership to Make Appointments—Agreement: A unanimous-consent agreement was reached providing that, notwithstanding the adjournment of the Senate, the President of the Senate, the President Pro Tempore, and the Majority and Minority Leaders be authorized to make appointments to commissions, committees, boards, conferences, or interparliamentary conferences authorized by law, by concurrent action of the two Houses, or by order of the Senate. **Page S4199**

Signing Authority—Agreement: A unanimous-consent agreement was reached providing that Senators Warner, Kaine, Cardin, and Van Hollen be authorized to sign duly enrolled bills or joint resolutions from Thursday, June 20, 2024 to Monday, July 8, 2024. **Page S4199**

Pro Forma Sessions—Agreement: A unanimous-consent agreement was reached providing that the Senate adjourn, to then convene for pro forma sessions only, with no business being conducted on the following dates and times, and that following each pro forma session, the Senate adjourn until the next pro forma session: Friday, June 21, 2024, at 6:30 a.m.; Tuesday, June 25, 2024, at 11:30 a.m.; Friday, June 28, 2024, at 12 noon; Tuesday, July 2, 2024, at 12 noon; and Friday, July 5, 2024, at 9 a.m.; and that when the Senate adjourns on Friday, July 5, 2024, it next convene at 3 p.m., on Monday, July 8, 2024. **Page S4199**
