Born in Virginia in 1872, Ogle Harris grew up as one of five children. He spent his life in the Town of Occoquan where he raised his seven children from his marriages to Cora L. Peyton and Lottie Bowles.

In the early part of the 20th century, Harris opened a business in Occoquan selling handmade ice cream out of his home's summer kitchen on Washington Street and at the African American Odd Fellows Hall. He eventually converted his ice cream shop into one of Occoquan's two main grocery stores.

Mr. Harris was known throughout the community for his honesty, generosity, and his upstanding character, which allowed his business to flourish. After his death in 1949, his son, Arthur, and his daughter-in-law, Doris, took over the store. The store served as a center for Occoquan's commercial and African American communities and continuously supported the success of the Town of Occoquan until its closure in 1974.

In recognition of and appreciation for Ogle Harris and his descendants' contributions to the Town of Occoquan, the Occoquan Town Council has bestowed the honorary designation of "Ogle Harris Way" to the 100 block of Poplar Alley.

Mr. Speaker, I ask my colleagues to join me in celebrating Ogle Harris's life and his contributions to the Town of Occoquan. His legacy will live on through the designation of "Ogle Harris Way" and the memories of his impact on the Occoquan community.

Jack flew combat tours during the Korean War and was stationed onboard the USS Sicily and USS Rendova aircraft carriers in the Sea of Japan. During the Vietnam War, he became the commander of Attack Squadron 22 and flew 254 combat missions. For his heroic actions in combat, Jack received numerous awards, including the Silver Star, two Bronze Stars, the Legion of Merit, fourteen Air Medals, and two Navy Commendation Medals. He later earned his master's degree in international affairs from George Washington Universitv.

In July 1973, Jack retired from the Navy as a Captain. He had been working for the Joint Chiefs of Staff at the Pentagon. In civilian life, Jack continued his passion of flying while volunteering in our community. He conducted flights for police departments, schools, and individuals in need across North Texas. Jack previously served on the advisory board for Paris Airport and the City of Reno. He is a current board member of the Paris Junior College Alumni & Friends Association. For his outstanding contributions, Jack was recognized in 2017 as a distinguished graduate of Paris High School and inducted into Paris Junior College's Academic Hall of Honor. He also received the Federal Aviation Administration's prestigious Wright Brothers Master Pilot Award to mark over 50 years of excellent flight. I wish Jack continued success and good health for many years to come.

Mr. Speaker, I rise today to celebrate the 50th Anniversary of the Bayou Classic, an annual football classic that honors the heritage and accomplishments of America's Historically Black Colleges and Universities, specifically between Grambling State University and Southern University and Agricultural & Mechanical College located in Baton Rouge, Louisiana; and, Grambling State University, a member of the University of Louisiana System Institution, is in Grambling, Louisiana. Southern University A&M College, a member of the Southern University System, is in Baton Rouge, Louisiana.

The Bayou Classic has earned the distinction of being the No. 1 HBCU Classic in the Nation, with a storied history dating back to 1932, and has long promoted the importance of sportsmanship, musicianship, community, and traditions by representing the talents and achievements of students, staff, and alumni of Historically Black Colleges and Universities.

The Bayou Classic brings together fans and alumni of Grambling State University and Southern University and A&M College from around the globe to New Orleans, creating a vibrant celebration of football, family, traditions, and pageantry surrounding Historically Black Colleges and Universities.

The Bayou Classic's core audience primarily consists of students, alumni, military personnel, and leaders from Historically Black Colleges and Universities, with age demographics ranging from high school students, college students, university alumni, and football fanatics.

The Bayou Classic attracts participants from all over the world, but has a dedicated national audience, including but not limited to Alabama, Arkansas, California, Florida, Georgia, Illinois, Louisiana, Mississippi, New York, North Carolina, South Carolina, Tennessee, and Texas.

The Bayou Classic has consistently achieved record-breaking attendance, with projections of sustained future growth, particularly the Battle of the Bands & Greek Step Show, which draws an average attendance of 30,000 with sold out crowds for the past three years, and over 60,000–65,000 attendees for Game Day.

The 44th Annual Bayou Classic in 2017 propelled the event to be recognized as the No. 1 HBCU Classic and the most attended football game in the FCS division, further solidifying its status as the No. 1 HBCU Classic in the world since 2019.

The Bayou Classic officially celebrated 50 years of HBCU football rivalry, in which Southern University defeated Grambling State 27–22, on November 25, 2023 in the City of New Orleans at the Caesars Superdome. The school's records are Southern 26 wins, Grambling 24 wins.

I am happy to recognize this event, held in Louisiana's Second Congressional District, and proclaim the Bayou Classic as an historic event that showcases the excellence, pride, and unity of Historically Black Colleges and Universities. I appreciate all attendees from around the country and beyond who joined us in celebrating this momentous occasion, and to recognize the enduring legacy of the Bayou Classic, as we celebrated the 50th Anniversary.

Mr. SCOTT of Virginia. Madam Chair, I rise today in support of the inclusion of a pilot program for a national simulation-based emergency preparedness network in the Fiscal Year 2025 Homeland Security Appropriations Act. This pilot program will support the Department of Homeland Security (DHS) Office of Health Security's (OHS) mission to strengthen the Nation's health security through leadership and partnership, a safer and healthier Department of Homeland Security (DHS) workforce, and optimal care for patients.

I worked on this language with my fellow cochairs of the Modeling and Simulation Caucus, Reps. BERGMAN, SORENSEN, and RUTHERFORD and am pleased to see it included.

The simulation-based emergency preparedness network will deliver simulation-based training that meets existing and emerging local and regional needs to licensed healthcare professionals, first responders, and volunteers. This network supports all five phases of emergency management by ensuring our vital healthcare workforce is prepared prior to an emergency, able to respond effectively, save lives, prevent further damage, and contribute to healing during recovery. The program will also serve the training needs of the greater U.S. healthcare system.

Unfortunately, the underlying appropriations bill fails to invest in other national needs. It fails to fund effective strategies to keep our communities safe, much needed programs to assist migrants, and critical programs to combat public health threats. The bill also limits the ability of the department to counter misinformation, meet cybersecurity needs, and bans abortion services for individuals in U.S. Immigrations and Customs Enforcement (ICE) custody. I urge my colleagues to maintain this program to further modeling and simulationbased emergency preparedness network as we work towards a mutually agreeable funding bill.
