

This past year, the superintendent of Harrison School District 2, Dr. Wendy Birhanzel, was named Colorado Superintendent of the Year by the Colorado Association of School Executives for the district's high achievement and innovative approaches to education.

As the first district in Colorado to put student representatives on the Board of Education, Harrison D2 prioritizes students and their families. An open enrollment policy allows youth to enroll in any of D2's nine elementary schools, four K–8 schools, one K–12 online school, two middle schools, two high schools, one career readiness academy, International Baccalaureate program, home school program, or three charter school systems. The district's culturally and linguistically diverse education has received local and national awards, and an Advancement Via Individual Determination (AVID) program is available from elementary to high school.

Harrison School District 2 believes that socioeconomic status should not be a barrier to educational opportunity, and this commitment extends beyond K-12. Through the D2 promise, graduates from any high school in the district can receive a free two-year college education at Pikes Peak State College, inclusive of tuition, fees, books, and academic support. Harrison School District 2 also serves community members by offering free adult Basic Education, a General Educational Development (GED) class, and English as Second Language classes. Harrison D2's career-connected learning approach is reimagining education to produce the skilled workforce that the Pikes Peak region needs.

This year, Dr. Murphy has earned the distinguished honor for his exceptional leadership and transformative impact at the Jacobs School of Medicine and Biomedical Sciences.

Dr. Murphy is an internationally recognized expert in respiratory infectious diseases, specializing in otitis media (ear infections) in children and lower respiratory tract infections in adults with chronic obstructive pulmonary disease (COPD). His groundbreaking work has identified causes of bacterial infections and developed vaccinations and intervention strategies to prevent and treat these illnesses.

Additionally, in 2015, Dr. Murphy founded the University at Buffalo's Clinical and Translational Science Institute (CTSI) with support from the National Institute of Health. As a SUNY Distinguished Professor and Senior Associate Dean for Clinical and Translational Research, Dr. Murphy is a pillar of the University at Buffalo Department of Medicine's academic community. With 230 publications and 13 patents and chapters in medical textbooks, Dr. Murphy's work has played a pivotal role in preventing and treating respiratory tract bacterial diseases.

Mr. Speaker, I rise today to honor a loving wife, seasoned educator, legendary coach, and dear friend of longstanding, Coach Carolyn Wright An event to celebrate her remarkable coaching career was held on Saturday, August 10, 2024, at The Perfect Place in Columbus, Georgia. Coach Wright will be retiring after 45 years of dedicated service to education and athletics.

The genesis of the life of Coach Wright began in Tuskegee, Alabama. She is a product of the Tuskegee Institute High School, graduating from there in 1974. Coach Wright furthered her education in 1978 when she graduated from Alabama State University in 1978 earning a BS Degree in Physical Education/Special Education. Coach Wright went on to receive a master's degree in Specific Learning Disabilities in 1981 also from Alabama State.

Her career in education began at St. Jude Home for Children in Montgomery, Alabama. She also taught special education students at Hancock Central in Sparta, Georgia from 1978 to 79 and learning disability students at Stanhope Elmore High School Millbrook, Alabama from 1979 to 91. She spent her summers honing her education and coaching skills by working with the Upward Bound Program and the National Sports Youth Program at Alabama State University from 1979 through 1985. Her legendary coaching career began in 1986 at Mcintyre Junior High School where she coached basketball, softball, track, volleyball, and bowling. She left that position in 1991.

In 1991, she became the head coach at Central High School. She helped to guide the Lady Red Devils to four Final Four appearances, 12 appearances in the sweet sixteen, nine appearances in the Elite Eight, and 18 State tournament appearances overall. Her teams won 11 area championships while she amassed an overall record of 597–375 in 32 overall seasons at the helm. Her amazing career only produced four losing seasons as she was named bi-city coach of the year on several occasions. She was awarded the Sports Vision Legacy Award in 2018–19.

Her legacy extended beyond basketball, as she was instrumental in starting a volleyball program in the Phenix City Schools. She coached Volleyball at Central High School for sixteen years, winning more than 200 games. Her volleyball teams reached the Super Regional Tourney in 2014 for the first time in school history. She also served as the girls' head track coach and the boys' assistant track coach from 1992 through 2007 Coach Wright helped to guide 14 individual girls and relay teams to state titles Overall, she coached more than 30 boys and girls state champions. Because of her commitment to excellence, Coach Wright is largely responsible for over 200 athletes obtaining scholarships to colleges and universities.

Leaving behind a stellar career and legacy at Central, Coach Wright is now the Athletic Director and Head Girls Varsity Basketball Coach and Physical Education Instructor at Johnson Abernathy Graetz High School. During her tenure at Johnson Abernathy, Coach Wright was blessed to enter the 600-win club. Coach Tom Landry once said that "A coach is someone who tells you what you don't want to hear, who has to see what you don't want to hear, who has to see what you don't want to see so you can be who you always knew you could be." For over four decades, Coach Carolyn Wright has been helping young people from all walks of life to become who they always knew they could become.

Coach Wright has spent 45 years in the teaching profession and has distinguished herself as a leader and mentor to those coming behind her. She was the chair of the Health and Physical Education Department at Central and the Freshman Academy from 1991 to 2003. She served as the Assistant Athletics Director from 2009 to 2021. Coach Wright served on the AHSAA Strategic Planning Committee in 2016. And because of her commitment to excellence, she was chosen as the Phenix City Public Schools Secondary Teacher of the Year in 2014–15.

She has accomplished much in her life but none of it would have been possible without the love and grace of God and the support of her husband, Coach Bobby Wright who is a Hall of Fame basketball coach in his own right. This amazing couple is the only husband-wife duo to be inducted into the Alabama Sports Hall of Fame. Between the two of them, they have amassed 1,227 wins and a winning percentage of .680, the highest winning percentage of any husband-wife duo in the history of the State of Alabama.

But even with all of this, Coach Wright has found time to be a faithful servant of God as a member of the Saint John African Methodist Episcopal Church where she serves as a member of the Steward Board. She has also been a dedicated member of Alpha Kappa Alpha Sorority, Inc since 1976 and is currently an active member of the Gamma Tau Omega Chapter.

On a personal note, both Coach Wrights have been dear friends to my wife Vivian and me for many years. We are both thankful for their friendship, support and counsel over the years.

Mr. Speaker, I ask my colleagues to join my wife Vivian, and me in honoring Coach Carolyn Wright for her lifetime of service to God, her community, and humankind. May God continue to rain down blessings upon her, her family, her community and all the young people whose lives she will influence in the days, weeks and months ahead. Whereas, Waldo had his first airplane ride from a nearby farm field in 1946.

Whereas, Waldo enlisted in the U.S. Air Force in 1957. He trained as a mechanic and was assigned to Smoky Hill AFB in Salina, Kansas. There, he took flying lessons with the local military flying club, where he earned his Private and Commercial Pilot certificates.

Whereas, in 1959, Waldo was hired by the University of Minnesota as an instructor for the university flight facility at Anoka County Airport.

. Whereas, by 1967, Waldo became the Chief Pilot for the University of Minnesota.

Whereas, Waldo transported university officials, including presidents and coaches, and made more than 1,000 organ transplant flights and medical assistance flights with hospital medics.

Whereas, in September 1972, Waldo rescued a student pilot after distress calls could not be heard by local air traffic control. Anderson was commended by the National Association of Air Traffic Specialists for his "calm, cool reassurances" that brought the plane back to a safe landing.

Whereas, Waldo retired from the University of Minnesota in 1996 but never from flying.

Whereas, Waldo has been an FÁA Designated Pilot Examiner since 1967 and has flown more than 33,000 hours in more than 50 different aircraft.

Whereas, Waldo has been an instructor with the American Bonanza Society for more than 26 years.

Whereas, Waldo has provided flight instruction to countless pilots, including a NASA astronaut and more than 40 pilots now flying for commercial airlines, including two nephews who are captains with Delta Airlines.

Whereas, Waldo's vast network and experience also includes brushes with Hollywood. He has trained many celebrities, including Harrison Ford, and flew a 1929 Sikorsky S-38 in the movie "The Aviator" with Leonardo DiCaprio and Cate Blanchett.

Whereas, Waldo is an accomplished airplane appraiser, providing reliable appraisals to satisfied customers across the country. Among the more interesting planes that he tracked down was one of the original Bellanca's that made up the fleet for Hawaiian Airlines at its founding. The plane was restored and featured in the airline's 80th anniversary celebration and he was invited to visit the restored plane in Honolulu.

Whereas, for all these accomplishments and more, Ralph Waldo Anderson was inducted into the Minnesota Aviation Hall of Fame in 2008.

Whereas, Waldo has been married to Ruth Anderson for over 59 years, raising five children together, and spends time in Minnesota and Arizona, with visits to every airport in between.

Whereas, Waldo celebrates his 90th birthday on September 23, 2024, and continues to fly, instruct, appraise, and enjoy planes, with no signs of stopping. Now, therefore, be it recognized,

Now retired, Lorenzo continues to serve his community with the same dedication he showed in his military career. As the current president of the "Americans of Italian Origin" (AIO), he plays a pivotal role in the AIO Annual Seafood Dinner, raising thousands of dollars in scholarships for the children and grandchildren of local Italian Americans. Lorenzo also contributes to the Quality of Life Committee of "Focus Macomb," offering valuable recommendations to improve living conditions in Macomb County. His past involvement with the Italian American Chamber of Commerce further highlights his commitment to community service.

Dr. Brown's unparalleled expertise in interpreting market price movements and evaluating the impacts of federal and state policies on agriculture has made him a sought-after voice in both state and national agricultural discussions. His testimony before the U.S. Congress has helped shape policies that directly affect the livelihood of farmers and the agricultural economy. In Missouri, his work with the state legislature has been vital in assessing the economic effects of state policy options on Missouri agriculture, ensuring that our farmers have the information they need to thrive.
