Res. 1469, Ensuring accountability for key officials in the Biden-Harris administration responsible for decisionmaking and execution failures throughout the withdrawal from Afghanistan. The rule provides for consideration of H.R. 3334, the “Sanctioning Tyrannical and Oppressive People within the Chinese Communist Party Act”, under a structured rule. The rule waives all points of order against consideration of the bill. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Foreign Affairs or their respective designees. The rule provides that the amendment in the nature of a substitute recommended by the Committee on Foreign Affairs

The rule provides that, in lieu of the amendment in the nature of a substitute recommended by the Committee on the Judiciary now printed in the bill, an amendment in the nature of a substitute consisting of the text of Rules Committee Print 118–51 shall be considered as adopted and the bill, as amended, shall be considered as read. The rule waives all points of order against provisions in the bill, as amended. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on the Judiciary or their respective designees. The rule provides one motion to recommit. The rule further provides for consideration of H.R. 8790, the “Fix Our Forests Act”, under a structured rule. The rule waives all points of order against consideration of the bill. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Natural Resources or their respective designees. The rule provides that the amendment in the nature of a substitute recommended by the Committee on Natural Resources now printed in the bill, modified by the amendment printed in part C of the Rules Committee report, shall be considered as adopted, and the bill, as amended, shall be considered as read. The rule waives all points of order against provisions in the bill, as amended. The rule further makes in order only the amendments printed in part D of the Rules Committee report. Each amendment shall be considered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and con-

trolled by the proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for division of the question. All points of order against the amendments printed in part D of the report are waived. The rule provides one motion to recommit. The rule further provides for consideration of H. Res. 1469, Ensuring accountability for key officials in the Biden-Harris administration responsible for decisionmaking and execution failures throughout the withdrawal from Afghanistan, under a closed rule. The rule provides that upon adoption of the resolution it shall be in order without intervention of any point of order to consider H. Res. 1469. The rule provides that the resolution shall be considered as read. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Foreign Affairs or their respective designees. Finally, the rule provides that Section 3(j) of House Resolution 5 is amended by adding at the end the following new paragraph: “(3) DEFINITION.—For purposes of this subsection, ‘non-governmental capacity’ shall mean any capacity except representing the executive branch of the United States government”. Testimony was heard from Chairman Westerman, Chairman McCaul, Chairman Cole, and Representatives Crow, Self, Amo, Fitzgerald, Nadler, and DeLauro.
