He also serves on the hospital's Bioethics Committee.

Dr. Sharon received his bachelor of arts and master of arts degrees from Georgetown College in Kentucky. His master of divinity and doctor of ministry degrees were earned at The Southern Baptist Theological Seminary in Louisville, Kentucky.

In addition to his numerous degrees and accolades, it is his kindness and dedication to everyone he encounters that truly defines him. And, alongside his beloved wife, Gesa, he has built a beautiful family. Together they have four children, three of whom are married, and five grandchildren.

Dr. Gene Kallsen, a former chief of the Department of Emergency Medicine, was instrumental in reforming ambulance services, ensuring faster response times and better patient care. Today, the UCSF Fresno Emergency Medicine residency program stands as a model of excellence in medical education and emergency response. Dr. Marvin Pittman was a visionary educator in the early 1920's who believed in the strength and power of public education. The consolidation of thirteen one-room schools was voted for by the community on May 2, 1923, and in April 1924, the cornerstone of a new K–12 school was laid. This school was named Lincoln Consolidated School in connection between the equal education opportunity ideals of Abraham Lincoln and the goals of the district. Once welcoming 500 students in 1924, Lincoln now hosts a diverse student population of over 3,000.

Lincoln Consolidated Schools District is currently home to four elementary schools, one middle school, and one enlarged high school. Their commitment to developing students into high-achieving, inspired adults is exemplified through their partnership with Eastern Michigan University's Early College Alliance. At no cost, high school students are given the opportunity to experience higher education and earn college credits, opening their eyes to the possibilities after graduation. With a \$25 million bond passed in 2018, the district was able to improve facilities for athletics, fine arts, technology, and more. The Lincoln Athletic Building, with new fitness and multi-sport areas was opened in 2021 and showcases the district's dedication to community involvement by encouraging community members to also utilize the space.

Mr. Speaker, I ask my colleagues to join me today in honoring the staff, students, and community that have made Lincoln Consolidated Schools a tremendous educational environment for the last century. Dr. Pittman would be proud of how they have continued to build upon his ideals for public education. Ty was undoubtedly an impactful, dedicated figure within our Illinois community.

Anaheim's Halloween Parade would quickly become one of the biggest seasonal celebrations in the Nation, attracting crowds of over 75,000 attendees. In the 1960s and 1970s, the parade was broadcast on live television to be shared around the Nation. As an Anaheim kid, I had the opportunity to participate in the parade with my Benjamin Franklin Elementary classmates. And even as Anaheim grew from a rural town full of orange groves into a popular tourist destination and one of the largest cities in Orange County, the annual Halloween traditions did not disappear.

In 2012—and because of the hard work and dedication of the volunteers, local businesses, and community members—the Anaheim Halloween Parade and Fall Festival were revitalized. To honor the tradition's long history, several beloved floats from previous decades were brought back to life, including the 1953 Flying Sasser and the 1951 Rocket Witch.

Today, the parade still highlights the fall season and Halloween—but it has also grown to reflect our evolving local community. The celebration now also recognizes Dia de los Muertos, an important Chicano celebration that has strong roots in Anaheim's neighborhoods.

I ask my colleagues to join my hometown community in celebrating a century of one of Orange County's most important traditions. The Anaheim Halloween Parade has brought families out to celebrate for the past 100 years—and I am sure that it will continue to bring our community together for 100 more.

Elijah Stites was born in Essex, New Jersey, in 1758. During the American Revolution, he fought for the Essex County Militia, serving as color bearer at the Battle of Yorktown. In 1788, he and two of his brothers took part in an expedition along the Ohio River, helping to found the settlement of Columbia (modern-day Cincinnati). Later, he settled in Warren County with his wife, Rhoda, and their fourteen children.

Following his death in 1843, Stites was buried in Old Lima Cemetery in Allen County. Seventy years ago, the Lima DAR erected a plaque at the site of the cemetery recognizing him as the city's only Revolutionary War veteran. The organization will rededicate this plaque at a special ceremony on November 6.

Mr. Speaker, on behalf of the people of Ohio's Fourth Congressional District, I thank the women of Lima's DAR Chapter for putting together this rededication ceremony and for all they do to promote civic education. They are true examples of the DAR's high calling to "cherish, maintain, and extend the institutions of American freedom."

HONORING THE LEGACY OF EMORY F. LUCK

Luck, Ph.D., a remarkable individual whose life's journey was marked by resilience, unwavering determination, and a profound dedication to both education and sports. Emory Luck passed away at his home in Fresno, California on October 22, 2023, leaving behind a legacy that continues to inspire us all

Born in 1926 in Danville, Virginia, Emory was raised in Washington, D.C., as the son of Ada and Winston Luck. Despite attending a segregated school system, he graduated from the academically renowned Paul Laurence Dunbar High School. His early years were a testament to his strength in the face of adversity, as he confronted racial barriers with a spirit of determination and a hunger for knowledge. Emory's journey took him to the University of Illinois on an athletic scholarship, a significant achievement. Unfortunately, racial discrimination of the time prevented him from pursuing basketball, his first love. Instead, he turned to football to maintain his scholarship. It was not long before Emory departed from the university. determined to follow a different path.

After serving his country during World War II, Emory joined the Harlem Clowns professional basketball team, where he spent nine years as a player, coach, and general manager. His exceptional skills and dedication shone as he played against teams throughout California, Oregon, and Washington, proving his talent on the court.

With a thirst for knowledge and a desire to make a difference, Emory returned to academia, He enrolled at the University of Michigan in Ann Arbor, where he earned bachelor's and master's degrees in physical education. His commitment to education extended beyond his own studies, as he also taught in the Detroit public schools and worked for Eastern Airlines in customer relations. When the chance to work as an athlete counselor at the University of Illinois came his way, Emory eagerly accepted the opportunity. During this time, he demonstrated his devotion to the realms of both education and athletics. He committed himself to the pursuit of a Ph.D. in physical education and athletic administration, underlining his passion for excelling in sports and deepening is expertise in the field of physical education.

In 1969, Emory joined Northern Illinois University as an associate professor and assistant basketball coach. His career in coaching reached new heights in 1973 when he became head basketball coach, becoming only the second Black man to hold such a position at a Division 1 university in the United States. Although Emory stepped away from coaching and teaching for a brief period, his passion for sports and education led him back to Elgin Community College in Elgin, Illinois, where he served as an administrator and coach. In 1984, he was appointed athletic director, P.E. instructor, and golf coach at Fresno City College (FCC). Emory's impact at FCC extended beyond the realm of sports. For three years, he coached men's basketball and served as president of the Central Valley Conference. He later stepped down from the Athletic Director position but continued his dedicated service at FCC until his well-earned retirement in 2004.

Emory was not just an educator and coach; he was a devoted community member. He served on the board of the Fresno County E.O.C. for many years and retained a profound love for the game of golf and could often be found on the fairways of Fig Garden Golf Club. Emory is survived by Mary, his loving wife of 50 years, their beloved dog Annie, and his nieces and nephews who held a special place in his heart. His legacy lives on in the hearts of all those who had the privilege of knowing him.

Luck, Ph.D., an individual whose perseverance, commitment to education, and love for sports left an enduring mark. She dedicated many years of her life to Tribal service, holding numerous leadership positions, including Tribal vice chairperson of the Table Mountain Rancheria Tribal Gaming Commission, chairperson of the Table Mountain Rancheria Pow-Wow Committee, and chairperson of the Table Mountain Rancheria Enrollment.

Beverly Hunter's commitment extended beyond her Tribe. She was a tireless advocate for the greater Indian community in Central California. She served as a board member of the California Rural Indian Health Board, Inc. (CRIHB) and was the board chair for the CRIHB Traditional Indian Health Committee. Her dedication was further evident in her founding and chairing of the Phil D. Hunter and Warren Lee Jones Scholarship Fund since 2012, providing educational opportunities for future generations.

Beverly Hunter's leadership was vital in numerous organizations. She held roles such as treasurer of the California Rural Indian Health Board, chair of the California Indian Legal Services, and served on the Title IV Parent Committee, the American Indian Health Women Association, and Central Valley Indian Health. Her involvement with Central Valley Indian Health began from its inception, highlighting her deep-rooted commitment to the betterment of Indian health services. In 2012, Chairperson Hunter took on the role of founding chairperson for the Central California Yokuts NAGPRA (Native American Graves Protection and Reparation Act) Coalition. Alongside Tribal leadership from several Tribes, she advocated successfully for the return and reburial of ancestors and funerary objects held at UC Berkeley and the Field Museum of Natural History, Chicago. Her work in this area helped to uphold the dignity and respect of Indigenous peoples heritage.

Beverly Hunter is preceded in death by her parents, Warren Lee Jones and Rosie Jones, her husband, Phil D. Hunter, as well as her sister Loretta Ann Jones, and her brothers Myron Jones, Lyle Jones, and Matthew Jones. She is survived by her sons, Craig Martinez and Mark Martinez, as well as sisters Charlene Jones, Bernadine Jones, Juanita Jones, and brother Lonnie Jones. Her legacy lives on through her family, nieces, nephews, and the many lives she touched during her lifetime.

Beverly's life was a shining example of unwavering dedication to her Tribe and the greater Indian community. Her contributions to the advancement of Native American rights, health, and education have left an indelible mark. She will be remembered with the deepest respect and gratitude for her extraordinary leadership and service. As we offer our condolences to her family and Tribe, we honor and commemorate the life of Chairperson Beverly J. Hunter. Her legacy will continue to inspire and guide us in the ongoing pursuit of justice and recognition for Indigenous people.

HONORING RAOUL CUNNINGHAM IN HIS RETIREMENT

Mr. McGARVEY. Mr. Speaker, I rise today to pay tribute to Raoul Cunningham, one of Kentucky's greatest civil rights leaders, who recently announced his retirement after two decades serving as President of the Louisville Branch of the NAACP. His extraordinary leadership in the fight for equal rights has etched an indelible mark on our community.

Raoul Cunningham's commitment to justice began early, when, at just 14 years old, he

joined the Louisville NAACP Youth Council in 1957. During his high school years, as college students across the South initiated sit-ins and protested segregation, Raoul was inspired to bring similar action to Louisville. With the relative dearth of Black colleges in Kentucky compared to the rest of the Deep South, Cunningham and his young peers convinced their local NAACP branch that high school students could advocate just as well as college students. By the end of the year, the NAACP Youth Council, alongside the Congress of Racial Equality (CORE), began organizing protests in downtown Louisville.

Raoul Cunningham was among the first students arrested during these demonstrations, including at Stewart's Department Store, where customers of color were barred from the lunch counter. His arrest, the first of many, was a badge of honor for him. He famously said, "That jail ain't no big thing to any of us." For over two years, Cunningham and fellow students protested tirelessly after school, contributing to the passage of the first public accommodations law south of the Mason-Dixon Line. This achievement, which Cunningham considers his greatest, laid the groundwork for future civil rights fights.

After graduating high school, Cunningham attended Howard University, where his activism only grew stronger. He remained active in the NAACP through his college chapter, joined the Student Nonviolent Coordinating Committee (SNCC), and founded Howard's first Young Democratic Club. Upon returning to Louisville, he managed the historic campaign that led to Georgia Davis Powers becoming the first African American and first woman elected to the Kentucky Senate. He continued his work in politics before rejoining the NAACP as a regional coordinator for the Voter Empowerment Program.

Through demonstrations, negotiations, economic boycotts, and voter participation efforts, Cunningham helped bring an end to segregation in Louisville. The city of Louisville decided to honor him by inducting him into the Kentucky Civil Rights Hall of Fame in 2003. The following year, he was elected President of the NAACP's Louisville Branch, where he has proudly served since. He was awarded the Dr. Martin Luther King Jr. Freedom Award by the city of Louisville, an Honorary Doctor of Humanities Degree from Simmons College of Kentucky, and has been President of the Kentucky State Conference of the NAACP and served on the Kentucky Advisory Committee for Help America Vote (HAVA).

Mr. Speaker, Raoul Cunningham's lifelong commitment to civil rights transformed our community and inspired generations. I ask that the House of Representatives join me in recognizing his contributions to our country and congratulating him on his retirement.

Cohen Business and Industry Award.

He was a servant leader with genuine care for those around him. He transformed not only records but also the hearts and minds of entire communities.

Coach Abdur-Rahim was immediately embraced by the USF family.
