**I. FINDINGS AND CONCLUSION**

In accordance with Rule 18(e)(2) of the Committee on Standards of Official Conduct, the Committee hereby submits the following Report to the House of Representatives:

On September 15, 2010, the Committee convened for the purpose of considering the charges issued against Nicole M. Gustafson on May 26, 2010, of operating while impaired, driving under the influence—1st offense, and driving while intoxicated—1st offense. Ms. Gustafson entered a plea of guilty to operating while impaired on July 21, 2010, and was sentenced to a 30-day suspended sentence and placed on supervised probation for one year. Ms. Gustafson was also fined \$400.00 and required to complete a traffic alcohol program, victim impact panel, alcohol treatment, and alcohol testing. Ms. Gustafson intends to pay the \$400.00 fine and is complying with the terms of her sentence. All other charges were dismissed pursuant to the plea agreement.

The Committee voted against empanelling an investigative subcommittee regarding this matter. The Committee considered the scope and nature of Ms. Gustafson's conduct, and the fine and criminal disposition ordered by the D.C. Superior Court. The Committee has determined not to initiate review by an investigative subcommittee in this matter.
