Unlike a designation of beneficiary, once an assignment is executed, it is irrevocable.

As required by the Paperwork Reduction Act of 1995, Public Law 104–13, 94 Stat. 2812 (1980), and as amended by the Clinger-Cohen Act, Public Law 104–106, 110 Stat. 186 (1996), OPM is soliciting comments for this collection of information (OMB No. 3206–0270).
