k. *Description of Project:* The proposed Antelope Valley Water Storage Aquifer Pumped Hydroelectric Project would consist of: (1) a 600-foot-deep groundwater well; (2) a reversible pump/turbine rated at 150kW; (3) three flexible storage tanks connected by 12-inch pipe; and (4) appurtenant facilities.

When a Declaration of Intention is filed with the Federal Energy Regulatory Commission, the Federal Power Act requires the Commission to investigate and determine if the project would affect the interests of interstate or foreign commerce.

#### Notice of Availability of the Final Supplemental Environmental Impact Statement for the Alabama Power Company Coosa River Hydroelectric Project

In accordance with the National Environmental Policy Act of 1969 and the Federal Energy Regulatory Commission’s (Commission) regulations, 18 CFR part 380, the Office of Energy Projects has reviewed the application for a single new license to continue to operate and maintain three separately licensed projects and has prepared a final supplemental environmental impact statement (SEIS).<sup>1</sup> The single new license would combine the Coosa Hydroelectric Project (FERC No. 2146), which consists of the Weiss, H. Neely Henry, Logan Martin, Lay, and Bouldin developments, the Mitchell Dam Hydroelectric Project (FERC No. 82), and the Jordan Dam Hydroelectric Project (FERC No. 618) into one 969.9-megawatt project, the Coosa River Hydroelectric Project (Coosa River Project) No. 2146. The

projects are located on the Coosa River, in the states of Alabama and Georgia, and occupy about 508.31 acres of federal land administered by the U.S. Bureau of Land Management and 5.75 acres of federal land administered by the U.S. Army Corps of Engineers. The U.S. Environmental Protection Agency participated as a cooperating agency to prepare the final SEIS.

The final SEIS has been prepared to address the July 6, 2018 opinion issued by the United States Court of Appeals for the District of Columbia (court) regarding the Commission’s environmental review of the Coosa River Hydroelectric Project and supplements the final environmental assessment (FEA), issued December 31, 2009, for the project. The final SEIS focuses on the following issues identified by the court as needing further analysis and expands upon the analysis contained within the FEA for these issues: (1) dissolved oxygen; (2) fish entrainment and turbine mortality; (3) federally listed threatened and endangered species; and (4) cumulative effects. The final SEIS describes staff’s analysis of the applicant’s proposal and the alternatives for relicensing the project. The final SEIS documents the views of governmental agencies, non-governmental organizations, affected Indian tribes, the public, the license applicant, and Commission staff.

#### Port Arthur Pipeline, LLC; Notice of Schedule for the Preparation of an Environmental Assessment for the Louisiana Connector Pipeline Amendment

On July 14, 2023, Port Arthur Pipeline, LLC (Port Arthur) filed an application in Docket No. CP23–513–000 requesting a Certificate of Public Convenience and Necessity pursuant to Section 7(c) of the Natural Gas Act to construct and operate certain natural gas pipeline facilities. The proposed project is known as the Louisiana Connector Pipeline Amendment (Amendment), and would involve 38 modifications to the pipeline alignment, construction footprint, and installation methods for the Louisiana Connector Project, which was approved by the Commission on April 18, 2019, in Docket No. CP18–7–000.

On July 28, 2023, the Federal Energy Regulatory Commission (Commission or FERC) issued its Notice of Application for the Amendment. Among other things, that notice alerted agencies issuing Federal authorizations of the requirement to complete all necessary reviews and to reach a final decision on a request for a Federal authorization within 90 days of the date of issuance of the Commission staff’s environmental document for the Amendment.

This notice identifies Commission staff’s intention to prepare an environmental assessment (EA) for the Amendment and the planned schedule for the completion of the environmental review.<sup>1</sup>
