Remedies and complaint filing deadlines vary by program or incident.

Individuals who require alternative means of communication for program information (e.g., braille, large print, audiotape, American Sign Language, etc.) should contact the responsible agency or USDA TARGET Center at (202) 720-2600 (voice and text telephone (TTY)) or dial 711 for Telecommunications Relay Service (both voice and telephone users can initiate this call from any phone). Additionally, program information may be made available in languages other than English.

#### Foreign-Trade Zone (FTZ) 75; Authorization of Production Activity; Lucid Motors USA, Inc.; (Lithium-Ion Batteries); Casa Grande and Tempe, Arizona

On May 22, 2024, Lucid Motors USA, Inc. submitted a notification of proposed production activity to the FTZ Board for its facilities within Subzone 75N, in Casa Grande and Tempe, Arizona.

The notification was processed in accordance with the regulations of the FTZ Board (15 CFR part 400), including notice in the **Federal Register** inviting public comment (89 FR 47129, May 31, 2024). On September 19, 2024, the applicant was notified of the FTZ Board's decision that no further review of the activity is warranted at this time. The production activity described in the notification was authorized, subject to the FTZ Act and the FTZ Board's regulations, including section 400.14.
