#### Imposition of Conditions of Entry for Vessels Arriving to the United States From the Republic of Sudan

**AGENCY:** Coast Guard, DHS.

**ACTION:** Notice.

**SUMMARY:** The Coast Guard announces that it will impose conditions of entry on vessels arriving from the country of the Republic of Sudan. Conditions of entry are intended to protect the United States from vessels arriving from countries that have been found to have deficient port anti-terrorism measures in place.

**DATES:** The policy announced in this notice is effective on October 3, 2024.
