The staff of the Federal Energy Regulatory Commission (FERC or Commission) will prepare an environmental document, that will discuss the environmental impacts of the 507G Line Abandonment Project involving construction and operation of facilities by Tennessee Gas Pipeline Company, L.L.C. (Tennessee) in Acadia, Vermilion, Iberia, and St. Mary Parishes, Louisiana. The Commission will use this environmental document in its decision-making process to determine whether the project is in the public convenience and necessity.

This notice announces the opening of the scoping process the Commission will use to gather input from the public and interested agencies regarding the project. As part of the National Environmental Policy Act (NEPA) review process, the Commission takes into account concerns the public may have about proposals and the environmental impacts that could result from its action whenever it considers the issuance of an authorization. This gathering of public input is referred to as "scoping." The main goal of the scoping process is to focus the analysis in the environmental document on the important environmental issues. Additional information about the Commission's NEPA process is described below in the NEPA Process and Environmental Document section of this notice.

By this notice, the Commission requests public comments on the scope of issues to address in the environmental document. To ensure that your comments are timely and properly recorded, please submit your comments so that the Commission receives them in Washington, DC on or before 5:00pm Eastern Time on December 9, 2024. Comments may be submitted in written form. Further details on how to submit comments are provided in the *Public Participation* section of this notice.

Your comments should focus on the potential environmental effects, reasonable alternatives, and measures to avoid or lessen environmental impacts. Your input will help the Commission staff determine what issues they need to evaluate in the environmental document. Commission staff will consider all written comments during the preparation of the environmental document.

Summary of the Proposed Project

Tennessee proposes to abandon a portion of its 507G pipeline. The 507G Line Abandonment Project would consist of abandonment in-place and by removal of a portion of the 507G–100 Line and abandonment in-place and by removal of the remaining portion of the 507G-500 Line. According to Tennessee, since these pipeline facilities were placed in service, there have been changes in natural gas supply locations, patterns, and flows that have led Tennessee to now request abandonment of these facilities.

The 507G Line Abandonment Project would consist of the following facilities:

- abandon in-place and by removal approximately 59.6 miles and 15.8 miles of 16-inch-diameter pipeline of the 507G-100 Line, respectively; and
- abandon in-place and by removal approximately 7.9 miles and 1.1 miles of 12-inch-diameter pipeline of the 507G-500 supply lateral pipeline, respectively.

Under Section 2.55(a) of the Commission's regulations, Tennessee intends to relocate an existing pigging facility. The general location of the project facilities is shown in appendix

Land Requirements for Construction

Construction of the proposed facilities would disturb about 458.64 acres of land for the abandonment of the pipelines. Following construction,

Tennessee would maintain about 0.08 acre for permanent operation of the pigging facility; the remaining acreage would be restored and revert to former

NEPA Process and the Environmental Document

Any environmental document issued by the Commission will discuss impacts that could occur as a result of the construction and operation of the proposed project under the relevant general resource areas:

- geology and soils;
- water resources and wetlands;
- vegetation and wildlife;
- threatened and endangered species;
- cultural resources;
- land use:
- environmental justice;
- air quality and noise; and
- reliability and safety.

Commission staff will also evaluate reasonable alternatives to the proposed project or portions of the project and make recommendations on how to lessen or avoid impacts on the various resource areas. Your comments will help Commission staff identify and focus on the issues that might have an effect on the human environment and potentially eliminate others from further study and discussion in the environmental document.

Following this scoping period, Commission staff will determine whether to prepare an Environmental Assessment (EA) or an Environmental Impact Statement (EIS). The EA or the EIS will present Commission staff's independent analysis of the issues. If Commission staff prepares an EA, a Notice of Schedule for the Preparation of an Environmental Assessment will be issued. The EA may be issued for an allotted public comment period. The Commission would consider timely comments on the EA before making its decision regarding the proposed project. If Commission staff prepares an EIS, a Notice of Intent to Prepare an EIS/ Notice of Schedule will be issued, which will open up an additional comment period. Staff will then prepare a draft EIS which will be issued for public comment. Commission staff will consider all timely comments received during the comment period on the draft EIS and revise the document, as necessary, before issuing a final EIS. Any EA or draft and final EIS will be available in electronic format in the public record through eLibrary 3 and the Commission's natural gas environmental documents web page

Background: The EFAB is an EPA advisory committee chartered under the Federal Advisory Committee Act (FACA), 5 U.S.C. 10, to provide advice and recommendations to EPA on innovative approaches to financing environmental programs, projects, and activities. The Board was established in 1991 to provide advice and recommendations to EPA. Since inception, the Board has advised the EPA on a wide-ranging set of issues including but not limited to the following:

- Creating incentives to increase private investment in the provision of environmental services and removing or reducing constraints on private involvement wherever possible;
- Developing new and innovative environmental financing approaches and supporting and encouraging the use of cost-effective existing approaches;
- Identifying approaches, challenges, opportunities, and methodologies specifically targeted to small community financing;
- Assessing government strategies for implementing public-private partnerships, including privatization, operations and maintenance issues, and other alternative financing mechanisms;
- Improving governmental principles of accounting and disclosure standards
