10. *Abstract:* The Debt Collection Improvement Act of 1996 requires that agencies collect TINs from individuals who do business with the Government, including contractors and recipients of credit, licenses, permits, and benefits. The TIN will be used to process all electronic payments (refunds) made to licensees by electronic funds transfer by the Department of the Treasury. The Department of the Treasury will use the TIN to determine whether the refund can be used to administratively offset any delinquent debts reported to the Treasury by other Government agencies. In addition, the TIN will be used to collect and report to the Department of the Treasury any delinquent indebtedness arising out of the licensee's or applicant's relationship with the NRC.

Framatome Inc.; Application for Standard Design Certification of the **U.S. EPR; Exemption**

AGENCY: Nuclear Regulatory Commission.

ACTION: Notice; issuance.

SUMMARY: The U.S. Nuclear Regulatory Commission (NRC) is issuing an exemption in response to an April 17, 2024, letter from Framatome Inc. (Framatome), which requested an extension to the exemption from regulatory requirements regarding the annual reports required by regulations (hereafter "required report") for the U.S. EPR standard design certification application for the years 2024–2028. The regulation for which exemption is sought covers emergency core cooling systems (ECCS) for light-water nuclear power reactors. Staff review of the U.S. EPR standard design certification application was suspended in April 2015 at the request of the applicant. Framatome committed to submit the required report before any request to reactivate the U.S. EPR review. Framatome further committed to providing an update to the required report, or taking other appropriate action, as necessary, no later than December 31, 2028. The NRC staff reviewed this request and determined that it is appropriate to grant the exemption in accordance with the regulations as the request does not present an undue risk to public health

or safety and is consistent with the common defense and security; furthermore, special circumstances exist.

DATES: The exemption is effective on December 9, 2024.
