NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966
(80 Stat. 271; 1 U.S.C. 113)—

“ . . .the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

In light of the Embassy's receipt of Ministry of Foreign Affairs Note No. USA-2/88/2007, dated 14 February 2007, concerning removal from the Agreement of the provision relating to regulations of computer reservation systems, the Embassy proposes that Annex III to the Agreement be deleted. If the Ministry concurs with this proposal, the Embassy further proposes that this note and the Ministry's affirmative note in reply shall constitute an agreement on this subject which shall enter into force on the date of the Ministry's note in reply.
