**AMENDMENT NO. 1 TO THE THIRD AGREEMENT BETWEEN  
THE GOVERNMENT OF THE REPUBLIC OF INDONESIA AND  
THE GOVERNMENT OF THE UNITED STATES OF AMERICA  
REGARDING A DEBT-FOR-NATURE SWAP WITH RESPECT TO CERTAIN  
DEBT OWED BY THE GOVERNMENT OF THE REPUBLIC OF INDONESIA TO  
THE GOVERNMENT OF THE UNITED STATES OF AMERICA**

The Government of the Republic of Indonesia and the Government of the United States of America (the “Parties”).

Recognizing that the Parties recently signed the Third Agreement Between The Government Of The Republic Of Indonesia And The Government Of The United States Of America Regarding A Debt-For-Nature Swap With Respect To Certain Debt Owed By The Government Of The Republic Of Indonesia To The Government Of The United States Of America on September 29, 2014 (the “**Debt Swap Agreement**”), which entered into force on September 29, 2014, pursuant to section 9.1 of the Debt Swap Agreement;

Whereas section 8.1 of the Debt Swap Agreement allows its amendment with the written consent of both Parties; and

In light of the desire of the Parties to resolve in a timely manner certain conditions precedent that are requirements to the Closing under the Second Amendment to the Forest Conservation Agreement among the Government of the Republic of Indonesia, Conservation International Foundation, and Yayasan Keanekaragaman Hayati Indonesia, dated as of September 29, 2014;

Have agreed to amend:


(1) section 2.3 of the Debt Swap Agreement by deleting “December 15, 2014,” and inserting in its place “January 22, 2015.”; and

(2) section 9.2(a) of the Debt Swap Agreement by deleting “December 15, 2014,” and inserting in its place “January 22, 2015.”


This amendment shall enter into force upon the date of the last signature hereto.
