NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966 (80 Stat. 271; 1 U.S.C. 113)—

"...the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence ... of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof."

If the above proposal is acceptable to the Government of the United States of America, the Embassy proposes that this Note and the Department's Note in reply shall constitute an agreement between the two Governments to extend the aforesaid Agreement for an additional five-year period, which shall enter into force on the date of the Department's Note in reply and shall supersede the Agreement to extend the Agreement Relating to Scientific and Technical Cooperation between the Government of the Republic of Korea and the Government of the United States of America of July 31, 2015.

The Department of State has the honor to inform the Embassy that the Government of the United States of America accepts the proposal set forth above. The Embassy's Note and this Note in reply shall constitute an agreement between the two Governments to extend the Agreement Relating to Scientific and Technical Cooperation between the Government of the United States of America and the Government of the Republic of Korea for an additional five-year period from July 2, 2014, which shall enter into force on the date of this Note and shall supersede the Agreement to Extend the Agreement Relating to Scientific and Technical Cooperation between the Government of the Republic of Korea and the Government of the United States of America of July 31, 2015.
