CHAP. 142 .- An act to reduce and fix the Adjutant General's Department of the Army.

Adjutant-General's Department, how constituted.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Adjutant General's Department of the Army shall hereafter consist of one Adjutant General, with the rank, pay, and emoluments of a brigadier general; two assistant adjutants general, with the rank, pay, and emoluments of colonels; four assistant adjutants general, with the rank, pay, and emoluments of lieutenant colonels; and ten assistant adjutants general, with

CHAP. 143.—An act authorizing the coinage of a twenty cent piece of silver at the mints of the United States.

R.S., Title xxxvii,

Be it enacted by the Senate and House of Representatives of the United Twenty-cent sil- States of America in Congress assembled, That there shall be, from time to time, coined at the mints of the United States, conformably in all 1873, c. 131, v. 17, respects to the coinage act of eighteen hundred and seventy-three a coin of silver of the denomination of twenty-cents and of the weight of five grams.
