DECISION AWARDING DAMAGES¹

On February 18, 2021, Vienna Giglio filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the “Vaccine Act”). Petitioner alleges that she suffered a left shoulder injury related to vaccine administration (“SIRVA”) resulting from an influenza vaccine received on October 12, 2020. Petition at 1. Petitioner further alleges the vaccine was received in the United States, she suffered residual effects for more than six months, and neither Petitioner nor any other party has ever filed an action or received or accepted compensation in the form of an award or settlement for her vaccine-related injury. Petition at ¶¶ 4, 17-19; Ex. 10 at 3. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On August 18, 2022, a ruling on entitlement was issued, finding Petitioner entitled to compensation for SIRVA. On August 17, 2022, Respondent filed a proffer on award of compensation (“Proffer”) indicating Petitioner should be awarded \$58,000.52. Proffer at 4. In the Proffer, Respondent represented that Petitioner agrees with the proffered award. *Id.* Based on the record as a whole, I find that Petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the Proffer, **I award Petitioner a lump sum payment of \$58,000.52 (comprised of \$57,500.00 for pain and suffering and \$500.52 for out of pocket expenses) in the form of a check payable to Petitioner.** This amount represents compensation for all damages that would be available under Section 15(a).

The Clerk of Court is directed to enter judgment in accordance with this decision.³
