## **DECISION AWARDING DAMAGES**<sup>1</sup>

On November 29, 2023, Lindell Ellis filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, et seq.² (the "Vaccine Act"). Petitioner alleges that that she suffered a shoulder injury related to vaccine administration ("SIRVA"), a defined Table injury or in the alternative caused-infact injury, after receiving an influenza vaccine on November 1, 2022. Petition at 1, ¶¶ 4, 27-28. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On June 20, 2024, I issued a ruling on entitlement, finding Petitioner entitled to compensation for her SIRVA. On July 9, 2024, Respondent filed a proffer on award of compensation ("Proffer") indicating Petitioner should be awarded \$68,588.84, representing Compensation in the amounts of \$67,500.00 for pain and suffering and \$1,088.84 for past unreimbursable expenses. Proffer at 1-2. In the Proffer, Respondent

represented that Petitioner agrees with the proffered award. *Id.* Based on the record as a whole, I find that Petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, I award Petitioner a lump sum payment of \$68,588.84, representing Compensation in the amounts of \$67,500.00 for pain and suffering and \$1,088.84 for past unreimbursable expenses in the form of a check payable to Petitioner. This amount represents compensation for all damages that would be available under Section 15(a).

The Clerk of Court is directed to enter judgment in accordance with this decision.<sup>3</sup>

#### RESPONDENT'S PROFFER ON AWARD OF COMPENSATION

On November 29, 2023, Lindell Ellis ("petitioner") filed a petition for compensation under the National Childhood Vaccine Injury Act of 1986, 42 U.S.C. §§ 300aa-1 to -34 ("Vaccine Act" or "Act"), alleging that she suffered a left shoulder injury related to vaccine administration ("SIRVA"), as the result of an influenza ("flu") vaccination administered on November 1, 2022. Petition, ECF No. 1, at 1.

On June 20, 2024, the Secretary of Health and Human Services ("respondent") filed a Rule 4(c) Report indicating that this case is appropriate for compensation under the terms of the Act for a SIRVA Table injury, and, later that day, the Chief Special Master issued a Ruling on Entitlement finding petitioner entitled to compensation. ECF Nos. 19, 20.

#### I. Items of Compensation

#### A. Pain and Suffering

Respondent proffers that petitioner should be awarded \$67,500.00 in pain and suffering damages. *See* 42 U.S.C. § 300aa-15(a)(4). Petitioner agrees.

## B. Past Unreimbursable Expenses

Evidence supplied by petitioner documents that she incurred past unreimbursable expenses related to her vaccine-related injury. Respondent proffers that petitioner should be awarded past unreimbursable expenses in the amount of \$1,088.84. *See* 42 U.S.C. § 300aa-15(a)(1)(B). Petitioner agrees.

### II. Form of the Award

Petitioner is a competent adult. Evidence of guardianship is not required in this case.

Respondent recommends that the compensation provided to petitioner should be made through a lump sum payment as described below and requests that the Chief Special Master's decision and the Court's judgment award the following: a lump sum payment of \$68,588.84, in the form of a check payable to petitioner.

## III. Summary of Recommended Payments Following Judgment

Lump sum payable to petitioner, Lindell Ellis: \$68,588.84
