

In the Senate of the United States,

November 14, 2002.

Resolved, That the bill from the House of Representatives (H.R. 3529) entitled “An Act to provide tax incentives for economic recovery and assistance to displaced workers.”, do pass with the following

AMENDMENT:

Strike out all after the enacting clause and insert:

1 ***SECTION 1. SECTION 114 OF PUBLIC LAW 107-229.***

2 *Section 114 of Public Law 107-229 is amended by*
3 *striking “the date specified in section 107(c) of this joint*
4 *resolution” and inserting “March 31, 2003”.*

1 **SEC. 2. EXTENSION OF THE TEMPORARY EXTENDED UNEM-**
 2 **PLOYMENT COMPENSATION ACT OF 2002.**

3 (a) *IN GENERAL.*—Section 208 of the Temporary Ex-
 4 tended Unemployment Compensation Act of 2002 (Public
 5 Law 107–147; 116 Stat. 30) is amended to read as follows:

6 **“SEC. 208. APPLICABILITY.**

7 “(a) *IN GENERAL.*—Except as provided in subsection
 8 (b), an agreement entered into under this title shall apply
 9 to weeks of unemployment—

10 “(1) beginning after the date on which such
 11 agreement is entered into; and

12 “(2) ending before April 1, 2003.

13 “(b) *TRANSITION FOR AMOUNT REMAINING IN AC-*
 14 *COUNT.*—

15 “(1) *IN GENERAL.*—Subject to paragraphs (2)
 16 and (3), in the case of an individual who has
 17 amounts remaining in an account established under
 18 section 203 as of March 29, 2003, temporary extended
 19 unemployment compensation shall continue to be
 20 payable to such individual from such amounts for
 21 any week beginning after such date for which the in-
 22 dividual meets the eligibility requirements of this
 23 title.

24 “(2) *NO AUGMENTATION AFTER MARCH 29,*
 25 *2003.*—If the account of an individual is exhausted
 26 after March 29, 2003, then section 203(c) shall not

1 *apply and such account shall not be augmented under*
2 *such section, regardless of whether such individual's*
3 *State is in an extended benefit period (as determined*
4 *under paragraph (2) of such section).*

5 *“(3) LIMITATION.—No compensation shall be*
6 *payable by reason of paragraph (1) for any week be-*
7 *ginning after June 28, 2003.”.*

8 *(b) EFFECTIVE DATE.—The amendment made by this*
9 *section shall take effect as if included in the enactment of*
10 *the Temporary Extended Unemployment Compensation Act*
11 *of 2002 (Public Law 107–147; 116 Stat. 21).*
