**A BILL**

To authorize a land conveyance between the United States and the City of Craig, Alaska, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Craig Recreation Land  
5       Purchase Act”.

1 **SEC. 2. AUTHORIZATION FOR CONVEYANCE.**

2 If the City of Craig, Alaska, (“City”) tenders all  
3 right, title and interest of the City in and to the municipal  
4 lands identified on the map entitled “Sunnahae Property  
5 and Trail,” dated April 22, 1992 and labeled Attachment  
6 A, to the Secretary of Agriculture (“Secretary”) within six  
7 months of the date the City receives the results of the ap-  
8 praisal conducted pursuant to section 4, the Secretary  
9 shall accept such tender.

10 **SEC. 3. ACQUISITION OF LAND BY THE CITY OF CRAIG.**

11 (a) Funds received by the City under section 2 shall  
12 be used by the City for the purchase of lands shown on  
13 the map entitled “Wards Cove Property,” dated March 24,  
14 1969 and labeled attachment B.

15 (b) The purchase of lands by the City under sub-  
16 section (a) shall be for an amount equal to the appraised  
17 value of the lands conveyed to the Secretary by the City,  
18 except that the Secretary and the City may equalize the  
19 values by adjusting acreage or by payments not to exceed  
20 \$100,000.

21 **SEC. 4. APPRAISAL.**

22 Prior to any conveyance, the Secretary shall conduct  
23 an appraisal of the lands identified for conveyance by the  
24 City in accordance with the United States Department of  
25 Justice Uniform Standards of Appraisal and shall notify  
26 the City of the results of the appraisal.

1 **SEC. 5. MANAGEMENT OF CONVEYED LANDS.**

2       Lands received by the Secretary shall be included in  
3 the Tongass National Forest and shall be managed in ac-  
4 cordance with the laws, regulations, and forest plan appli-  
5 cable to the Tongass National Forest.

6 **SEC. 6. AUTHORIZATION.**

7       There are authorized to be appropriated such sums  
8 as may be necessary to carry out the provisions of this  
9 Act.
