Mr. MURKOWSKI (for himself and Mr. STEVENS) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

## A BILL

To amend the Denali Commission Act of 1998 to establish the Denali transportation system in the State of Alaska.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Denali Transportation  
5       System Act”.

6       **SECTION 2. DENALI TRANSPORTATION SYSTEM.**

7       The Denali Commission Act of 1998 (Public Law  
8       105–277; 42 U.S.C. 3121 note) is amended—

9               (1) by redesignating section 309 as section 310;

10       and

1 (2) by inserting after section 308 the following:

2 **“SEC. 309. DENALI TRANSPORTATION SYSTEM.**

3 “(a) CONSTRUCTION.—

4 “(1) IN GENERAL.—The Secretary of Transpor-  
5 tation shall establish a program under which the  
6 Secretary may pay the costs of construction (includ-  
7 ing the costs of design) in the State of Alaska of the  
8 Denali transportation system.

9 “(2) DESIGN STANDARDS.—Any design carried  
10 out under this section shall use technology and de-  
11 sign standards determined by the Commission.

12 “(b) DESIGNATION OF SYSTEM BY COMMISSION.—  
13 The Commission shall submit to the Secretary of  
14 Transportation—

15 “(1) designations by the Commission of the  
16 general location and termini of highways, port and  
17 dock facilities, and trails on the Denali transpor-  
18 tation system;

19 “(2) priorities for construction of segments of  
20 the system; and

21 “(3) other criteria applicable to the program es-  
22 tablished under this section.

23 “(c) CONNECTING INFRASTRUCTURE.—In carrying  
24 out this section, the Commission may construct marine  
25 connections (such as connecting small docks, boat ramps,

1 and port facilities) and other transportation access infra-  
 2 structure for communities that would otherwise lack ac-  
 3 cess to the National Highway System.

4 “(d) ADDITION TO NATIONAL HIGHWAY SYSTEM.—  
 5 On completion, each highway on the Denali transportation  
 6 system that is not already on the National Highway Sys-  
 7 tem shall be added to the National Highway System.

8 “(e) PREFERENCE TO ALASKA MATERIALS AND  
 9 PRODUCTS.—In the construction of the Denali transpor-  
 10 tation system under this section, the Commission may give  
 11 preference—

12 “(1) to the use of materials and products indig-  
 13 enous to the State; and

14 “(2) with respect to construction projects in a  
 15 region, to local residents and firms headquartered in  
 16 that region.”.

17 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

18 Section 310 of the Denali Commission Act of 1998  
 19 (Public Law 105–277; 42 U.S.C. 3121 note) (as redesign-  
 20 nated by section 2(1)) is amended by striking subsection  
 21 (a) and inserting the following:

22 “(a) IN GENERAL.—There are authorized to be ap-  
 23 propriated to the Commission—

24 “(1) to carry out the duties of the Commission  
 25 under this title (other than section 309), and in ac-

1 cordance with the work plan approved under section  
2 304, such sums as are necessary for fiscal year  
3 2003; and

4 “(2) to carry out section 309 \$440,000,000 for  
5 each of fiscal years 2003 through 2008.”.
