# **A BILL**

To amend title V of the Social Security Act to convert funding for personal responsibility education programs from direct appropriations to an authorization of appropriations.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CONVERTING FUNDING FOR PERSONAL RE-**  
4 **SPONSIBILITY EDUCATION PROGRAMS FROM**  
5 **DIRECT APPROPRIATIONS TO AN AUTHOR-**  
6 **IZATION OF APPROPRIATIONS.**

7 (a) IN GENERAL.—Section 513(f) of the Social Secu-  
8 rity Act (42 U.S.C. 713(f)), as added by section 2953 of  
9 the Patient Protection and Affordable Care Act (Public  
10 Law 111–148) and as amended by section 10201(h) of  
11 such Act, is amended—

12 (1) in the heading, by striking “APPROPRIA-  
13 TION” and inserting “AUTHORIZATION OF APPRO-  
14 PRIATIONS”;

15 (2) by striking “appropriated, out of any money  
16 in the Treasury not otherwise appropriated,” and in-  
17 serting “authorized to be appropriated”;

18 (3) by striking “2010” and inserting “2012”;

19 and

20 (4) by striking the second sentence.

21 (b) CONFORMING AMENDMENTS.—Section 513 of the  
22 Social Security Act is further amended—

23 (1) in subsection (a)(1)—

24 (A) in subparagraph (A)(i), by striking  
25 “amount” and inserting “amounts”; and

1           (B) by striking subparagraph (B) and re-  
2           designating subparagraph (C) as subparagraph  
3           (B); and  
4           (2) in subsection (c)—

5           (A) in paragraph (1), by striking  
6           “amount” and inserting “amounts”; and

7           (B) in paragraph (2), by striking  
8           “amount” and inserting “amounts”.

9           (c) RESCISSION OF UNOBLIGATED FUNDS.—Of the  
10          funds made available under such section 513, the unobli-  
11          gated balance is rescinded.
