## A BILL

To delay enforcement and establishment of certain water quality standards within the Great Bay Estuary, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. GREAT BAY ESTUARY.**

4 (a) DELAY OF ENFORCEMENT AND ESTABLISH-  
5 MENT.—During the 5-year period beginning on the date  
6 of enactment of this Act, the Administrator of the Envi-  
7 ronmental Protection Agency may not—

8 (1) require a covered treatment works to com-  
9 mence construction on any upgrade of a facility for  
10 the purpose of enforcing water quality standards or

1 effluent limitations with regard to nitrogen under  
2 section 402 of the Federal Water Pollution Control  
3 Act (33 U.S.C. 1342); or

4 (2) establish any water quality standard or ef-  
5 fluent limitation with regard to nitrogen in the  
6 Great Bay Estuary under title III of such Act (33  
7 U.S.C. 1311 et seq.).

8 (b) STUDY REQUIRED.—

9 (1) IN GENERAL.—Not later than 5 years after  
10 the date of enactment of this Act, the Administrator  
11 shall conduct, and make available to the public the  
12 results of, a peer-reviewed study regarding eelgrass  
13 levels, and the causes of any loss of eelgrass habitat,  
14 in the Great Bay Estuary.

15 (2) PUBLIC PARTICIPATION.—The Adminis-  
16 trator shall allow for public participation in the de-  
17 velopment of the study conducted under this sub-  
18 section.

19 (c) DEFINITIONS.—In this section:

20 (1) COVERED TREATMENT WORKS.—The term  
21 “covered treatment works” means a publicly owned  
22 treatment works, as that term is defined in section  
23 212 of the Federal Water Pollution Control Act (33  
24 U.S.C. 1292), that contributes nitrogen loadings to  
25 the Great Bay Estuary.

1           (2) GREAT BAY ESTUARY.—The term “Great  
2 Bay Estuary” means the estuarine zone that extends  
3 from the mouth of Portsmouth Harbor, in the vicin-  
4 ity of Portsmouth, New Hampshire, to the head-of-  
5 tide for the 8 rivers (including the tributaries of  
6 those rivers) that flow into Great Bay, Little Bay,  
7 and the Piscataqua River.

8           (3) ESTUARINE ZONE.—The term “estuarine  
9 zone” has the meaning given that term in section  
10 320(k) of the Federal Water Pollution Control Act  
11 (33 U.S.C. 1330(k)).
