Mr. Larsen of Washington (for himself, Mr. Dicks, Mr. Inslee, Mr. Smith of Washington, Mr. McDermott, Mr. Grimm, Mr. Keating, Mr. Sires, Ms. Pingree of Maine, Mr. Butterfield, Mr. Bishop of New York, and Mr. Connolly of Virginia) introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To promote secure ferry transportation and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "United States Ferry
- 5 Systems Investment Act of 2011".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:
- 8 (1) Ferries are a vital part of the United States
- 9 transportation system, carrying more than

- 1 100,000,000 passengers annually in at least 38 2 States.
 - (2) In many congested metropolitan areas, ferries are one of the few remaining options for significant transportation capacity expansion.
 - (3) Ferries are the sole or primary transportation connection for many island and isolated communities.
 - (4) Ferries provide a critical emergency evacuation alternative for both large cities and remote locations.
 - (5) Ferries can be part of an interim solution when transportation infrastructure fails. For example, ferries were used to provide interim transportation after the terrorist attacks in New York on September 11, 2001, disrupted train service and after part of the San Francisco Bay Bridge collapsed in the Loma Prieta earthquake.
 - (6) Ferries offer a relatively energy-efficient, environmentally friendly, and low-stress mode of travel.
 - (7) Almost all of the largest and most important ferry services are publicly owned or provide transportation at public terminals, are integrated

1	with other transportation modes, and are operated
2	in a manner to serve the public interest.
3	(8) According to the Secretary of Transpor-
4	tation, almost 25 percent of United States ferries
5	are 40 years or older and 5 percent of United States
6	ferries are 60 years or older.
7	(9) Federal investment in the United States
8	ferry system is necessary because—
9	(A) of the unique and important role fer-
10	ries play in the United States transportation
11	system;
12	(B) of the large and growing need for new
13	and replacement ferry vessels and terminals;
14	and
15	(C) ferries do not fit neatly into other Fed-
16	eral mode-specific transportation programs.
17	(10) The distribution of Federal ferry funds by
18	formula is appropriate because that method of dis-
19	tribution would dedicate funding to the largest and
20	most important public ferry systems.
21	(11) The distribution of Federal ferry funds by
22	discretionary awards is also appropriate because that
23	method of distribution would help initiate and ex-

pand ferry services throughout the United States.

1 SEC. 3. SECRETARY DEFINED.

- In this Act, the term "Secretary" means the Sec-

- 4 SEC. 4. CONSTRUCTION OF FERRY BOATS AND FERRY TER-

10	standing section 118(b), funds made available to
11	carry out this section shall remain available until ex-
12	pended.".

3	SEC. 6. FERRY JOINT PROGRAM OFFICE.
4	(a) Establishment and Purpose.—
5	(1) ESTABLISHMENT.—The Secretary shall es-
6	tablish within the Department of Transportation a
7	Ferry Joint Program Office (in this section, referred
8	to as the "Office") for the purposes described in
9	paragraph (2).
10	(2) Purposes.—The purposes of the Office
11	shall be—
12	(A) to coordinate Federal programs affect-
13	ing ferry and ferry facility construction, mainte-
14	nance, operations, and security; and
15	(B) to promote transportation by ferry as
16	a component of the United States transpor-
17	tation system.
18	(b) Functions.—The head of the Office shall carry
19	out the following functions:
20	(1) Coordinating programs related to ferry
21	transportation carried out by the Department of
22	Transportation, including programs carried out by
23	the Federal Highway Administration, the Federal
24	Transit Administration, the Maritime Administra-
25	tion, and the Research and Innovative Technology

1	Administration, and such programs carried out by
2	the Department of Homeland Security and other
3	Federal and State agencies, as appropriate.
4	(2) Ensuring resource accountability for pro-
5	grams carried out by the Secretary related to ferry
6	transportation.
7	(3) Providing strategic leadership for research,
8	development, testing, and deployment of technologies
9	related to ferry transportation.
10	(4) Promoting ferry transportation as a means
11	to reduce social, economic, and environmental costs
12	associated with traffic congestion.
13	(5) Developing energy-efficient operating mod-
14	els to reduce carbon emissions associated with ferry
15	transportation.
16	SEC. 7. NATIONAL FERRY DATABASE.
17	Section 1801(e) of the Safe, Accountable, Flexible,
18	Efficient Transportation Equity Act: A Legacy for Users
19	(Public Law 109–59; 23 U.S.C. 129 note) is amended—
20	(1) in paragraph (2) by inserting ", including
21	any Federal, State, or local government funding
22	sources," after "sources"; and
23	(2) in paragraph (4)—
24	(A) in subparagraph (B) by striking "and"
25	at the end;

1	(B) by redesignating subparagraph (C) as
2	subparagraph (D);
3	(C) by inserting after subparagraph (B)
4	the following:
5	"(C) ensure that the database is consistent
6	with the national transit database maintained
7	by the Federal Transit Administration; and";

9	(D) in subparagraph (D), as redesignated
10	by subparagraph (B) of this paragraph, by
11	striking "2009" and inserting "2018".
12	SEC. 8. NATIONAL FERRY TRANSPORTATION INSTITUTE.
13	(a) Establishment.—Not later than 1 year after
14	the date of enactment of this Act, the Secretary shall
15	award a grant to a college to establish a National Ferry
16	Transportation Institute (in this section referred to as an
17	"Institute") at the college.
18	(b) Administration.—The Secretary shall award
19	and administer the grant under subsection (a) in coopera-
20	tion with the heads of appropriate entities of the Depart-
21	ment of Transportation and of the appropriate State
22	transportation department, public ferry transportation au-
23	thorities, private ferry operators, ferry builders, ferry
24	transportation employees, and other colleges, universities,
25	and research institutes

(c) Functions.—The Institute— 1 2 (1) shall— (A) conduct research and recommend de-3 4 velopment activities on methods of improving ferry transportation programs in the United 6 States, including methods of reducing wake, 7 providing alternative propulsion, integrating use 8 of clean, renewable fuels, and testing advanced 9 materials for use in ferry construction; 10 (B) develop and conduct training programs 11 ferry transportation system employees, United States Government employees, and 12 13 other individuals, as appropriate, on develop-14 ments, techniques, and procedures pertaining to 15 the construction and operation of ferries; 16 (C) encourage and assist collaborative ef-17 forts by public and private entities to preserve, 18 improve, and expand the use of ferries as a 19 mode of transportation; 20 (D) preserve, utilize, and display historical 21 information about the use of ferry transpor-22 tation in the United States and in foreign coun-

tries; and

1	(E) develop models and recommendations
2	to enhance security on ferries and in and
3	around ferry facilities; and
4	(2) may provide funds from a grant under sub-
5	section (a) to a contractor or other entity to assist
6	the Institute in carrying out the functions described
7	in subparagraphs (A) through (E) of paragraph (1)
8	(d) Selection Criteria.—The Secretary shall
9	award the grant under subsection (a) on the basis of the
10	following criteria:
11	(1) The extent to which the needs of the State
12	in which the applicant is located are representative
13	of the importance of public and private ferries to the
14	region's transportation system, including both re-
15	gional travel and long-range travel and service to
16	isolated communities.
17	(2) The historical importance of ferry transpor-
18	tation to the region in which the applicant is located
19	(3) The history and diversity of such region in
20	the maritime community, including ferry construc-
21	tion and repair and other shipbuilding activities.
22	(4) The anticipated growth of ferry transpor-
23	tation and the building of ferries in such region.
24	(5) The availability of public-private collabora-

tion in such region.

1	(6) The demonstrated research and extension
2	resources available to the applicant to successfully
3	carry out the functions described in subsection (c).
4	(e) REQUIREMENT FOR NON-FEDERAL FUNDING.—
5	A college may not be awarded the grant under subsection
6	(a) unless the college is able to provide 25 percent of the
7	costs associated with establishing, operating, and main-
8	taining the Institute and the research and development ac-
9	tivities carried out by the Institute from non-Federal
10	sources.
11	(f) REPORT.—Not later than 1 year after the date
12	of enactment of this Act, and annually thereafter, the Sec-
13	retary shall submit to Congress a report on activities car-
14	ried out under this section, including a description of the
15	activities carried out by the Institute.

16 (g) AUTHORIZATION OF APPROPRIATIONS.—There is 17 authorized to be appropriated to the Secretary \$5,000,000 18 for each of fiscal years 2012 through 2018 to carry out 19 this section.
