3 **SECTION 1. REPLACEMENT OF JOHN H. CHAFEE COASTAL**
4 **BARRIER RESOURCES SYSTEM MAP.**

5 (a) IN GENERAL.—The map subtitled “Sachuest
6 Point Unit RI–04P, Easton Beach Unit RI–05P, Almy
7 Pond Unit RI–06, Hazards Beach Unit RI–07”, included
8 in the set of maps entitled “John H. Chafee Coastal Bar-
9 rier Resources System” referred to in section 4(a) of the
10 Coastal Barrier Resources Act (16 U.S.C. 3503(a)) and
11 relating to certain John H. Chafee Coastal Barrier Re-
12 sources System units in Rhode Island, is hereby replaced
13 by another map relating to the units entitled “John H.
14 Chafee Coastal Barrier Resources System Sachuest Point
15 Unit RI–04P, Easton Beach Unit RI–05P, Almy Pond
16 Unit RI–06, and Hazards Beach Unit RI–07” and dated
17 September 30, 2009.

18 (b) AVAILABILITY.—The Secretary of the Interior
19 shall keep the replacement map referred to in subsection
20 (a) on file and available for inspection in accordance with
21 the provisions of section 4(b) of the Coastal Barrier Re-
22 sources Act (16 U.S.C. 3503(b)).
