Mr. MCKINLEY introduced the following bill; which was referred to the
Committee on Ways and Means

A BILL

To provide for the treatment of certain hospitals under the
Medicare program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fair Competition for
5 Hospitals Act of 2011”.

6 **SEC. 2. TREATMENT OF CERTAIN HOSPITALS.**

7 (a) TREATMENT.—

8 (1) IN GENERAL.—Notwithstanding any other
9 provision of law, effective for discharges occurring
10 on or after October 1, 2011, for purposes of making
11 payments under section 1886(d) of the Social Secu-

1 rity Act (42 U.S.C. 1395ww) to a hospital described
2 in paragraph (2), the wage index that applies to
3 such hospital under such section shall be the highest
4 wage index assigned to hospitals in the core-based
5 statistical area in which the hospital is located (re-
6 gardless of which State the hospital is located in) as
7 a result of the application of section 4410(a) of the
8 Balanced Budget Act of 1997 (42 U.S.C. 1395ww
9 note).

10 (2) HOSPITAL DESCRIBED.—A hospital de-
11 scribed in this paragraph is a hospital—

12 (A) that is located in a core-based statis-
13 tical area which is comprised of counties from
14 more than 1 State;

15 (B) that is not located in a core-based sta-
16 tistical area in which 1 or more hospitals are
17 subject to the minimum wage index under para-
18 graph (h)(4) of section 412.64 of title 42, Code
19 of Federal Regulations; and

20 (C) that is not located in a core-based sta-
21 tistical area in which the highest wage index de-
22 scribed in paragraph (1) applies to hospitals de-
23 scribed in such paragraph under a State reim-
24 bursement system under section 1814(b)(3) or

1 1886(c) of the Social Security Act (42 U.S.C.
2 1395f(b)(3); 1395ww(c)).

3 (b) RULES.—Any increase in the wage index of a hos-
4 pital as a result of the application of subsection (a) shall
5 be treated as the result of a decision of the Medicare Geo-
6 graphic Classification Review Board under paragraph (10)
7 of section 1886(d) of the Social Security Act (42 U.S.C.
8 1395ww(d)) and subject to budget neutrality under para-
9 graph (8)(D) of such section.
