A BILL

To restrict funds for operations in Libya, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Defund Libya Act”.

5 **SEC. 2. PROHIBITION ON FUNDS FOR OPERATIONS IN**
6 **LIBYA.**

7 (a) IN GENERAL.—No Federal funds may be ex-
8 pended, obligated, or used in any manner to support di-
9 rectly or indirectly operations in or over Libya.

1 (b) RESCISSION OF FUNDS.—Any obligated, but not
2 expended, funds to support directly or indirectly oper-
3 ations in or over Libya shall be rescinded.

4 **SEC. 3. PROHIBITION ON FUNDS FOR NATO OPERATIONS IN**
5 **LIBYA.**

6 (a) IN GENERAL.—No Federal funds may be ex-
7 pended, obligated, or used in any manner to support di-
8 rectly or indirectly North Atlantic Treaty Organization op-
9 erations in or over Libya.

10 (b) RESCISSION OF FUNDS.—Any obligated, but not
11 expended, funds to support directly or indirectly North At-
12 lantic Treaty Organization operations in or over Libya
13 shall be rescinded.

14 **SEC. 4. PROHIBITION ON FUNDS FOR OPERATIONS IN AC-**
15 **CORDANCE WITH UNITED NATIONS SECURITY**
16 **COUNCIL RESOLUTION 1973.**

17 (a) IN GENERAL.—No Federal funds may be ex-
18 pended, obligated, or used in any manner to support di-
19 rectly or indirectly operations in or over Libya in accord-
20 ance with United Nations Security Council Resolution
21 1973.

22 (b) RESCISSION OF FUNDS.—Any obligated, but not
23 expended, funds to support directly or indirectly oper-

- 1 ations in or over Libya in accordance with United Nations
- 2 Security Council Resolution 1973 shall be rescinded.
