A BILL

To prohibit the Secretary of Defense, the Director of the Central Intelligence Agency, and any other officer or employee of the Federal Government from providing information about the mission to kill Osama bin Laden to any person outside the Federal Government until the Inspectors General of the Department of Defense and the Central Intelligence Agency carry out an investigation and provide a briefing to Congress on the matter, and for other purposes.

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Stop Subsidizing Hol-

5 lywood Act”.

6 **SEC. 2. PROHIBITION ON PROVISION OF INFORMATION RE-**
7 **LATING TO MISSION TO KILL OSAMA BIN**
8 **LADEN UNTIL COMPLETION OF INVESTIGA-**
9 **TION AND BRIEFING BY INSPECTORS GEN-**
10 **ERAL OF DEPARTMENT OF DEFENSE AND**
11 **CENTRAL INTELLIGENCE AGENCY.**

12 (a) PROHIBITION.—The Secretary of Defense, the
13 Director of the Central Intelligence Agency, and any other
14 officer or employee of the Federal Government may not
15 provide any information about the mission to kill Osama
16 bin Laden to any person outside the Federal Government
17 until the investigation and briefing required under sub-
18 section (b) are completed.

19 (b) REQUIREMENT FOR INVESTIGATION AND BRIEF-

20 ING.—The Inspector General of the Department of De-

21 fense and the Inspector General of the Central Intelligence

22 Agency shall carry out an investigation and conduct a clas-

23 sified briefing for members of the congressional commit-

24 tees specified in subsection (c) regarding the mission to

25 kill Osama bin Laden. The investigation and briefing shall

1 consider, at a minimum, all the questions set forth in the
2 letter of August 9, 2011, from the Chairman of the Com-
3 mittee on Homeland Security of the House of Representa-
4 tives to the Inspector General of the Department of De-
5 fense and the Inspector General of the Central Intelligence
6 Agency.

7 (c) CONGRESSIONAL COMMITTEES.—The congres-
8 sional committees specified in this subsection are as fol-
9 lows:

10 (1) The Committee on Homeland Security of
11 the House of Representatives and the Committee on
12 Homeland Security and Governmental Affairs of the
13 Senate.

14 (2) The Committees on Armed Services of the
15 House of Representatives and the Senate.

16 (3) The Permanent Select Committee on Intel-
17 ligence of the House of Representatives and the Se-
18 lect Committee on Intelligence of the Senate.

19 **SEC. 3. PROVISIONS RELATING TO ASSISTANCE PROVIDED**
20 **BY DEPARTMENT OF DEFENSE TO ENTER-**
21 **TAINMENT MEDIA.**

22 The Secretary of Defense shall—

23 (1) determine the full costs of operations for
24 providing assistance to entertainment media by the

1 Office of the Assistant Secretary of Defense for
2 Public Affairs; and

3 (2) require that fees charged to persons receiv-
4 ing such assistance be adequate to cover such full
5 costs.
