## A BILL

To provide for the issuance of a semipostal to benefit the  
Peace Corps.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Peace Stamp for the  
5 Peace Corps Act”.

1 **SEC. 2. PEACE CORPS STAMP.**

2 (a) IN GENERAL.—The United States Postal Service  
3 shall, for a 2-year period beginning no later than 12  
4 months after the date of the enactment of this Act, issue  
5 a semipostal to benefit the Peace Corps.

6 (b) REQUIREMENTS AND AUTHORITIES.—The  
7 issuance of such semipostal and the disposition of the  
8 amounts becoming available from the issuance of such  
9 semipostal shall be governed by section 416 of title 39,  
10 United States Code, subject to the following:

11 (1) The differential included in the rate of post-  
12 age established for such semipostal under section  
13 416(c) of such title may not exceed 25 percent.

14 (2) The Peace Corps shall be the sole agency to  
15 which any amounts becoming available from the sale  
16 of such semipostal may be transferred under section  
17 416(d)(1) of such title.

18 (c) SEMIPOSTAL DEFINED.—For purposes of this  
19 section, the term “semipostal” has the meaning given such  
20 term by section 416(a)(1) of such title.
