## A BILL

To authorize improvements to flood damage reduction facilities adjacent to the American and Sacramento Rivers near Sacramento, California, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Natomas Basin Flood  
5 Protection Improvements Act of 2011”.

6 **SEC. 2. PROJECT MODIFICATION, AMERICAN AND SAC-**  
7 **RAMENTO RIVERS, CALIFORNIA.**

8 (a) IN GENERAL.—The project for flood damage re-  
9 duction, American and Sacramento Rivers, California, au-

1 thORIZED by section 101(a)(1) of the Water Resources De-  
2 velopment Act of 1996 (Public Law 104–303; 110 Stat.  
3 3662), and modified by section 366 of the Water Re-  
4 sources Development Act of 1999 (Public Law 106–53;  
5 113 Stat. 319), section 129 of the Energy and Water De-  
6 velopment Appropriations Act, 2004 (Public Law 108–  
7 137; 117 Stat. 1839), and section 130 of the Energy and  
8 Water Development and Related Agencies Appropriations  
9 Act, 2008 (Division C of Public Law 110–161; 121 Stat.  
10 1947), is further modified to authorize the Secretary of  
11 the Army to construct improvements to flood damage re-  
12 duction facilities adjacent to the American and Sac-  
13 ramento Rivers in the vicinity of Sacramento, California,  
14 substantially in accordance with the report of the Chief  
15 of Engineers entitled “American River Watershed (Com-  
16 mon Features) Project, Natomas Basin, Sacramento and  
17 Sutter Counties, California”, dated December 30, 2010,  
18 at an estimated total cost of \$1,389,500,000, with an esti-  
19 mated Federal cost of \$921,200,000 and an estimated  
20 non-Federal cost of \$468,300,000.

21 (b) CREDIT FOR NON-FEDERAL WORK.—

22 (1) IN GENERAL.—The non-Federal interest  
23 shall receive credit for expenses and in-kind con-  
24 tributions incurred by the non-Federal interest for  
25 planning, design, and construction of the project and

1 acquisition of lands, easements, rights-of-way, relo-  
2 cations, and dredged material disposal areas for the  
3 project.

4 (2) APPLICATION OF CREDIT.—Such credit  
5 shall be applied toward the non-Federal share of—

6 (A) the project; or

7 (B) any other project for which the non-  
8 Federal interest has entered into a cost-sharing  
9 agreement with the Secretary.

10 (3) LIMITATION ON STATUTORY CONSTRUC-  
11 TION.—Nothing in this subsection may be construed  
12 to limit the ability of the non-Federal interest to  
13 pursue credit or reimbursement for work performed  
14 by the non-Federal interest in connection with the  
15 project under any other authority, rule, or proce-  
16 dure, including section 104 of the Water Resources  
17 Development Act of 1986 (33 U.S.C. 2214).
