A BILL

To authorize the Secretary of the Interior to permit an exchange of land between the city of Ketchum and the Blaine County School District, Idaho.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. AUTHORIZATION OF EXCHANGE OF LAND BE-
- 4 TWEEN CITY OF KETCHUM AND BLAINE
- 5 COUNTY SCHOOL DISTRICT, IDAHO.
- 6 (a) AUTHORIZATION.—The Secretary of the Interior
- 7 may authorize the Blaine County School District to ex-
- 8 change the parcels described in subsection (d)(1) for the
- 9 parcels owned by the city of Ketchum, Idaho, described
- 10 in subsection (d)(2).

- 1 (b) Release.—Subject to subsection (c), the Sec-
- 2 retary shall execute a release of any condition providing
- 3 for a reversion of title to the United States that may be
- 4 contained in the conveyance by the United States to the
- 5 Blaine County School District of any parcels described in
- 6 subsection (d)(1) to be exchanged pursuant to subsection
- 7 (a).
- 8 (c) Conditions.—The Secretary may not execute a
- 9 release under this section unless the Blaine County School
- 10 District agrees, in a form satisfactory to the Secretary,
- 11 that the parcels described in subsection (d)(2) to be ac-
- 12 quired by exchange pursuant to subsection (a) shall be
- 13 subject to the conditions contained in the original convey-
- 14 ance by the United States to the Blaine County School
- 15 District of the parcels described in subsection (d)(1), in-
- 16 cluding the provision for reversion.
- 17 (d) Description of Lands.—The parcels of land
- 18 referred to in subsection (a) are—
- 19 (1) Lots 5, 6, 7, and 8, Block 53, Ketchum
- Townsite, Blaine County, Idaho; and
- 21 (2) Lot 8A, Desnoyers Subdivision, and a frac-
- tion of Lots 1 and 2, Block 31, Ketchum Townsite,
- Blaine County, Idaho.
- 24 (e) Modification of Patent.—On completion of
- 25 the exchange authorized by subsection (a), the Secretary

- 1 shall amend the original Bureau of Land Management
- 2 patent numbered 11-69-0013 providing for the convey-
- 3 ance to the Blaine County School District under the Act
- 4 of June 14, 1926 (commonly known as the "Recreation
- 5 and Public Purposes Act"; 43 U.S.C. 869 et seq.), to take
- 6 into account the exchange.
